2. The following friendly activities, among others, also are very important:

a. To promote establishment of PELPA (Palace of Earth-Loving Peace and Amity and to organize well ELAF (Earth-Loving Amicable Fellows).

b. To develop world-wide ZAP (Zoom Amicable Party). The ZAP shall be reorganized into FM, radio and TV.

c. To send congratulations and condolences. ELFO Presidents and the other staffs recognize the use of their pictures of face for ELFO's events, congratulations, condolences etc. **The members who were congratulated or received condolences will also express their celebrations or condolences for promotion of amity and compassion.**

In the former my message I wrote, “By the way I want to know if the above-mentioned purple phrases underlined are the very words by Mr. Elon Musk. If you answer Yes, I’ll ask Mr. Elon Musk to send other necessary message.” You didn’t answer in this respect. See your original message. Please answer me simply with Yes or No.

Mr. Elon Musk’s opinion on Ukraine like ours!!

Hon. Prof. Rikio found an article on Elon Musk’s opinion on Russo-Ukrainian War but in Japanese where he proposed, among others, the following points:

1. Re-run referendums, supervised by the UN, in the four Ukrainian regions that Russia has declared annexed.
2. The Crimean Peninsula, which Russia annexed in 2014, would be officially Russian territory.
3. Water supplies to the Crimean peninsula would be guaranteed.
4. Ukraine would remain neutral.

Mr. Elon Musk want to know if people agree to his proposal. I think it is a good chance to exchange opinions, to promote ELFO’s idea.

Dear members of our ELFO FAMILY, will you send me your comment? **Regarding these points, let’s agree, in principle, with him as ELFO FAMILY.** If there is no nay, I want to decide its adoption.

President's Administration

Dear Edmario, many thanks to you. Now you can understand how hard it is to perform even such a daily administrative task as sending important greeting and PROPOSAL to VIPs. Up to the present time almost all the important messages to many Heads of State around the world have been sent by Hon. Pres. Rikio of 82 years old. Too hard burden has been on his houlders. Please try to share burden with other Leaders.

President's and other staffs' external opinion after recognition by the GA!

When Presidents and staffs express one's opinion, they tried to obtain recognition from the ELFO GA (General Assembly) in advance. I wish all the staffs to respect such custom and rules.

What to do when a Promotor has NO Money??

Hon. Pres. Rikio sent me his draft additional rule to Charter of the OELO (Organization of Earth-Loving Oases) .You know, 2nd Pres Kisembo is in poor situation, our Pres. Edmario says he has no money, while I have great amount of debts. He wants to go Santa Catarina and talk with interested persons there, but he says he has no money. I suppose that not only at present time, but also in future, such poor but passionate members appear, so I propose to add to the OELO Charter an Article 56 (reddened by me) in order to help them.

Article 55 (6~8% interest) A Loanee-Enterpriser may encourage Cooperators' early determination of their investment by refunding on the basis of an agreement, irrespective of the time of conclusion of the MOU, additional 3 % interest to 1st runners of the investment, additional 2 % interest to 2nd runners, and additional 1 % to 3rd runners.

Article 56 (8% interest) 1. Unless otherwise agreed, any interested person, not only Loanee-Enterprisers, but also brokers, assistant etc. may borrow money from members of ELFO FAMILY before effectuation of the MOU, provided that the interest is 8%.

2. Not waiting for the term of repayment, the said borrower shall pay back the money as soon as possible when the person gets income enough for reimbursement.

Such above additional rule may be helpful for such poor passionate members, but not guarantees their necessity. Pres. Edmario says 1,000 US \$ is necessary for going there to Santa Catarina to talk with persons concerned. Applying above-mentioned Article 56, I propose to help him as follows.

1. He may go to Santa Catarina at any time by his own payment.
2. Not waiting for 1,000 US \$, he may decide to go there with the money to be sent by a member-lender.
3. A member-lender will send the money after Edmario's firm decision to go there.
4. If it turned out that he cannot go there, he shall return the money to the lenders immediately.
5. Edmario will repay with 8% interest. A individual contract will stipulate the term of repayment.
6. The above contract shall be reported to ELFO Secretary while the MOU is pending.

Dear Members, thus I'll decide tomorrow if there is no objection to Mr. Rikio's said proposal.
