1. Human life has a lot of suffering.

3. There is an end to suffering.
4. The way to end suffering is to follow the Middle Path.

Nepal is a beautiful country with the highest Everest. It is like Swiss with the Alps. Both countries are not big, and surrounded Powers. Switzerland became a permanent neutral nation while Nepal was rather of neutral character, for example, adopting non-alignment policy. Nepali nation will get more fruits if they conclude a permanent neutral treaty, and try to realize demand of 21 century: rule of law, peaceful settlement, disarmament, world federation, walking along the way which human being aspire for.

If Nepali ELAs become more passionate and ACT more energetically for these highest ideals, it will be easier for me to propose to all the ELAs, for example, that an ELFO South Asia Headquarter and an ELAC (Earth-Loving Amicable Court) for all the World be located in Nepal.

In March 30, 2020 our Nepali member Bhim Bahadur Khadka (below photo) sent me a document of Budhiganga Municipality, which asked aid to prevent CoronaVirus (CV).

According to the document, in Nepal four cases have been tested positive, and Nepalese people are without any proper testing and escaping away from quarantine due to lacking proper management and medical equipment. (Bhudiganga's population is 21,677 as of 2017)

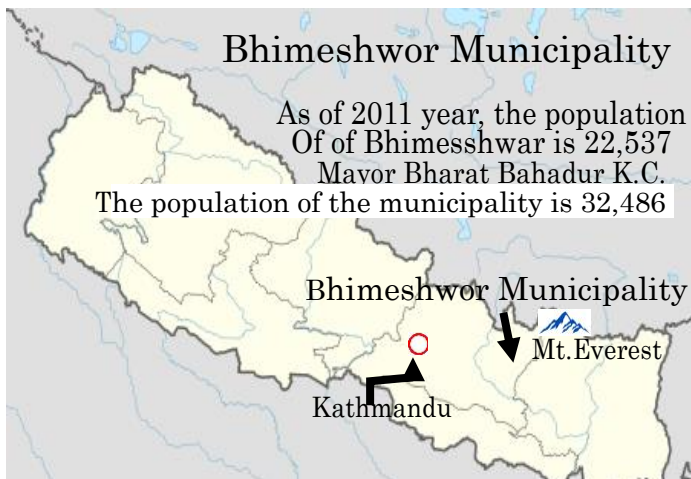
Our Nepali ELA asks to aid also his Municipality

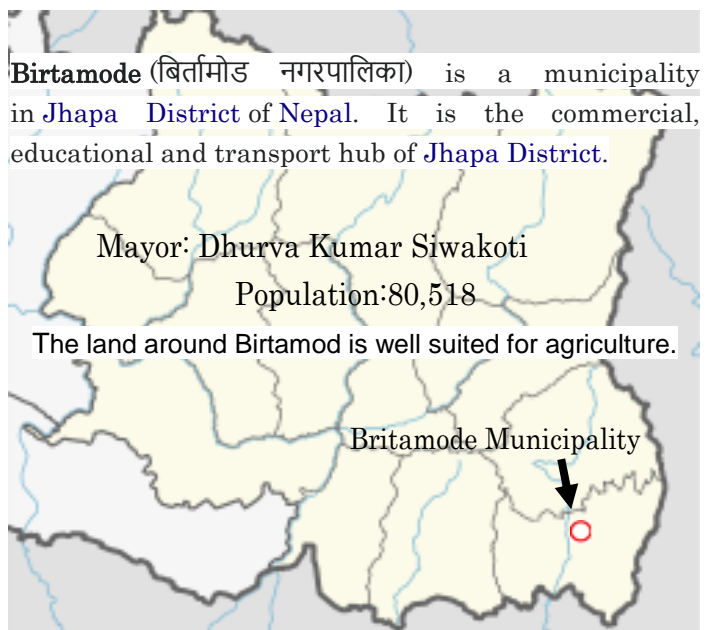

Let's conclude such an agreement.



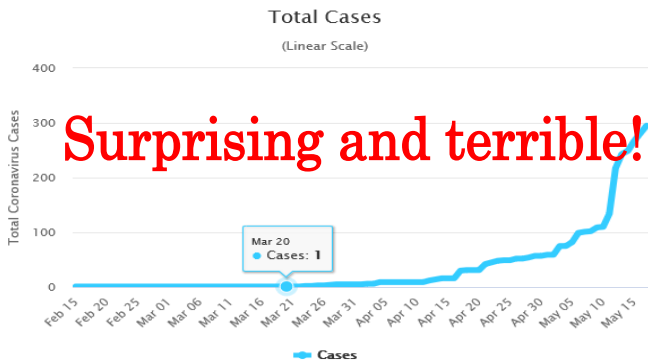

But from the bottom of our heart we wish that Kathmandu be the N.1 autonomy in the world. So let's continue to study this matter

POCNA (Peaceful Organization for Community of Northeast Asia) is very alike to our future ELFO (Earth-Loving Friendly Organization). I'll show you one of its declarations for reference.

The Declaration of the third int'l conference of the POCNA reads, among others, as follows:

Paragraoh 1 and 2 are omitted

3. Autonomies can be members of the ML

The POCNA would like to emphasize that it has the ML membership, which will enable the member to vote or take part in events without any duties such as membership fee or opening e-mails. This gives members a lot of advantage. At present no autonomies in any region has become a POCNA member yet. If an autonomy hesitates to become an official member, the POCNA recommend the autonomy to become a ML member at first stage.

5. Peaceful settlement territorial problems in Northeast Asia

In spite that 70 years passed since the end of the World War II, we view the territorial problems with apprehension because these problems were the great roots of the bilateral confrontation in Northeast Asia, and they are still remain unsettled.

The POCNA wishes the States concerned not to adopt such a single course to resort to a skirmish or to use armed force in case of their failure in diplomatic negotiation, but to use absolutely peaceful settlement system, namely, to use also international conciliation, international arbitration or international court. Regarding these aspects, the General Assembly of our Organization recognized the following 3 points.

1) General Assembly recognizes outline of the content in a letter which Mr. Rikio Kaneko (Hon. Prof. of Sapporo University) addressed to him in Kaneko's individual capacity in order to contribute to settlement of territorial problem, and to prepare for welcoming Russian President V.V. Putin,

2) General Assembly recognizes the content of letters addressed, by the POCNA President in his name, to Russian

President V.V. Putin, Prime Minister of Japan Shinzo Abe and State Head of People's Republic of China Xi Jinping, and request him to propose more or less concrete measures of settlement of territorial problems.

3) General Assembly request accelerate deliberation on 'Draft Principles proposed by General Director of Territorial Boundary Council' which are posed shown in his book 'Peaceful Organization for Community of Northeast' (January, 2015, p.97)

6. Control excessive nationalism and stabilization of international relations

POCNA concerns about the expression of extreme nationalism these years and linked actions of the nations. Generally, no people today want a war, much less nuclear war. We prefer utmost friendship between peoples. Besides, racial independence and self-determination is recognized by the Charter of the United Nations, and this should be respected.

To keep peace, we need to stop self-righteous actions and care for and accept the others. On the other hand, in some cases it would be difficult to compromise between two nations. Then we will need the third party's decision (e.g. arbitration or judgments). Now in Northeast Asia we need not "Power Control", but "Regal Control".

Present 'Declaration of International Conference of the Peaceful Organization for Community of Northeast Asia' will be sent not only to the 6 States relating to the POCNA, but also all the Member-states of the United Nations.

2. As for annual membership fee of a Nepali State and autonomies, I propose to lay down the following rules:

a. An individual's annual membership fee is about average food expenses a day in Nepal;

b. Annual membership fee of an autonomy is: its population × GDP per capita ÷ 20,000,000

c. Annual membership fee of Nepali State is: UN annual financial contribution of a State ÷ 10,000

Cf. Nepali financial contribution is 0.007%

The other day the GA (General Assembly) decided that "Organizational annual membership is 100 dollars." Later I thought though it is too simple, it is not faire: Nepali State, Kathmandu, and a small village would be to pay the same amount of money!? On the other hand, we must take into account the annual membership fee of the ELFO (Earth-Loving Friendly Organization).

There we could not see any draft rules as for annual membership fee of a State and an autonomy, and I added the following standard to my draft Charter of the ELFO:

a. An individual's annual membership fee is

average food expenses a day in one's country;

b. Annual membership fee of an autonomy is: its population × GDP per capita ÷ 20,000,000

c. Annual membership fee of a State is: UN annual financial contribution of a State ÷ 10,000

For further reference please consider the NELFA Constitution, Article 6, which stipulates that 'President may try to conclude an agreement with the ELFO and other family organizations to the effect stipulated in Article 1, Paragraph 4, provided that after its conclusion the NELFA members will be exempted from annual membership fee of the said organizations.'

Constitution of the NELFA

San for your pointing out that we can not go ahead without clarifying legal status of the NELFA (Nepali Earth-Loving Friendly Association) . That's right, I was so busy that I simply forgot to present a draft Constitution of the NELFA. Now every ELA can see my draft of it,



This kind of Constitution is familiar to many ELAs because firstly, I already sent to readers Constitution of MELFA (Mexican Earth-Loving



Friendly Association), and secondly, old ELAs know also many Constitutions of ELAC (Earth-Loving Amicable Club) of local character.

Old ELAs around the World also know that all the Constitutions have just 8 Articles, and phrases in them are almost the same. For example, all the existing Constitutions of ELFO and ELAC stipulate in their preamble as follow:

We, Supporters of an Earth-Loving Friendly Organization,

conscious of importance of promoting friendship and partnership among us and nations,
respecting reasonably national as well as international, all humankind interests,
aspiring for creation and development of a general Earth-Loving Friendly Organization

So far as the Constitution of NELFA is concerned, I added to its Purposes another one which reads: '**to be the best example among all the national Associations around the World, aspiring for ideals nobler and higher than Everest.**' though jurists don't like such poetic expression. Here readers see a draft Constitution of the NELFA.

The Constitution of Nepali Earth-Loving Friendly Association

We, Supporters of an Earth-Loving Friendly Organization,

conscious of importance of promoting friendship and partnership among us and nations,
respecting reasonably national as well as international, all humankind interests,
aspiring for creation and development of a general Earth-Loving Friendly Organization
(hereinafter referred to as the ELFO),

adopted the present Constitution of Nepali Earth-Loving Friendly Association on the fourth day of July, two thousand twenty year.

Actually it was prepared by me, Rikio Kaneko, in Sapporo in the HOUSE for peace, welfare and Amity (left picture) because I had already made up a prototype of this kind of Constitution which adopted and will be adopted in common around the world.

Article 1 (Purposes and activities) The purposes and activities of the Nepali Earth-Loving Friendly Association (hereinafter referred to as the NELFA or Association) are as follow:

1. to strengthen friendship and partnership

among the present NELFA members as well as the other family organizations around the World.

2. to introduce our NELFA and Nepal to the World, if possible, promoting exchanges especially in economic, and touristic fields, producing Earth-Loving Goods and others. (See <https://elgs.thebase.in>)

For example, to produce and sell Earth-loving Caps or tools of Earth-Loving 5-5 game is very easy, because their standards are already made up in Sapporo.

3. to popularize easy Earth-Loving Games such as 5-5 game and simple Earth-Loving Sports such as Earth-Loving park golf.
4. to support the said general ELFO, to be its member, to be ready to act for Nepali branch if our NELFA and the ELFO agree to such cooperation.
5. to open an Earth-Loving Festival or Party promoted by our NELFA.

In August 1, 2020 Zoom party is supposed to be in Sapporo, but if you are ready, Nepali side may be a promoter for it.

6. to be the best example among all the national Associations around the World, aspiring for ideals nobler and higher than Everest.

It seems that Nepali members are more than Japanese now because recently there are more than 100 Nepali ELAs. If Nepali ELAs can contribute to betterment of our precious Earth, showing other examples earlier than others, it's already a miracle.

Article 2 (Principles) The NELFA shall observe the bellow-mentioned principles:

1. to respect all human being's interests, our reasonably national, regional and local interests.
2. to be friendly and cooperative beyond race, nationality, language, religion, etc.
3. to respect natural friendship which derives from a simple fact that we are human beings.

Article 3 (Entry) 1. Not only a Nepali national, but also any person concerning this place (an autonomy, its component or a company, a foreigner etc.) may be a member of our NELFA.

So, for example, I can be its member, too.

2. 4 kinds of membership are in the NELFA: a special member, a common member, an organizational member and a ML member.

3. AA ML (Mailing List) member has not any duties in relations with the NELFA, provided that any ML member has one vote, the right to

be a candidate for staff,

and to join events. As to

votes NELFA applies the

ELFO provisions with necessary qualification.



Article 4 (Principal organs) 1. In the NELFA there will be established, as its principal organs, a General Assembly, President, Council, Secretariat.

A ML member may be a staff of these organs, so it is possible that the Association will be managed by the ML members without any money or fund if they like such a form.

2. President has a primary responsibility to manage the NELFA and may appoint its staffs.

Article 5 (Membership fee) A common member's annual membership fee is an amount of money equivalent approximately to XXX US \$, an organizational member's is that equivalent approximately to XXX US \$. (Tell me your wish)

Special budget may be compiled as for a special plan, for example, a friendly party or an event.

Article 6 (Cooperation with the ELFO) President may try to conclude an agreement with the ELFO and other family organizations to the effect stipulated in Article 1, Paragraph 4, provided that after its conclusion NELFA members will be exempted from annual membership fee of the said organizations.

Character of local Earth-Loving Clubs, regional ELFAs (Earth-Loving Friendly Association), national ELFAs and world-wide ELFO are almost the same: they are friendly and Earth-loving. If each member were to pay membership fee to these kinds of organizations respectively, it would be burdensome, so we adopted the present Article.

Article 7 (Seat) The seat of the NELFA is located in Kathmandu, Nepal. Dear Suresh San, will you suggest a concrete place as the seat of the NELFA?

Article 8 (Effectuation) The present Constitution shall be effective on the fourth day of July when the First General Assembly of the NELFA adopts it.

Let the present NELFA Constitution effectuate on the day of opening of Nepali GA.

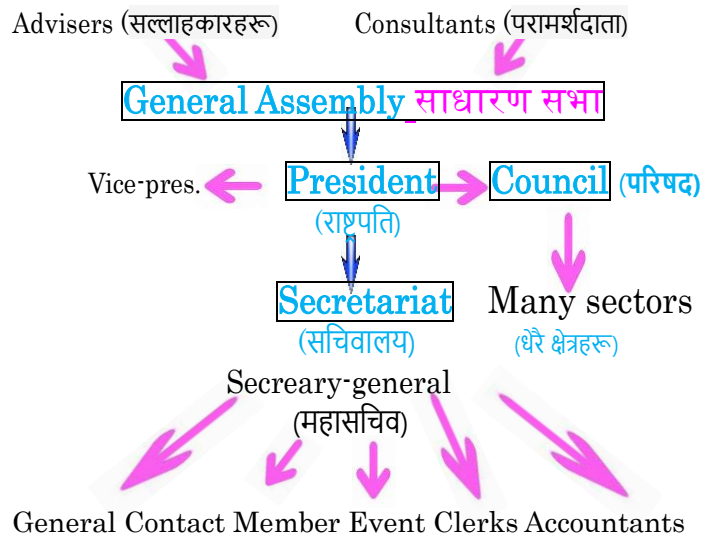

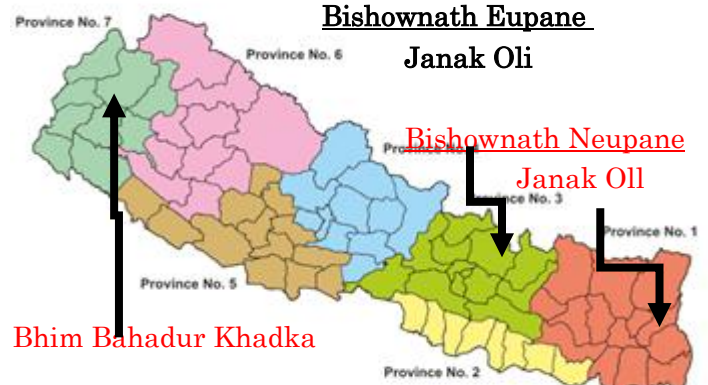

Now I drafted bellow-mentioned rules to be presented to the coming General Assembly:

Rules of Remuneration for Staff of Secretariat

1. Only staff for Inviting Members (SIM) of the Secretariat will receive **30%** of membership fee which special, common or organizational members pay to the NELFA who joined it through.
2. All the staffs of the Secretariat may be a SIM. The other members of the NELFA cannot receive a certain amount of remuneration even if a new member joined the NELFA through them.
3. Secretary-general can receive, in principle, **5%** of membership fee of a given year.
4. A SIM may receive above-indicated amount for the following annual membership pay of the member who joined the ELFA through that SIM.

Supposing that Mr. A joined the NELFA as a special member whose annual membership is 30 dollars, then a SIM can receive 10 dollars at the time of Mr. A's entry. And next year also the SIM can receive the same amount from the NELFA if Mr. A remains as a NELFA member.

5. In case a SIM succeeded in inviting a person as a ML member, the SIM can receive remuneration only when a ML member become a common or a special member.
6. A SIM has a duty, among others, to be present in Secretariat office when a Secretary-general holds a meeting. If a SIM cannot be present, he or she shall help the Secretariat with another service.

This means that a ML member cannot be a SIM. It is desirable that a SIM become a special member of the NELF, who has some role there.

7. 10 % of the membership fee will be used for welfare (for corona relief fund for a while.)

The NELFA shall take into account population of the autonomies concerned when it distribute the said 10% sum of money.

8. The General Assembly will decide, in 5 years, if the NELFA continues such system or not.
