I have honor to have received your sign of interest in my ELFO (Earth Loving Friendly Organization). From the bottom of my heart I wish you join us. Please see URLs about us, and send me your consent "Yes". That is all for your procedure of registration.

Our mother organization ELFO bore her baby organization OELO (Organization of Earth-Loving Oases). Firstly, I'll explain the ELFO of inclusive character, and secondly the OELO of financial character.

ELFO

A Our ELFO is so inclusive that there are many Principal organs. You can belong to some of them below mentioned:

An Interstate Council, a Solidarity Council, a Religion and Ethics Council, a Deputies Council, a Council of Peace, a Council of Friendship, a Council of a Judicial Affairs, a Border Council, an Economic Social Council, a Finance and Industry Council, a Human Rights Defense Council, a Council for Employment and Labor, a Council of Welfare and Medicine, a Council for Humanitarian Aid, a Council of Communication and Transport, a Council of Resources and Environment, a Council for Conservation of Resources, an Energy Council, an Educational, Scientific and Cultural Council, a News and Information Council, a Council of Tourism and Accommodations, a Council of Sports and Games, a Youth Council, Earth-Loving Amicable Court.

I suppose you are more interested in our Finance and Industry Council (FIC) of private law character than Economic Social Council of public law character.

B FIC: We are happy if you are ready to be a member of the FIC (Finance and Industry Council). If it is burdensome, you may be common

member without portfolio, and get acquainted with wonderful financiers and economists.

According to ELFO Charter, the principal functions of the FIC are, among others, as follow:

- a. to encourage financial and industrial activities, which will serve the welfare and economic development of the communities.
- b. to make an effort to create an Earth-Loving Bank, which will support financial and industrial activities of communities.
- c. to promote creation of Earth-Loving Company. [Currently there is such company in Sapporo, Japan, owned by our Hon. Pres. Rikio Kaneko.]

[C] Decision of ELFO General Assembly: It decided to encourage

- a. to create FUND for establishing ELCs (Earth-Loving Company), ELABs (Earth-Loving Amicable Banks), ELFUs (Earth-Loving Friendship Universities) in any places where we can do.
- b. to promote creation of accommodation (hotels or hostels) and investment for it. Currently we are planning a project in San Paulo, Brazil and in Sapporo, Japan, but in future ELFO will pay attention to many cities around the world.

[D] Matching of Cooperators with Applicants (Loanees):

Thank you again for your interest in our ELFO and your potential readiness to cooperate with members who plan many kinds of projects. Recently our GA (General Assembly) of the ELFO adopted Rules and forms for Cooperators (investors, bankers and other economists) and Applicants (Loanees) wanting loan.

Our ELFO will help you conclude a contract on your transaction. You may be an investor or an applicant wanting fund, depending upon situation. (See its Rules and forms <http://mopw.org/elo%20n6%20rules%20appli.pdf>)

[E] Invitation of foreign investment to you or your company: In our ELFO there are many rich people. So you can invite them to invest in your project, as a result, gaining profits, refunding them interest and remainder.

Regarding ELFO membership fee, you can use following rules:

1. A member (named A) will send a certain amount of money (US\$ B) to a member-investor or company (named C);
2. The C will gain profits by using B, every year pay A's dues to the ELFO Secretariat for A, interest to A, and will repay all remainder to A at the end of contract period.
3. A certain amount of money depends upon an agreement between A and C.

[F] ZAP (Zoom Amicable Party): ELFO is holding every day the easy-going ZAP. You may chat, talk, introducing yourself. We talk frequently about economy and investment. ELFO leaders explain about ELFO more in detail, even sing a welcoming song written by Hon. Pres. Rikio for you, I'll often be present in the ZAP.

[G] National VIP. We are happy if you are ready to be a VIP of your national ELFA (Earth-Loving Friendly Association) in your country, for example, Acting President or Vice-President of the ELFA or Chief or Vice chief of finance sector of the ELFA to be appointed by central ELFO. And there you may challenge to create your national ELC (Earth-Loving Company) or Earth-Loving Bank if you like.

OELO

One of the most important roles of the OELO (Organization of Earth-Loving Oases) is promotion of members' economic activities: its mother organization ELFO adopted such OELO Charter recently (24/1/1).
