## Rikio's 5th Draft MOU on CSR Solutions

In July 9, 2024, I presented the 1st draft, and from July 18, 2024 began the work for revision of the draft. Green phrases are recent addition, red words are today's addition and *italic is my comment*.

## Memorandum Of Understanding on CSR's Projects

We Partners Concerning Projects of CSR Solutions,

recognizing that the realization of the present projects is important for contributing to rise in standard of living of partners as well as many interested persons and people around them,

convinced that international cooperation for completion of these projects will produce fruitful results, being an example uniting ELFO members,

Have Resolved To Combine Our Efforts To Realize Projects of CSR Solutions.

Done at the city of Kinshasa the xxx th day of xxx month, two thousand twenty four.

#### PART I. INTRODUCTION

#### Article 1. Parties to the MOU

- 1. Original Parties to the Memorandum Of Understanding (hereinafter referred to as MOU) shall be, in principle,
  - a. Loanee CSR Solutions (hereinafter referred to as CSR);
- b. ELFO Pres. Edmario and the member of ELFO FAMILY who will succeed, by the end of this year, in letting bankers or investors to invest capital concerning present MOU;
- c. Cooperators (bankers, investors etc.) whom any member invited to join the ELFO FAMILY, and who are ready invest in projects of CSR;
  - d. Any member willing to invest in projects of CSR; and
- e. A bank Itaú Internacional ready to be in charge of accounting affairs concerning projects of CSR Solutions.

- 2. Mr. Kisembo Abraham as a first runner provided for in the present MOU.
- 3. ELFO Hon. Pres. Rikio will not be a party to the present MOU, provided that he will be a personal assistant to the CSR Solutions.

#### Article 2. Character of this partners' group

- 1. This partners' group around CSR Solutions will be soft, and there will not be its President, Representative or Head of the group. The above-said bank may be a Chair with equal right of vote with others, but will not be superior over other partners. (Par in parem non habet jurisdictionen)
- 2. CSR Pres. Nehemie may appoint ELFO Hon. Pres. Rikio as his 1<sup>st</sup> Assistant responsible for arranging affairs.

#### Article 3. Purposes of the MOU

- 1. Purposes of the MOU are the followings:
- a. to realize a project of construction of an Earth-Loving ecovillage in Baraka in the territory of Fizi in South Kivu in the Democratic Republic of Congo;
- b. to realize a project of construction of an Earth-Loving ecotown in Kinshasa;

I suppose that these 2 projects of ecovillage and ecotown are safer and more profitable than only one project of ecovillage. If many houses are built in ecovillage, but they remain unsold, it will be difficult to manage well. On the other hand, such risk will be less in Kinshasa. 200 million \$, for example, may be for ecovillage, and the other 200 million for ecotown, for example.

- c. to create value to be shared fairly not only among parties to the MOU, but also any member of ELFO FAMILY.
- d. to enlarge opportunity of employment of ELFO members by hiring majority of them in the ecovillage.
- 2. Partners shall try so that present MOU be a good example to be followed not only by them regarding later projects, but also by other ELFO members.

#### Article 4. Joining the MOU

The MOU is open not only to any ELFO member at the time of signature of the MOU, but also to any member acceding to the ELFO FAMILY later.

#### PART II. LOANEE'S RIGHTS AND DUTIES

Article 5. Loan for projects of Earth-Loving Ecovillage and Ecotown

1. A loanee CSR Solutions may receive total sum of 400,000,000 US \$ while Cooperators are ready to remit up to that extent.

It is probable that by the end of this year CSR and brokers cannot collect 400 million \$, so that I suppose some Cooperators will remit their money separately in accordance with agreement among interested persons.

2. Even if Loanee CSR does not receive total sum 400, 000, 000 US & by the end of this year of 2024, the CSR may begin its projects at any time on its own responsibility.

See Article 8 on "Encouraging steps by CSR Solutions". When the CSR receives the capital through these steps, it may begin its work now, probably, together with its own capital.

3. Regarding capital sent to the CSR by a Cooperator after January 1, 2025, it shall be refunded by 2035 in accordance with agreement between them.

Article 6. Security for the Earth-Loving Ecovillage and Ecotown

- 1. Pres. Nehemie sent me a document on security in French (click here),
- 2. Then in July 21, 2024 he sent it in English (click here)

Dear CSR Pres. Mr. Nehemie, thank you so much for your English text now. It seems to be security provided by local, not central Government. Is my supposition right? Anyway it is very good, it is a kind of PPP (Public Private Partnership).

#### Article 7. Refund and Interest to be paid to investors

- 1. The total sum of loan with its interests shall be refunded within 10 years. *In other MOUs the period is 5 years. They will be revised also as 5 years.*
- 2. The interest rate for 10 years will be 5 % to be applied every year unless otherwise provided in individual agreement between CSR and the other persons concerned.
  - 3. Supposing the present MOU will be effective in December 31<sup>st,</sup> 2024, CSR may refund the said 400,000,000 US \$ to the Cooperators, by agreement with them, choosing one of following models:
    - a. Model A of CSR's light burden as is shown in A in an annex I.
    - b. Model B of CSR's moderate burden as is shown in B in annex I.
    - c. Model C of CSR's heavy burden as is shown in C in annex I.
    - d. Model D of mixed burden to which CSR and Cooperators agree.
    - 3. When CSR fails to refund in a given year above-mentioned, the interest of that year will be 6%, and from the 6<sup>th</sup> year the 7% of interest will be applied to the refund. Any partner shall not regard arrears of CSR as unfriendly.

#### PART III. ENCOURAGING STEPS

#### Article 8. Encouraging 3 steps by CSR Solutions

- 1. CSR may encourage Cooperators' early determination of their investment by refunding on the basis of an agreement, irrespective of the time of conclusion of the present MOU, to  $1^{\rm st}$  runner of the investment, additional 3% of the sum, to  $2^{\rm nd}$  runner additional 2%, to  $3^{\rm rd}$  runner additional 1%.
- 2. Concrete conditions regarding remittance, refund etc. shall be agreed to between CSR Pres. Nehemie and the Cooperators.

#### Article 9. The 1st Runners with 8% interest

- 1. OELO 1<sup>st</sup> Pres. Kisembo and CSR Pres. Nehemie shall be the obligatory 1st runner to demonstrate their firm determination to realize the present objects, remitting at least 5,000 US \$ to independent bankbook for Earth-Loving Project (its Representative is Mr. Nehemie) which is to be issued by a bank in DRC.
- 2. A Brazilian bank Itaú Internacional will be also an obligatory 1<sup>st</sup> runner to realize the present objects, remitting at least 5,000 US \$ to above-said independent bankbook for Earth-Loving Project.
- 3. OELO 2<sup>nd</sup> and 3<sup>rd</sup> Presidents, Vice-Presidents shall be also the 1<sup>st</sup> runner to remit at least 1,000 US \$, provided that they may claim refund for one year with simple interest of 8%.

When Vice President remits 1,000 US \$, he or she can receive 1,050 US \$.

4. Any member of ELFO FAMILY may lend one's money to a specialist in investment to get maximum gain which is permitted by domestic law, enjoying the right to receive refund with 7% interest. The other 1% of the remittance will be remuneration for the said specialist.

#### Article 10. The 2st Runners with 7% interest

- 1. The following members of OELO shall be the 2<sup>nd</sup> runner who may receive interest of annual 7% of one's remittance:
  - a. Head of the Board of directors;
  - b. Head of following Departments: a lodging business operator department, a lodging manager department, a lodging intermediaries department, investment department and other necessary departments.
  - c. Representative of Cooperators
  - d. Representative of Loanees
  - e. Secretary-General.
- 2. Any member of ELFO FAMILY may lend one's money to a specialist in investment to get maximum gain which is permitted by domestic law, enjoying the right to receive refund with 6% interest. The other 1% of the remittance will be remuneration for the said specialist.

#### Article 11. The 3rd Runners with 6% interest

- 1. The following members of the ELFO and the ICO shall be the 3rd runner who may receive interest of annual 6% of one's remittance:
  - a. President of the ELFO;
  - b. President of the ICO;
  - c. Each Head of principal organs of the ELFO and the ICO;
  - d. Members of Interstate-Council which is composed more than 350 diplomats of ministry of foreign affairs as of July 26, 2024.
  - e. Secretary-General.
- 2. Any member of ELFO FAMILY may lend one's money to a specialist in investment to get maximum gain which is permitted by domestic law, enjoying the right to receive refund with 5% interest. The other 1% of the remittance will be remuneration for the said specialist.

#### Article 12. Remittance

- 1. International remittance of money among the present partners shall be conducted through Paypal unless otherwise agreed.
  - 2. The CSR shall have its own bankbook exclusively for its projects.

Then a member may send money directly to the bankbook. But in this case remittance route may be through some banks, and its fee maybe surprisingly expensive while the fee is almost gratis through the Paypal.

#### Article 13. Zoom Amicable Party

This Article and the following 2 Articles are stipulated in the OELO Charter.

- 1. If a Loanee wants investment of more than 1, 000, he or she will have duty to create one's domestic or international ZAP (Zoom Amicable Party) aiming at creation of FM and Radio.
- 2. The Loanee has a duty to join the ELFO central ZAP for 30 minutes at least once a week, and if it is impossible, let some member join it.
- 3. When the ZAP grows into a FM, a Radio or a TV company, he or she may be its staff.

#### Article 14. One's National ELFA

- 1. If a Loanee wants investment of more than 10, 000, he or she will have duty to establish one's national ELFA (Earth-Loving Friendly Association).
  - 2. The said Loanee may ask one's patriot to be President of the national ELFA.

#### Article 15. One's National or local ELC

- 1. If a Loanee wants investment of more than 100, 000, he or she will have duty to establish one's national or local ELC (Earth-Loving Company) or local ELC in accordance with rules in the ELFO FAMILY.
- 2. The said Loanee may ask one's patriot to be President of the national or local ELC.

#### Article 16. CSR's support for the ELFO

If the ELFO as the developer and financier succeed in funding of this project through its connections, ELFO has right to earn revenue from the CSR at least for 25 years.

This Article originate from Amb. Kisembo's following message dated July 3, 2024 (p.3): "There's need for funding of this project which I believe if taken up by ELFO as the developer and financier through ELFO connections, ELFO will be able to earn revenue from it at least for 25 years."

#### PART III. BROKER, REPRESENTTIVE, ASSISTANT

#### Article 17. Brokerage and work

- 1. Members' brokerage will be 1 % of the loan, the brokerage is included in the loan. (It means that brokerage will be paid from among the Loan.)
- 2. Not only ELFO Pres. Edmario, but also any other OELO member-broker may receive 1% brokerage, regarding capital remitted by Cooperators, from among the total sum of loan 400,000,000 US \$.

#### Article 18. Representative Amb. Mr. Kisembo Abraham

- 1. Amb. Mr. Kisembo Abraham, who invited Pres. Nehemie of the CSR to join ELFO FAMILY, is latter's Representative, therefore he may get 1 % of remittance sent to the CSR from Cooperators.
- 2. Regarding the above-mentioned 1 % of remittance, its 5 % will be donated to the OELO and 5 % to its mother organization ELFO by rule of ELFO FAMILY, 5 % to Mr. Edmario because he succeeded in persuading a Brazilian bank Itaú Internacional to be a party to the present MOU.

#### PART IV. ASSISTANT

Article 19. Wide gates for gain by any member of ELFO FAMILY

1. Not only Mr. Rikio, a personal assistant to the CSR, but also any member of ELFO FAMILY may gain 1 % of the remittance sent by his or her effort to the CSR from a Cooperator. Their gain is not of brokerage character, rather as a result of useful and significant service for the CSR.

When 100 million US \$, for example, is remitted by a Cooperator (a bank, an investor etc.) whom you invited to join ELFO FAMILY, you can get its 1 % gain, that is, 1 million US \$.

2. From among above 1% of the remittance its 5 % shall be donated to the OELO, and 5 % to its mother organization ELFO.

In case of the above-mentioned example, 5 % of 1 million, that is, 50,000 US \$ will be donated to the OELO and also 50,000 US \$ will be donated to the ELFO.

3. Pres. Nehemie and his assistants shall conclude a formal contract on their services, which will be one of great sources of happiness for many members of One Large Blessed ELFO FAMILY by demonstrating good example of promoting amity and cooperation between the present 2 parties. The prescribed contract is annexed to the present MOU as ANNEX E, which will be opened in the website of ELFO FAMILY.

#### PART IV. FINAL PROVISION

#### Article 20. The Charter of the OELO

Charter of OELO (Organization of Earth-Loving Oases) shall be respected even though it is not created at present, seats of its President and other staffs are vacant. (As for the Charter see <a href="http://mopw.org/elo%20n9%20char%20240214.pdf">http://mopw.org/elo%20n9%20char%20240214.pdf</a>)

#### Article 21. Accountant bureau for present projects

- 1. Accountant bureau for the present projects will be created in a memberbank or investment company in Democratic Republic of Cong or in any bank ready to be a party to the present MOU.
- 2. It shall make an entry of burdensome items of financial affairs among partners, so it will receive 1% commission of total loan of 400,000, 000 US \$.

#### **Article 22 Legal conflicts**

- 1. Conflict concerning the present projects shall be settled within the frame of the ELFO's system of settling conflicts at the first stage. When a party to the MOU is dissatisfied with its conclusion, another means may be used.
- 2. Within the ELFO conflicting parties shall try to use 3 Persons' Investment Conciliation or 3 Judge' investment arbitration.

#### **Article 23 Custody**

- 1. The MOU is will be in the custody of the ELFO Secretariat.
- 2. The MOU shall be open in the ELFO FAMILY's web-site http://mopw.org

#### Article 24 Effectuation of the MOU

1. So far as Article 10 is concerned, it may be effective when CSR Solutions r 10/35

and the first runner conclude an agreement on concrete conditions.

- 2. Present MOU may come into effect when all the following persons agree to it by sending their consent to the ELFO Secretariat, which shall inform ELFO members of their consent.
- 3. When the MOU is opened in the website of ELFO FAMILY, and since then for a week there does not appear any objection to it, the MOU shall be finally effective even if a partner's legal seal lacks.

#### Article 25. Withdrawal

- 1. When a partner wants to withdraw from the present projects, he or she shall inform beforehand at 2 months notice.
- 2. If less than one month passed since the partner's accession to the present MOU, he or she can receive 90% of refund, but if more than one month passed, the partner cannot receive refund.

#### **Article 26 Original Partners**

- 1. Original partners are those ELFO members who are a signatory at the time of effectuation of the present MOU.
  - 2. The following members are an original partner:
    - (a). CSR Solutions, Cameroonian, address: Isokolo, New Road, Limbe Fako Division, South West Region, Cameroon.
    - (b) Mr. Edmario, Brazilian, address: Address: 246, 20961160, Sampaio, Rio de Janeiro, Brazil. Email address: edmariopeixinho90@gmail.com; Tel and whatsapp: ++55 21 97899-5523.
    - (c) The 1st runner of investment
    - (d) The 2<sup>nd</sup> runner of investment
    - (e) The 3<sup>rd</sup> runner of investment
    - (f) The other Cooperators (bankers, investors etc.)
- (g) A bank ready to be in charge of accounting affairs concerning projects of CSR Solutions.

#### **Article 27 Succeeding Partners**

- 1. Succeeding partners are those ELFO members who will be a party to the present MOU during period of effectuation until December 31,2029.
- 2. These succeeding partners will have the same conditions of loan as the original partners.
- 3. Succeeding partners' names will be opened in in the present MOU as well as in the ELFO website.

## ANNEX II. CSR's Contract

#### A Contract between CSR and (Assistant's name) on Amity and Cooperation

Cooperate Social Responsibility Solutions (hereinafter referred to as CSR) and (Assistant's name) have honor to have concluded the present Contract between the CSR and (Assistant's name) on Amity and Cooperation.

#### Article 1. One of great sources of happiness

Both parties shall make efforts so that present Contract be one of great sources of happiness for members of One Large Blessed ELFO FAMILY by demonstrating a good example of promoting amity and cooperation between the present 2 parties.

#### Article 2. 1 % of remittance

(Assistant's name) shall be CSR Pres. Nehemie's good Assistant to invite, in Pres. Nehemie's name, potential Cooperators (bankers, investors etc.) for him, receiving 1 % of remittance which was sent by (Assistant's name)'s effort.

#### Article 3. Donation

From among above 1% of the remittance its 5 % shall be donated to the Organization of Earth-Loving Oases (OELO), and 5 % to its mother organization ELFO (Earth-Loving Friendly Organization) which, when it received the said 5 %, shall donate immediately its 20 % to national Red Crosses of belligerent States for children suffering from war.

#### Article 4. A due form of invitation

(Assistant's name) shall send invitatory message, in principle, that (Assistant's name) is a member of the ELFO, and a personal assistant to an ELFO member Pres. Mr. Nehemie, whose company is making efforts to realize big projects (400 million US \$), so that Pres. Nehemie will be very pleased if (Cooperator's name) is interested in them, seeing its MOU (Memorandum of understanding) attached to the present message.

#### Article 5. Immunity from obligation

(Assistant's name) may be immune from any obligation so long as (Assistant's name) acts in accordance with OELO Charter, respecting Pres. Nehemie's lawful instruction.

#### Article 6. Settlement of conflicts

Conflicts between Pres. Nehemie and (Assistant's name) will be settled by procedure laid down in OELO Charter.

## Any ELFO member may be an assistant

to Cooperators (bankers, investors etc.), brokers, or/and Loanees by a contract who may, in their names, invite a new Cooperator or a Loanee. (OELO Chater, Article 48. <a href="http://mopw.org/elo%20n15%20char-e-240810.pdf">http://mopw.org/elo%20n15%20char-e-240810.pdf</a>). Below you can see, for example, a draft Contract between ELFO Pres. Edmario and any member of ELFO FAMILY. The present draft was made up by me, ELFO Hon. Pres. Rikio Kaneko

#### A Draft Contract between Pres. Edmario Peixinho and Louis R. on Amity and Cooperation

Mr. Edmario Peixinho dos Santos, President of the ELFO, namely, Earth-Loving Friendly Organization (hereinafter referred to as Edmario) and Louis R. (hereinafter referred to as Louis) have honor to have concluded the present Contract between Edmario and Louis on Amity and Cooperation.

#### Article 1. One of great sources of happiness


