27 Earth-Loving Amicable Clubs 27 の地球愛友好クラブが世界に散在

German lady Celina Remus stayed in my accommodation in February of 2020, and we agreed to the following Constitution of an amicable Club.

We the Supporters of a future Earth-Loving Friendly Organization,

conscious of importance of promoting friendship and partnership among us, inhabitants and nations in the world,

respecting reasonably national as well as international (all humankind) interests.

aspiring for creation and development of a general Earth-Loving Friendly Organization

(hereinafter referred to as the ELFO),

adopted the present Constitution of DE Lueneburg Earth-Loving Friendly Club on the thirteenth day of February, two thousand twenty year.

Article 1 (Purposes and activities) The purposes and activities of the DE Lueneburg Earth-Loving Friendly Club (hereinafter referred to as the

Club) are as follow:

1. to strengthen friendship and partnership among the present Club members as well as the other family organizations around the World.

This purpose is the most important in all Clubs all over the World.

2. to introduce Lueneburg to the World, if possible,

promoting exchanges especially in economic, and touristic fields, producing Earth-Loving Goods and others.



For example, to produce and sell Earth-Loving Caps is very easy for many ELFCs, because its standard are already made up. (See Earth-Loving Goods Store. https://elgs.thebase.in)

- **3.** to support the said general ELFO, to be its member, to be ready to act for its Lueneburg local branch if our Club and the ELFO agree to such cooperation.
- **4.** to open an Earth-Loving Friendly Party promoted by our Club.

Article 2 (Principles) Our Club shall observe the bellow-mentioned Principles:

- 1. to respect all human being's interests as well as reasonably national, regional and local interests.
 - 2. to be friendly and cooperative beyond race, nationality, religion, party, and State etc.
 - **3.** to respect natural friendship which derives from a simple fact that we are human beings.

Article 3 (Entry) 1. Not only an inhabitant in Lueneburg, but also any person (an autonomy, its component or a company, a foreigner etc.) may be a member of our Club.

So I can be its member, too.

2. In the Club there are 3 kinds of membership: a common member, an organizational member and a ML

member.

3. A ML (Mailing List) member has not any duties in relations with the Club, provided that any ML member has one vote, the right to be a candidate for staff, to join events.

Article 4 (Principal organs) 1. In the Club there will be established, as its Principal organs, a General Assembly, a Representative, a Secretariat.

Any ML member may be a staff of these Principal organs. So it may be possible that all the members of the Club are ML members if they like such a form.

2. Representative has a primary responsibility to manage the Club and may appoint its staffs.

Article 5 (Membership fee) A common member's annual membership fee is an amount of money equivalent approximately to 10 US \$, an organizational member's is that equivalent approximately to 200 US \$.

Of course, a special budget is compiled as for a special plan, for example, at the time when there will be a friendly party or events.

Article 6 (Cooperation with the ELFO) A Representative may try to conclude an agreement with the ELFO and other family organizations to the effect stipulated in Article 1, Paragraph 3, provided that after its conclusion members of our Club will be exempted from annual membership fee of the said organizations.

You know, character of a local ELFC, a regional ELFA (Earth-Loving Friendly Association), a national ELFA and a world-wide ELFO are almost the same: friendly, Erath-Loving and peace -loving.

If each member were to pay membership fee to these kinds of organization respectively, it would be burdensome, complex and negative, so we adopted the present Article.



Lueneburg ルエンブルグの紹介

Lüneburg also called **Lunenburg** in English, is a town in the German state of Lower Saxony. It is located about 50 km (31 mi) southeast of another Hanseatic city, Hamburg, and belongs to



that city's wider metropolitan region. he capital of

the district which bears its name, it is home to roughly 77,000 people. Lüneburg's

urban area has a population of around 103,000. Lüneburg has been allowed to use the title "Hansestadt" (Hanseatic Town)



in its name since 2007, in recognition of its membership in the former Hanseatic League. Lüneburg is also home to Leuphana University. **Article 7 (Seat)** The seat of our Club is located in Lueneburg, Germany.

Article 8 (Signature) The present Constitution may become effective when 3 supporters agree to the present Constitution of our Club.
