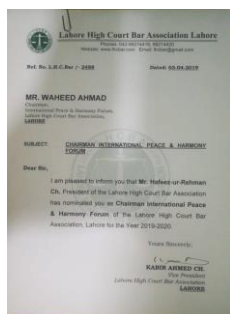
Mr. WAHEED Ahmad became an ELA! An advocate of Pakistani High Court
