As a Chairman of the CEP (Committee for Electing President), I announce that today (2020/11/10) Mr. Rikio Kaneko (pic.) was elected the 1st President of our ELFO (Earth-Loving Friendly Organization) with overwhelming majority of votes.



Because he is a 'Representative of many ELAs, including all the Diplomats and other VIPs, each of them has a lot of votes.

There were only 2 candidates for ELFO President. The other candidate is Mr. Sahdev Singh, it turned out that he is a Representative of 70 ELA members, who did not send me any mail. It's OK. In this case, all of the 70 ELAs are regarded as voted for Mr. Shadev Singh.

Hopefully, it is desirable that by the end of this year someone will be elected President of our ELFO, and in January the 1st of HAPPY NEW YEAR 2021 the GA will declare the establishment of the ELFO.

Personally I want that President appoints one Vice-president from each country. Who will be a Chairperson? What matters will be agenda items? We must do such preparatory work.

There was only one ELA whose Representative is Mr. Rikio Kaneko, but voted for Mr. Sahdev Singh.

So 71 ELAs voted for Mr. Sadev Singh.

The other day the GA adopted the rule that **5 votes will be given to a judge, an advocate and a professor**. Among the above-mentioned 71 ELAs there is only one who is mentioned as 'advocate' (N.30 of ELAC member list). Strictly speaking, it follows that Mr. Sadev Singh polled **75 votes**. Supposing that all of 71 ELAs were a judge, a advocate or professor, the maxim votes would be **355 votes** (71 ELAs × 5 votes).

On the other hand, Mr. Rikio Kaneko is a Representative of overwhelming majority of ELAs, including even many Indians. So far as they are concerned, the CEP counted votes as follows:

A. 39 Indian ELAs (N.1~N.39) were regarded as voted for Mr. Rikio Kaneko because he is their Representative.

B. 20 Indian ELAs, whose Representatives are Ms. [Adv Chitranjali Negi](#) and Prof. Dr. Sreenivasulu, also were counted as voted for Mr. Rikio Kaneko because he is their Representative.

Mr. [Rajendra Senchurey](#) is a Representative of **1** Nepalese. As Mr. Rikio K. is R. Senchurey's Representative, they were regarded also as voted Mr. Rikio K.

Dilomats' and VIPs' votes are Overwhelming

A State, an Autonomy, a Diplomat and other VIPs have many votes in accordance with their population. Mr. Rikio Kaneko is their Representative. The CEP counted their Dip. and VIPs' votes as follows:

A. National VIPs

- a. 2 former Prime-Ministers-----32 votes
- b. 1 former candidate for President-----16 votes
- c. 50 National Diplomats, in all -----2270 votes

At last today the CEP could totalize votes for Presidential election. The remaining task was to know how many additional votes were there uncouncted for a candidate Mr. Rikio Kaneko. It turned out there are such ELAs bellow-mentioned, whose Representative is Rikio Kaneko.

A. Deputies

- a. Parliamentarians :2 persons 30 votes×2 p.= **60 votes**
- b. Deputies of an autonomies :2 p. 10 v.×2 p.= **20 votes**

B.Professors : 5 persons----- 5 votes×5 p.= **25 votes**

C.Advocates : 7 persons -----5 votes×7 p.= **35 votes**

Total **140 votes**

Supposing that 5 votes will be given to a judge, an advocate and a professor, and the CEP should exactly indicates number of votes, it needs more time to announce it.

The CEP is of opinion, however, that our ELFO is voluntary organization, and should not be ruled rigid bureoucratism, it is already clearer than bright Sun that Mr Rikio Kaneko won the election. The CEP wish the current GA confirme it.

The CEP apologizes that our announcement was late, wishes epoch-making development of our ELFO.

These 140 votes will be added to votes (3526 votes) for Rikio Kaneko, which you can see in a former attachment sent 28th of this month (the preceding page of the present MM). So it is regarded that **3366 ELAs** voted for Mr.Kaneko Rikio, while **75 ELAs** voted for Mr. Sahdev Singh.

Mr. Rikio Kaneko said to me that he would appoint Mr. Sahdev Singh as Vice-president of the ELFO, so that again I express my hearty wish that our innovative epoch-making ELFO develop harmoniously, contributing to make our Earth better, cooperating with each other.

Rules on election of President

1. Any member of the ELA may be a candidate for ELFO President and an elector. A new outside person may be an elector if he or she sends, by 19:00 of 18th of November 18, 2020, a message on one's willingness to be an ELFA member, writing one's name, address, Email address and tel. number.

2. By 17:00 of 10 of October the candidate shall send to the CEP a message on one's readiness to be President by email. **If there is only one candidate by that time, the candidate will be the first President.**

3. A candidate for ELFO is regarded exceptionally as having voted for oneself at the date of announcement of one's candidacy for the presidency.

(The following draft rule is for the next election)

An ELAs' Representative shall complete one's voting within 2 days after final day for notification of candidate for President, and inform one's ELA group of whom he or she voted for.

4. An ELA member who wants to be a candidate for ELFO President may express one's opinion at anytime and anywhere.

5. **In Novemver from 9:00 of 20th day to 17:00 of 21st the CEP will conduct election if there are plural candidates for ELFO President.**

Actually 2 candidates appeared: Mr. Rikio Kaneko and Mr. Sahdev Singh.

ELAs elect President by secret ballot, only writing candidate's sign (the 1st candidate's sign is A, the 2nd candidate's B, the 3rd candidate's is C etc.), and sending it by email to the CEP.

Mr. Rikio Kaneko; **A** and

Mr. Sadev Singh; **B**

If an ELA abstains from voting without obvious will of abstention, the person's Representative Rikio Kaneko and other Representatives may use the vote instead of him or her. (See, Constitution, Article 3)

At present there are 5 Representatives of ELAs:

(1) Mr. **Dr. Sahdev Singh** (Indian President of the IELFA) for **26** Indians whom he recommended to be an ELA;

(2) Mr. **Prof. Dr. Sreenivasulu NS** for **5** Indians whose names he sent me;

(3) Mr. **Rajendra Senchurey** for **one Nepalise** who is his friend; and

(4) Ms. **Adv Chitranjali Negi**, lawyer at Supreme Court of India, for **15 new members** of whom she informed me 18th November.

(5) Hon. Prof. **Rikio Kaneko** for almost all the other ELAs. *I have been their Representative for a long time.*

6. In the evening or at night of the 20th, the CEP will announce the results of election.

Inaugural speech as President of the ELFO

Hon. Prof., ELA Repr. **Rikio Kaneko**

I am very thankful for my dear overwhelming majority of ELAs who elected me as the first honoral President of this inovative world-wide epoch-making **ELFO** (Earth-Loving Frirndly Organization).

I am very grateful to all the ELAs (Earth-Loving Associate) around the world, who understand ELAs' important roles and have cooperated more or less with me.

Though the other Indian candidate **Mr. Sahdev Singh** could not won presidential election, he was a passinate, courageous and gentleman-like person, stimulating our ELA moveement. As a President, therefore, today I appoint him as the first Vice-President of our ELFO. Likewise I appoint also as Vice-President Mr. **Chubasco Diranga** from Nauru. He wanted to be ELFO President, but withdrew from it. Our Organization must be the very friendly and amicable one, go ahead harmoniously and peacefully, cooperating with each other.

So that please feel free yourself to send me your willingness to get a status within the ELFO. I am sure that with a little bit of your additional cooperation with me and other leaders, we ELAs and our ELFO can make our Earth better further.

I asked you to increase the number of our ELAs, yes, some members could do it, but so far as Diplomats and VIPs are concerned, only I succeeded to invite them to invite to be an ELA. I begant to call Diplomats in April of this year, and there are already 57 ELA-Diplomats and 3 ELA-VIPs. **Why cannot we invite many many Diplomats and other VIPs from almost all the countries around the world even next year if we cooperate with each other?**

Interstate Council Some members may ask me, "Even if we try to invite them to join the ELFO, what can do they?". Then first of all, I answer them, "The appearance of such corps, that is, almost full seats of the Interstate Council is a miracle. And continuence of its exisrence is unprecedented

historical event.”

My Dear ELA, now we start on our long journey for making our Planet better, more harmonious and more beautiful so that we could live here safer and happily, respecting each other without enmity and violence.

While we are traveling, it is possible that many times we will suffer from poverty, unexpected rain, actual typhoon, tsunami, radioactivity from atomic station, virus, starvation, crimes etc.

But my dear members of the ELFO, we will try to be source of hopes, never losing them. When I get up in the morning, I expect that you are going to spend the day, also trying to be source or lights of hopes not only for your family, but also for the ELFO members as well as other world people. Every time you see in my MM (Mail Magazine):

Harmony, Respect, Love, Good, Beauty

Even though it may be not so easy to realize them, let's try to do as much as we can, singing a song for friendship and peace. Likewise though it is not so easy to realize our ideals bellow-mentioned, let's go ahead along Earth-Loving Amicale Way, some milestones of which are:

Rule of Law, Peaceful Settlement, Disarmament, Restriction of Sovereignty, World Federation

Rule of Law It is necessary to establish Earth Community ruled by law, neither by force nor violence. Generally speaking, rule of law is functioning in each country, but in international relations they are very far from it, **only 1/3 (one third) of States recognize the jurisdiction of an International Court of Justice (ICJ).**

As a result, majority of States, including great powers, behave as they like, declaring self-righteously justification of their acts. Our ELFO will call all the States to recognize soon or later the jurisdiction of the ICJ of the UN (United Nations).

On the other hand, our ELFO will establish an innovative **ELAC** (Earth-Loving Amicable Court) which will be of all human kind character, and has wider jurisdiction, for this end, I propose to create system of **ELAFJ** (ELA-Friendly Judge), **ELAFA** (ELA-Friendly Advocate), and **ELAFC** (ELA-Friendly Conciliator).

Peaceful Settlement The UN Charter, Article 33 stipulates as follows:

The parties to any dispute, the continuance of which is likely to endanger the maintenance of international peace and security, shall, first of all, seek a solution by negotiation, enquiry, mediation, conciliation, arbitration, judicial settlement, resort to regional agencies or arrangements, or other peaceful means of their own choice.

It is natural for you to think that if it is so, all the States would have duty to recognize the ICJ jurisdiction as an ultimate guardian of law, but States do not interpret so. In a word majority of States want to behave as they like.

Can you imagine a State where only 1/3 of her people are ready to go to its courts of justice, and the other 2/3 have not any duty to appear there? No, you cannot imagine it!

Disarmament The UN Charter mentions disarmament or regulation of armaments (Art.11 and 26), so it is no wonder that in the dangerous situation of sixties a general treaty Non-Proliferation of Nuclear Weapons (NPT) was concluded in 1968, Article VI of which provides that:

Each of the Parties to the Treaty undertakes to pursue negotiations in good faith on effective measures relating to cessation of the nuclear arms race at an early date and to nuclear disarmament, and on a **treaty on general and complete disarmament** under strict and effective international control.

According to the NPT, only 5 powers have right to possess nuclear weapons (even to increase them), alas, other countries began to have them. Our Planet is becoming more dangerous than ever before.

Restriction of State Sovereignty

Because an intrinsically unreasonable international system cannot continue to exist, it will be transformed into a new one based on rule of law, compulsory peaceful settlement of conflicts, then process of the said 'general and complete disarmament' will go on.

In such future a State cannot behave self-righteously. At that stage of development, external State sovereignty will be considerably restricted, while internal sovereignty will remain with it's a little bit of curtailment.

World Federation (WF 世界連邦)

National States were formed mainly because feudal local lords, city states or other autonomies handed over their reins of power to a central national State. Likewise the WF may be established when many or all the national States hand over their external sovereignty to the WF, ONE STATE.

Each national state will continue to exist mainly with internal sovereignty, so remain a State name, and nationality of its people. A general treaty on the WF will stipulate sphere of external and internal State sovereignty as well as the form of the WF legislation, administration and judicature.

What did we do better things? You and I?

Don't say we did nothing. The ELFO is still an embryo. We all agreed, however, to the Charter of the ELFO, and we will go ahead along the way from rule of law to the World Federation.

At present time there are only 5 national ELFAs (Earth-Loving Friendly Association); namely: **MELFA** (Mexican); **NELFA** (Nepali); **FELFA** (Fijian); **IELFA** (Indian) and **JELFA** (Japanese). Although these national ELFA may expect my help to a certain degree, you must now try to stand up by yourselves, make an effort by yourselves to walk, think and ACT. How impressive and profoundly touch our heart to see many kinds of animals standing up with tottering steps soon after their birth!!

On the other hand, now there are more than 100 countries where our dear ELAs live. I suppose they also want their own national or regional NELA.

You remember that Nepali ELAs want to create an **ELFO South Asian Headquarter in Nepal** (the GA decision). Sooner or later will be created a **CNELFA** (Chinese) and a **PELFA** (Philippine) As for **AELFA** (African Earth-Loving Friendly Association), I proposed its Constitution because there appeared ELA-Former Prime Minister **Edward Lowassa** (Tanzania) while Ambassador Ghana wishes that ELAs' **African headquarter** be created in his Ghana, and Ms. Ivo Arrey Mbongaya wants to create **CELFA** (Cameroon Earth-Loving Friendly Association). Recently an incumbent Prime-Minister **Moeketsi Majoro** inquired me about us, and I sent him my readiness to appoint his national the first ELA-President of South African ELFO Headquarter.

5 Wishes to the ELFO:

Friendship, Peace, Solidarity, Non-discrimination, Fairness

The ELFO (Earth-Loving Friendly Organization, 地球愛友好機構) seems to be one of stars shining in the dark skies, and we wish that it will perform its purposes. As '**the path is made by walking**' (African proverb), let's also walk in accordance with ELFO Charter.

Friendship I will make great efforts so that the ELFO 'contribute to development of friendly relations among nations based on equal rights of peoples, especially to promote friendly relations among private organizations and common people through personal intercourse, tourism, home stay, ML, mail magazines, Skype, Line etc.' (Art.1);

Peace I wish also that the ELFO 'contribute to maintaining peace and peaceful settlement of conflicts' (Art.1); that the ELFO will call eminent persons to join it as member of the Council of Peace.

Non-discrimination This is used in a sense that ELFO members shall '**promote friendship among nations without distinction as to race, nationality, sex, language, religion and regime, which drives from a simple fact that we are human beings.**' (See the ELFO Charter, Art.49)

Solidarity It is one of the most important conception in the ELFO because it would have effects to harmonize different conflicting interests among nations. Solidarity Councilors will be elected not on the base of national or local election districts, but an international or world-wide single electoral district.

This system is as if it were home run in a baseball. We wish many people support it.

Fairness In order to contribute to establishment of 'Rule of Law', not 'rule of force', the ELFO has a

The GA will continue also during such time from the following days excepting Saturday and Sunday, provided that any member may express one's opinion at any time.

B. Place: Capporo

C. Communication: through the Internet (Zoom, email etc.) and tel.

A. Languages in English in General Assembly (GA)

Official language is English

I am ready to be a Chairperson of the first day.

Who is ready to be a Vice-chair?

B. Votes in the GA of the ELFO

1. As a rule every ELA has one vote, provided that a diplomat and VIPs have many votes indicated in list of members the Interstate Council and President has votes provided for in the present Charter, Article 8.

2. Entrust: 'As to a ML member's vote, so long as the member does not express yes or no, it shall be regarded as the same with that of President, Chief of national headquarter or Representative of a concerned organization.' (Article 8, Para. 2)

3. So if any ELA cannot be present at the GA, please entrust another ELA with given matters. Otherwise I or other representatives will vote for the absent person.

Rikio Kaneko's URGENT MOTION!!

Taking into account CEP Chairman Kunihiro Matsumoto's request (p.37 of present MM). I want to deliberate this matter from tomorrow. Matsumoto's apprehension concerns mainly about votes by emails from ELA-Members whose representative are Mr. Sreenivasulu for 5 Indians, Mr. Rajendra Senchurey for one Nepalese, Ms. Chitranjali Negi for 15 new members, in all 21 members. I ask these 21 members not to poll 20th, but on later date which the GA decides.

N.1. ELFO Charter 地球愛機構憲章

My proposal : to adopt my draft Charter which will be sent to ELL-Members as a final Charter.

The ELFO Goals are:

The symbol mark is based on one of the the ELGs (Earth-Loving Goods) which my ELC (Earth-Loving Company) is selling at 100,000 yen (about 1,000\$). The ELC is ready to rent it gratis for the ELFO. The EELFA will revise the logo mark with permission of the ELC.

N.4. NELFA staffs NELFA 役員 NELFअचिक िी

GA adopted a list of staffs, which I (Rikio Kaneko) presented at 21st of November.

Decision of 2020/11/22:

1. it is necessary to talk among Presidents of the ELFO, the MELFA, the NELFA, the FELFA and IELFA and ELFO. President shall present draft agreements to the GA.

2. In order to maintain stable financial base of not only national ELFA (Earth-Loving Friendly Association), but also of central ELFO, A half of special members and common members of a given ELFA will belong to its national ELFA, but the other half will be members of the ELFO. (The latter will be ML members of national ELFA who has neither any financial duty nor other duty.)

So far as JELFA (Japanese Earth-Loving Friendly Association) is concerned, I want it to be a **rather complete organ of the ELFO for 5 years**. Because actual duality of the ELFO and JELFA would lead to ineffective, unnecessary double work.

On the other hand, I think that such an active ELFA as the IELFA could do better activities if it maintains its independent character, not becoming one of the ELFO organs.

For this purpose the ELFO shall encourage the creation **Relief FUND** the part of which (fund) will be lent to a poor State or autonomy suffering from coronavirus.

6. Recruitment of members.

When members of LinkedIn know our ELFO, not a small number of them expect here and there some income from our organization. I say to them, "This is not a company, it cannot pay salary." But I began to think about their remuneration for their service as follows:

Remuneration for staff's service कर्मचारियों की सेवा के लिए पारिश्रमिक

1. Any present member will receive **20%** of membership fee which special, common or organizational members pay to the NELFO who joined it through that present member.
2. In the 2nd year the present member may receive above-indicated amount from among membership fee to be paid by the member who joined the ELFO through that present member. In the following years the same rule shall be applied.
3. In case a present member succeeded in inviting a person as a ML member, the former can receive remuneration only when the ML member becomes a common or a special member.

And this rule was adopted by the GA.

N.8. Budget of 2020 year २०२० बष

A. the General Assembly will deliberate a **draft budget** to be compiled by a commission under Economic and Social Council and decide the budget for the first fiscal year. (2021/4/1~2022/3/29)

B. Annual membership fee

There are considerable differences of income among nations, so when the said commission decide membership fee, it shall take into account the GDP per capita of each State. For it, see the following URLs:

Remuneration; transport; postage etc.

E. President, Chief director of Finance and Industry Sector, and Secretary-general and **President of each Regional Headquarter** may receive a certain amount of **remuneration** from the ELFO.

F. 5 % of the membership fee will be used for welfare (for corona relief fund for a while.)

N.9. ELFO Regional Headquarter

Article 6 (Principal organs) stipulates that

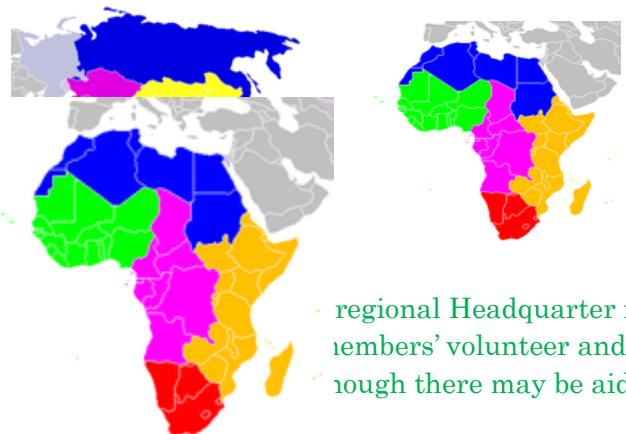
Under the General Assembly will be set up several regional headquarters, each national general headquarter, local headquarters, sub-local branches of amicable character. (Paragraph 3)

President's proposal are as follows:

A. To create many headquarters in accordance with regional division by the United Nations, so first of all, the above-mentioned Paragraph 3 will be corrected as follows:

Under the General Assembly will be set up regional headquarters, in principle, in accordance with regional division by the United Nations, each national general headquarter, local headquarters, sub-local branches of amicable character. (Paragraph 3)

C. The GA recognizes the following Regional Headquarters, considering their members' readiness.

1. ELFO South Asian General Headquarter (Nepal or Bangladesh)
2. ELFO North African General Headquarter (Egypt).
3. ELFO West African General Headquarter (Ghana)

D.ELFO Pacific Ocean General Headquarter

You know that I appointed Mr. as ELFO Vice-President. Let's ask him to study an idea on establishing the Pacific Ocean General Headquarter.

= President R. Kaneko's proposal adopted DEC,11 =

A. In Colombia there very few members, if any. So at present time let's think 3 nations: Nepal, Bangladesh or India.

B. At the first stage the ELFO will create its South Asian Headquarter (SAHQ) in Nepal or Bangladesh as I proposed yesterday:

1. Not current GA (General Assembly), but future GA, considering wishes and passion of Nepali and Bangladeshi people, will decide the location at the time when the number of members of BELFA (Bangladeshi Earth-Loving Friendly Association) will be the same.

Thanks to this policy, Bangladeshi members will try to increase their members. It is very good. At present time, Bangladeshi members are very few.

2. Members' passion is one of the important elements for deciding the location.

a. When the number of members of the NELFA and BELFA will be the same, then both Associations will talk about it.

b. If both of them could not agree to the location, then the ELFO shall hold a referendum where members of the BELFO and NELFO will have a vote.

C. Division of work (functions) is desirable.

1. Many old ELAs remember that the NELFA wanted both ELAC (Earth-Loving Amicable Court) and SAHQ. But as Indian ELAs grew in number, I began to think of division of work: In India of non-violence will be established the ELAC while in Nepal – the SAHQ. Everest is beautiful, so there would be many participants, I thought.

2. To create the ELAC is gigantic world-wide project: I wish from the bottom of my heart that Indian members concentrate their energy to establish it as promptly as possible because many problems are urgent, and develop the ELAC world-wide because here and there we witness horrible violence. There are countless domestic as well as international terrible legal problems to be settled by peaceful means. To move many bad things to better direction demands a lot of energy. Dear Indian members, first of all, please act in this field. I'll cooperate.

3. If you try to catch both 2 rabbits, you cannot catch neither. It's a Japanese proverb. Let Nepali or Bangladeshi members try to establish the SAHQ if they have passion. If Indian members monopolized both ELAC and SAHQ, Nepali members, now naked, would weep, and Bangladeshi members' morale might be shaken. If neither Nepali nor Bangladeshi members are unable actually to establish the SAHQ in one or some years, then it is possible that Indian members will have the right to create it or we will design rotation system in turn.

N.10. ELAC (Earth-Loving Amicable Court)

United Nations has its own court: International Court of Justice. Likewise the ELFO will have its own court: Earth-Loving Amicable Court (ELAC). See Charter of the ELFO.

The GA has already recognized the followings:

- a. Adoption of the ELAC (see Charter)
- b. Adoption of its more concrete conception seen in R. Kaneko's article: Not terrible, **but amicable** several aspects of ELAC'
- c. Adoption of 'Draft guidelines...' written by Prof.Dr. Sreenivasulu NS. (For both articles, see MM 'EL Amicable Court' N.4, 2020/11/14.)

Now in this session of the GA I propose following:

1. I propose to locate it in India. If it is located in India, it admits of no doubt that the ELAC would heighten considerably Indian international status and authority.

2. One of the typical forms of the ELAC is an e-court.

3. Purposes and Principles in the ELAC Statute

THE STATUT OF
THE EARTH-LOVING AMICABLE COURT
地球愛友好裁判所規程

CHAPTER 1 PURPOSES AND PRINCIPLES

Article 1 (purposes) The principal purposes of THE EARTH-LOVING AMICABLE COURT (ELAC) are:

1 to contribute to the settlement of conflicts and establishment of peace in the vast space from the view point of values not only of States but also of all mankind, all the Earth and the Cosmos, forming a clear view of the demand of the times;

2 to contribute to the settlement of social, environmental, human rights problems and disarmament problem including the nuclear weapons, and for this purpose to strengthen world-wide or regional cooperation;

3 to give legal advices, to answer legal questions, and approaching contesting parties friendly, to exercise good offices, to mediate among parties and to undertake conciliation, contributing to the settlement of the conflicts;

4 to request the contesting parties to submit the problem to an court of justice when they cannot settle legal contentious problems by negotiation and the other peaceful means;

5 to open the door of the ELAC when there is not response to the said request, and to show the most authoritative and solid legal judgment in the world in which many ELA-Friendly Judges (ELAFJ), and ELA-Friendly Advocates (ELAFA) may take part; and

6 to establish permanent ELAC Regional Courts in the regions to which jurisdictions of courts of justice do not reach unconditionally and where “rule by force” stalk with a haughty air, and to make efforts to establish “the rule by law”.

Article 2 (principles) The ELAC shall follow the below-mentioned principles.

1 In the ELAC shall dominate the principles of pacifism, democracy, respect of human rights and participation of the general public in a certain matters;

2 The ELAC shall respect international law and not intervene in the internal matters of any State, shall not discriminate apriori (in advance) against specific nations nor stimulate bad national emotion;

3. On legal judgment, the ELAC shall make an effort not to bring forth a duality of norms between existing law and the legal judgment, provided that Judges shall take into account the necessity of development of the Earth Community in accordance with demand of the times;

4. The ELAC is one of Principal organs of the ELFO of international NGO of neutral and all humankind character, and shall not be, in principle, a legal person of any country, provided that the ELAC shall cooperate with the Governments, the United Nations, international organizations, NGO and NPO;

5. The ELAC shall be composed of ELAFJ (ELA Friendly Judge), ELAFA (ELA-Friendly Advocate), ELAFC (ELA-Friendly Conciliator) and Registry.

6 The ELAC shall advise many times
contesting parties to compromise during litigation;
and

7. In the ELAC the principle of parties'
autonomy shall be recognized widely so far as it does
not infringe both domestic law and international law.

a. When conflicting parties want help of the
ELFO members besides the those of the ELAC, the
latter shall not intervene in their affairs;

b. When conflicting parties want an ELAFA to
be their Judge, the latter may agree to it;

c. When conflicting parties wish somewhat
special requirements or special composition of an
ELAC for them, such a temporal Court may be
created.

8. The ELAC is based, as a rule, on members'
good intentions and volunteerism, provided that the
ELAFJ, ELAFA, ELAFC and parties to a conflict
may agree to payment for remuneration.

**And let the GA decide that from now
on present and former Judges and Advocates
may act as ELAFJ and ELAFA so far as
such actions are neither against domestic
nor international law.**

inaugurational speech, (2) The Declaration of the 3rd

with the ELFO, so to speak, a mother of the ELFO) , and (3)
members' opinions. My draft Declaration reads:

Declaration of the 1st Conference Of the Earth-Loving Friendly Organization

**At last today the 1st day of January of
Happy New Year, two thousand twenty and
twenty one we ELA, Earth-Loving Associates,
succeeded in creating an innovative
Earth-Loving Friendly Organization (ELFO)
of all humankind character and we want to
share this pleasure with all the people around
the world.**

In these hard days of coronavirus not only
the ELFO members, but also all the humankind
must unite their forces in order to change the
present miserable domestic and world situation
and to make our earth better, maintaining our
precious Planet beautiful.

In November 10th day, 2020 year in city of Sapporo
the 1st Earth-Loving Friendly Organization Conference
was held electronically and the GA (General Assembly) of
the ELFO adopted many important agenda items.
ended on the 1st day of January, twenty and twenty one,
declaring establishment of ELFO of all humankind
character.

In the midst of the 1st General Assembly (GA),
election of the ELFO President was conducted, and
on 20th Novemver Mr. Rikio Kaneko, an Hon. Prof.
Sapporo University was elected as the 1st President
of the ELFO. Soon he appointed as a Vice-President
of the ELFO an Indian Dr. Mr Sadev Sing. anothcan

Now we start on our long journey in order to
make our Planet better, more harmonious and more
beautiful so that we could live here safer and happily,
respecting each other without enmity and violence.

While we are traveling, it is possible that many times we will suffer from poverty, unexpected rain, actual typhoon, tsunami, radioactivity from atomic station, virus, starvation, crimes etc.

But we will try to be source of hopes, never losing them. When we get up in the morning, let's say to oneself, "I will spend today, trying to be source or lights of hopes not only for my self, my family, but also for the ELFO members as well as other world people. Always remember very important ethical aspects to which our ELFO attaches much importance:

Harmony, Respect, Love, Good, Beauty

Even though it may be not so easy to realize them, let's try to do as much as we can, singing a song for friendship and peace. Likewise though it is not so easy to realize our ideals bellow-mentioned, let's go ahead along Earth-Loving Amicale Way, some milestones of which are:

Rule of Law, Peaceful Settlement, Disarmament, Restriction of Sovereignty, World Federation

Rule of Law It is necessary to establish Earth Community ruled by law, neither by force nor violence. Generally speaking, rule of law is functioning in each country, but in international relations they are very far from it, **only 1/3 (one third) of States recognize the jurisdiction of an International Court of Justice (ICJ).**

As a result, majority of States, including great powers, behave as they like, declaring self-righteously justification of their acts. Our ELFO will call all the States to recognize soon or later the jurisdiction of the ICJ of the UN (United Nations).

On the other hand, our ELFO will establish an innovative **ELAC** (Earth-Loving Amicable Court) which will be of all human kind character, and has wider jurisdiction, for this end, the GA of the ELFO adopted creation of a **Supreme ELAC** in India, **Regional ELACs** and many **National ELAC**.

Under the ELAC will be established also

- a. ELFO Interim Court;
- b. ELFO Human Rights Court;
- c. ELFO Territorial Boundary Court; and
- d. ELFO Administrative Court.

Besides them world people will see very good system of **ELAFJ** (ELA-Friendly Judge), **ELAFA** (ELA-Friendly Advocate) and **EL AFC** (ELA-Friendly Conciliator).

Dear world people, it is soon possible that you can be helped by these ELAC Courts, ELAFJ, ELAFA and ELFC. On the other hand, we the ELFO appeal to world non-member lawyers for support of the ELAC system.

Peaceful Settlement The UN Charter, Article 33 stipulates as follows:

The parties to any dispute, the continuance of which is likely to endanger the maintenance of international peace and security, shall, first of all, seek a solution by negotiation, enquiry, mediation, conciliation, arbitration, judicial settlement, resort to regional agencies or arrangements, or other peaceful means of their own choice.

It is natural for you to think that if it is so, all the States would have duty to recognize the ICJ jurisdiction as an ultimate guardian of law, but States do not interpret so. In a word majority of States want to behave as they like.

Can you imagine a State where only 1/3 of her people are ready to go to its courts of justice, and the other 2/3 have not any duty to appear there? No, you cannot imagine it!

It seems that our ELFO must design a system by which it will be obligatory for all the States to settle international conflict exclusively by peaceful means. On the other hand, our ELFO can present a concrete draft treaty regarding a given conflict as our President, Hon. Prof. of Sapporo University proposed a draft treaty on territorial problem between Japan and Russia.

Our ELFO will not remain a passive spectator of current and future serious conflicts especially when States are not able to settle them by peaceful means, and it is possible that our ELFO propose energetically peaceful means of their settlement.

Disarmament The UN Charter mentions disarmament or regulation of armaments (Art.11 and 26), so it is no wonder that in the dangerous situation of sixties a general treaty Non-Proliferation of Nuclear Weapons (NPT) was concluded in 1968, Article VI of which provides that:

Each of the Parties to the Treaty undertakes to pursue negotiations in good faith on effective measures relating to cessation of the nuclear arms race at an early date and to

nuclear disarmament, and on a **treaty on general and complete disarmament** under strict and effective international control.

Our ELFO declares solemnly that our Planet should never go ahead to arms race, so that States should never show their sharp fangs, not unilaterally justifying modernization of their armaments, rather at such time they should call out to States and world people for disarmaments and **mitigation of military alliances which would not stimulate arms race**.

According to the NPT, only 5 powers have right to possess nuclear weapons (even to increase them), alas, other countries began to have them. Our Planet is becoming more dangerous than ever before.

Under the Peace Council will be established Disarmament Committee, where they will deliberate fair process of disarmament.

Restriction of State Sovereignty

In a word sovereignty means supreme power of a State, which is composed of internal sovereignty and external (international) sovereignty.

Because intrinsically unreasonable international system cannot continue to exist for a long time, it will be transformed into a new one based on rule of law, and compulsory peaceful settlement of conflicts will be strengthened. Then process of the said 'general and complete disarmament' will go on.

In such future a State cannot behave self-righteously. At that stage of development, external State sovereignty will be considerably restricted, while internal sovereignty will remain with it's a little bit of curtailment.

A State name will remain as it is, and you can continue to maintain your nationality. Character of International law may be closer to World Law for the World Federation.

World Federation (WF)

National States were formed mainly because feudal local lords, city states or other autonomies handed over their reins of power to a central national State. Likewise the WF may be established when many or all the national States hand over their external sovereignty to the WF, ONE STATE.

Each national State will continue to exist mainly with internal sovereignty, so remain a State

name, and nationality of its people. A general treaty on the WF will stipulate sphere of external and internal State sovereignty as well as the form of the WF legislation, administration and judicature.

At the stage of the WF any State CANNOT possess State military strengths for settling external conflicts. It may possess forces, but it is not military forces for external conflict, but police forces only for domestic conflicts. It is the **WF Police Forces** that will settle international military conflicts.

In usual international life a constituent State of the WF is friendly with other States just as your autonomy is so with others within your State. The WF will be composed of such friendly peaceful States without military alliances. We the ELFO is of opinion that current neutral States or Non-allied States around the world should maintain such wise policy, not strengthening net of military alliances,

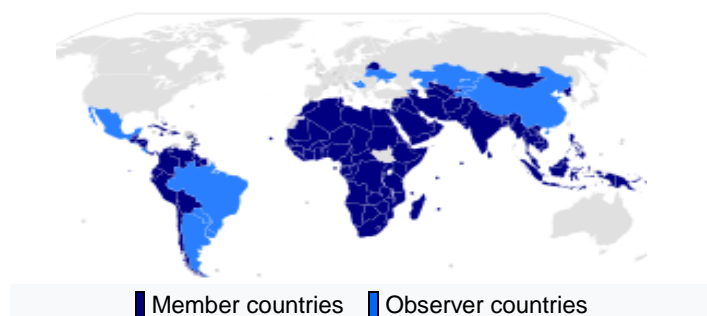
Neutral States without military alliances

Please see a constituent state of any given Federative Nation. There a state, for example a state of Texas of the USA, has not right to declare war against another state. In principle, each state is of permanent and neutral character.

If our ELFO President Rikio Kaneko suggests, when he says, "The higher are Nepali ideals, the better" such process of neutralization or non-allied policy, we welcome such idea concerning not only Nepal, but also Mongolia as well as other nations, among others, whose history was fool of fortune under neighboring Powers.

The **Non-Aligned Movement (NAM)** is a forum of 120 **developing world** states that are not formally

aligned with or against any major **power bloc**. After the **United Nations**, it is the largest grouping of states worldwide. Drawing on the principles agreed at the **Bandung Conference** in 1955, the Non-Aligned Movement was established in 1961 through an initiative of the Indian Prime Minister Jawaharlal Nehru. ([Non-Aligned Movement - Wikipedia](#))

In a word the ELFO supports process and movement for the World Federation.

The ELFO (Earth-Loving Friendly Organization, seems to be one of stars shining in the dark skies, and we wish that it will perform its purposes. As '**the path is made by walking**' (African proverb), let's ELFO Members also walk in accordance with its Charter.

Friendship The ELFO will make great efforts so that it 'contribute to development of friendly relations among nations based on equal rights of peoples, especially to promote friendly relations among private organizations and common people through personal intercourse, tourism, home stay, ML, mail magazines, Skype, Line etc.' (Art.1);

See, everybody, history of Olympic Games in ancient Greece. Can not we be wiser than ancient Greeks? Unfortunately in this respect we are doubtful.

Peace We wish also that the ELFO 'contribute to maintaining peace and peaceful settlement of conflicts' (Art.1). And let's ELFO members call out conflicting States and other parties to settle their disputes by peaceful means. In order maintain genuine peace we ELFO must consider not only legal outside respects, but also inner psychological aspects such as altruistic aspect or peace education.

Non-discrimination This is used in a sense that ELFO members shall '**promote friendship among nations without distinction as to race, nationality, sex, language, religion and regime, which drives from a simple fact that we are human beings.**' (See the ELFO Charter, Art.49)

In modern time still remain a problem of distinction as to sex of long history. Our ELFO wants to contribute to abolish, among others, distinction as to sex.

Solidarity It is one of the most important conception in the ELFO because it would have effects to harmonize different conflicting interests among nations. Solidarity Councilors will be elected not on the base of national or local election districts, but an international or world-wide single electoral district.

This system is as if it were home run in a baseball. We wish many people support it.

Fairness In order to contribute to establishment of 'Rule of Law', not 'rule of force', the ELFO has a Council of a Judicial Affairs and an Earth-Loving



Amicable Court (**ELAC**) and the General Assembly (GA) recognized **Prof. Dr. Sreenivasulu** (left) and **Mr. Waheed Ahmad** (Pakistani Advocate)

as a Vice-President of the ELAC.

Our President **Rikio Kaneko** was recognized also by the GA as a Vice-President of a ELAC Territorial Boundary Court.

There are a lot of unfair treatments not only in leagal fields, but also in economic social and other sectors. We must help people suffering from these unfair treatment.

**Source of Hopes, One Big Family,
EL Way, EL Oasis, EL Festival**

Source of Hope '**He who has health, has hope. And he who has hope, has everything**'

Dear ELFO members, let us be a source of hope on our precious Planet though it is now very hard time. We can be sourse of hopes and lights because our heart is so directed as to embrace all human being.

One Big Family Members of a family must be familiar, help each other as possible as they can, though some of them may live very far. Likewise it is desirable that all human being should be so, though each of them live scattered and very far and there sometimes may happen conflicts among them.

We ELFO members are a component of, so to speak, **Earth-Loving Amicable Family**. The ELFO Charter provides that it 'shall maintain cooperative relations...especially with international organizations which are similar with our Organization.' Fortunately we, honorable original members, are buds who will stimulate formation of one big Family.

EL Way is a nounce phrase by our President which means 'Earth-Loving Amicable Way'. In modern world there are many crimes caused by, among others, lack

of ethical awareness. If we do not have our norms of ethics, we will not be able to build good Earth Community.

Charter, Article 40 supposes necessity to systematize 'ethical norms which are simple and understandable for everybody.' Let's try to standardize it as follows:

(It's not a religion, it is a simple collection of ethical aspects.)

5 YEARS PROJECTS

What shall we do during 5 years?

1. Participation from all the nations on our Earth

At present time there are already more than 100 nations where our ELFO members live. 6 Diplomats are from International Organizations such as the UN, and 53 national Diplomats are our members.

Why cannot we invite many Diplomats from all the States on our Earth for 5 years? If we can, it would be more than magic. Then we will be able to do many good things!!

2. The Earth-Loving Friendly Court (ELAC)

This is a gigantic and epoch-making project which needs unimaginable energy, but which we ELFO must realize. Let's establish and develop SELAC (Supreme ELAC), RELAC (Regional ELAC), NELAC (National ELAC), and as a special courts, PELAC (Provisional ELAC), HELAC (Human Rights ELAC), TELAC (Territorial ELAC), AELAC (Administrative ELAC).

3. Creation of FUND

A. a revenue source is membership fee; investment from members, donation etc.

B. Uses of the FUND are mainly for:

- battling coronavirus;
- creation of ELAB (Earth-Loving Amicable Bank)
- creation of ELFU (Earth-Loving Friendship University)

We the ELFO think that PPP (Private Public

Partnership) is the best for the above-said ELAB and ELFU, so that we are very pleased if many partners, including States, are willing to be our partners.

4. Earth-Loving Amicable Festival

In October, 2020 President Rikio Kaneko began to organize ELA-Artists for the ELAF (Earth-Loving Amicable Festival). At present there are 23 ELA-Artists of several genres. We the ELFO expect that the ELAF Committee organize marvelous Earth-Loving Amicable Festival of all humankind character, and world people support them.

5. Earth-Loving INCRJA Amicable Way

INCRJA means India=Nepal=China=Russia=Japan=America

This idea was adopted by the GA of the NELFA in fall, 2020. The meaning of “Way” comprise, of course, a road, but it imply rather abstract line of friendship, soft and warm “Way” even in winter.

ELFO FUND

This is very important matter because it will be used for promoting friendship and peace among nations, developing the ELFO. I appointed a Japanese investor Satoshi Miura (pic.) as a Chairman of the FUND Committee.

First of all, let's see the decision on the FUND adopted by the GA (General Assembly) of the ELFO 1st of January, 2021 as one of the goals of 5 years, which reads:

3. Creation of FUND

A. a revenue source is membership fee; investment from members, donation etc.

B. Uses of the FUND are mainly for:

- a. battling coronavirus;**
- b. creation of ELAB (Earth-Loving Amicable Bank)**
- c. creation of ELFU (Earth-Loving Friendship University)**

We the ELFO think that PPP (Private Public Partnership) is the best for the above-said ELAB and ELFU, so that we are very pleased if many partners, including States, are willing to be our partners.

A. a revenue source

I propose as follows:

- a. From membership fee:** 10% of membership fee will be used for the FUND.
- b. From investment:** each ELFO-investor may conclude a contract with some person or an autonomy independently from the FUND, but may also conclude an investment contract with a FUND Committee (FC).
- c. From donation:** a donor may donate, specifying use of donation for some purpose, but at least 10% of donation shall be shared with the FUND. I made a donation of 5,000\$ to the ELLFO for personnel expenses, but 500\$ will be given to the FC.
- d. From a State or an autonomy:** If they think that our ideas are good and useful for them, they may be willing to cooperate with the ELFO. The more FUND, of course, the better for them. So that the FC must make energetic efforts to increase the FUND.

What State or autonomy is willing to cooperate with us? How about sounding, firstly, States of **FILFA**, **IELFA**, **JELFA**, **MELFA**, **NELFA**, and States from which VIPs and Diplomats join us?

B. Uses of the FUND

a. battling coronavirus: In the GA of the NELFA the members deliberated and adopted decision. There are 2 important conceptions: one of them is 5 years TYPICAL Contract, and the other is its supplementary steps. See MMs of Nepali edition.

I propose that in the ELFO also we apply 5 years TYPICAL Contract and its supplementary measures with necessary qualification.

b. creation of ELAB (Earth-Loving Amicable Bank)

Though ELFO members make efforts to invite capital for the ELAB, it will be risky and uneffective to try to create many ELABs at the first stage. So that one of the best choices is to create it in one country, and if it has more or less capital for creating its branches abroad, to widen its activities there, and later to let such branches be independent.

c. creation of ELFU (Earth-Loving Friendship University) The way of thinking this matter is the

same with the ELAB: Though ELFO members make efforts to invite capital for the ELFU, it will be risky to try to create many ELABs at the first stage. So that one of the best choices is to create it in one country, and if it has more or less capital for creating its branches abroad, to widen its activities there, and later to let such branches be independent.

Because there is United Nations University in Tokyo, I proposed that Japan would not be a candidate for inviting the ELFU. In the UN University there is online courses.



d. ratio of capital among 3 sectors

I propose that the FUND would be divided to 3 sectors equally more or less. If some sector of them contains difficult elements, its progress will be slow, and its rate of the FUND may become lower.

The above-said is my personal ideas which are not well considered. So please feel free to send me your comment on it.

Control of excessive nationalism

In conclusion our ELFO (Earth-Loving Friendly Organization) is obliged to express our apprehension about more or less extreme nationalism these years. Generally, no people today want neither serious conflict nor a war, much less nuclear war. We prefer utmost friendship among nations.

It goes without saying, however, that self-determination is recognized by the Charter of the United Nations, and this should be respected.

To keep peace, we need to stop self-righteous actions and we must consider other personality and respect it. On the other hand, in some cases it would be difficult to compromise between two States. Then we the ELFO propose to submit such difficult conflict to the fairer third party's decision (e.g. conciliation, arbitration or judgments). On our Earth we need to establish Community ruled by law, not self-righteous force or violence.

Q & A

I receive many questions from our members which may be categorized into several questions.

Question 1. What are ideals or goals of the ELFO?

Answer: It is clearly declared in the Preamble of our Charter of the ELFO which reads as follows:

We, the supporters of the present Carter,

recollecting that as history tells us, for a long time a human society has been of heterogeneous and separated character, constantly conflicting,

in the future, however, having respect for diversity on the Earth community, their culture and tradition, strengthening mutual understanding and solidarity among the nations,

attaching importance to friendly relations among nations and individual friendship derived from a simple fact that we are a human.

reaffirming faith in fundamental human rights, in the dignity and worth of the human person, in the equal rights of men and women and of nations large and small,

promoting conditions under which justice and respect for the obligations arising from treaties and other sources of international law can be maintained,

And for these ends,

practicing tolerance and living in peace with one another as good friends or associates,

making efforts to change the Earth into not arena of quarrels, but on the entire contrary, into a place where spirit of peace, friendship, welfare, and cooperation rules, which are sources of brightness and prosperity,

doing much toward establishment, on our Earth, of 'rule of law,' not 'rule of force,' settling international conflicts exclusively by peaceful means, considering one Earth or World Federation,

calling for disarmament and reduction of military expenditure as possible, diverting its reduction to peaceful sector, making our Earth a peaceful zone.

contributing to economic and social progress for each nation, searching for new orders that would have a good effect parallel on other fields,

deliberating other international issues, and, if necessary, sending our proposals to interested persons, which are based, on the principle of respect of reasonably national as well as international (all humankind) interests,

As for further development of our organization,

continuing to call for not only further strengthening of system of peaceful settlement of international conflicts, but also disarmament or perfect abolishment of armaments,

idealizing Earth-loving communities, where people could live without fear, understanding each other, sympathizing and fraternizing with one another,

respecting all human being's interests furthermore as well as reasonably national interests, deepening cooperative relations considerably with States, autonomies and individuals,

For the purpose of attaining above-mentioned ideals and purposes,

I have already written about them and other golden words in my MM (Mail Magazine) in detail (N.27). Here almost all of you cannot bear such contrary situation above-mentioned: Rule of force; Military settlement; Race of armaments; Absolute sovereignty; Extreme nationalism.

Such conceptions as Rule of Law, Peaceful Settlement, Disarmament, Restriction of Sovereignty, and World Federation are the demand of 21 century, and we ELAs will walk along this way, establishing an ELFO (Earth-Loving Friendly Organization), and singing our songs with and hopes.

Quesiton 2. What is purposes and its principles?

Members must know them in our Charter::

Article 1 (Purposes) The purposes of the Earth-Loving Friendly Organization (hereinafter referred to as Organization or ELFO) are:

- a. To contribute to development of friendly relations among nations based on equal rights peoples, especially to promote friendly relations among private organizations and common people through personal intercourse, tourism, home stay, ML, mail magazines, Skype, Line etc.
- b. To contribute to maintaining peace and peaceful settlement of conflicts;
- c. To contribute to raising economy and the standard of living, and to that end, to propose concerning supplemental relations and betterment of economic social systems;
- d. To promote interchanges in the field of education, science, culture, sports and others;
- e. To be a center for harmonizing actions of Members in the attainment of these common ends.

Article 2 (Principles) Our Organization and Members shall act in accordance with the following Principles.

- 1 Our Organization is based on the principle of equality among the same category of its Members.
- 2 Members shall fulfill in good faith the obligations assumed by them in accordance with the present Charter.
- 3 Member shall refrain in their relations from the threat or use of force.
- 4 This Organization shall not intervene in matters which are within the domestic jurisdiction of any State.
- 5 ML (Mailing List) members has one vote, the right to be a candidate for staff, to join events etc, but in relations with the ELFO they have not any duties besides those derived from international and domestic laws.

Quesiton 3. What is finance of the ELFO?

Our ELFO was born only 1st of January, 2021. Though it is, so to speak, a baby, it has its budget:

Finance of the ELFO

If the finance of the ELFO is unstable, we cannot manage it well, so, first of all, let's understand the outline of fundamental financial structure of our central Organization and its relations with other ELFA (Earth Loving Friendly Associations) of national character.

Central ELFO

National ELFAs

In principle, the Central ELFO and national ELFA are independent organizations. They have their own budget respectively. Here we will review financial sructure of the Central ELFO.

Central ELFO

General accounts

Special accounts

Accounts of the ELFO may be classified into general accounts and special accounts. The latter will be made up for special events such as a Conference or an Earth-Loving Festival, while the former is of usual regular character. Here we see the general accounts.

Income

As for income of the ELFO, annual membership is main source of it. Special members who will be staffs, and common members pay it, while a ML member does not. "ML (Mailing List) members have one vote, the right to be a candidate for staff, to join events etc, but in relations with the ELFO they have not any duties besides those derived from international and domestic laws." (Article 2)

Here you see ML members' easy-going position, And it applies not only to an individual, but also a State and an autonomy (self-governing body). So ML system encourages admission of many individuals. ML membership, however, must be restrictive, because if there are more ML members, the management of the ELFO will be in more difficult situation. The less ML members, the better will it be.

Economic differentials among nations are so great that we must consider them in advance when the General Assembly decides the concrete amount of membership fee. One of the basic unite is food expenses a day.

A common member' anual membership fee is 15 \$, while a special member's - 30 ~60 \$ (A kind 50 \$, B kind 40 \$, and C kind 30\$), for example. Diplomats, Juges, Deputies, Professors and Presidents are usually rich people. So it may be permissible that they will belong to A kind of special member, pay more than other categories of members.

It is one of the principal functions of the General Assembly to “deliberate and decide the budget of this Organization.” (Article 24). The Economic and Social Council shall “make economic social plans of one year and, if possible, 5 years, and also to present them, together with the draft budget, to the General Assembly.” (Article 60).

It is supposed that not only in Sapporo, but also in a lot of countries will be created an ELC (Earth Loving Company), which, “For the purpose of developing the Earth-Loving Friendly Organization, to it each Earth-Loving Company shall make a donation of 0.3 % of its gross sales.” (Article 62)

Outgoings

A. Personal expenses

Personnel expenditure will be the N.1 in such big Organization as the ELFO. Even at this stage of preparation, I must pay much money for constructing system of the ELFO, working more than 10 houres a day gratis. My wife is working 4 hours a day for ELA and ELFO gratis for them.

When the ELFO is established in near future, at least some staffs will be necessary in the Secretariat, who will work there almost every day.

If competent staffs would work gratis every day, it would be wonderful, but it is extremely difficult to find such persons.

B. Ofiice

I am ready to rent the 2nd floor of my HOUSE for Peace, Welfare and Friendship as an office of the ELFO if no one ready to do like that.

C. Apparatuses and miscellaneous expenses

Agenda item N.2. Review of the ELFO Charter

I propose, adding red phrases, the following 2 revisions:

A. Votes in the General Assembly

Article 8 (The right to vote) 1 At the time of deliberation and decision in the General Assembly members poll different votes in accordance with their kinds, in principle, as follows:

In other organs of the ELFO the votes which a member has plural votes shall be decreased to one tenth (1/10). At present in many Council Diplomats' votes are considerably many, and other members would be dissatisfied with such system.,

A. Votes in the General Assembly

Article 9 (A term of office) 1. A member of Principal organs may hold office, in principle, for 5 years. After the 5 years the next head of the Principal organs shall be chosen from among members whose nationality is different from that of the predecessor.

2. For provisional period the term of office of a Head and a Vice-head may be 1 year.

This revision will invigorate the activities of the Principal organs.,

Agenda item N.3. SAHQ (South Asian Headquarter)

In the 1st GA, it recognized the following Regional Headquarters:

1. ELFO South Asian General Headquarter (Nepal or Bangladesh)
2. ELFO North African General Headquarter (Egypt).
3. ELFO West African General Headquarter (Ghana)

In addition, the GA decided that not the 1st GA but future GA, considering wishes and passion of Nepali and Bangladeshi people, would decide the location at the time when the number of members of BELFA (Bangladeshi Earth-Loving Friendly Association) would be the same.

But it is not desirable that more than 1 year the SAHQ would not created. So that I ask the GA to revise the former decision as follows:

A future GA, considering wishes and passion of Nepali and Bangladeshi people, will decide the location at the time when the number of members of BELFA (Bangladeshi Earth-Loving Friendly Association) will be the same by the 31th of December, 2021.

If the number of the members of the NELFA and the BELFA (Bangladeshi earth-Loving Friendship Association) does not reach the same level by the 31th of December, 2021, the GA to be held in January, 2022 will decide this matter, considering also visa problem. Cf. Bangladeshi population as of 2018 is 161,376,708 18, while Nepali population is 28.09 million.

Agenda item N.5. Embodiment of FUND

ELFO FUND

This is very important matter because it will be used for promoting friendship and peace among nations, developing the ELFO. I appointed a Japanese investor Satoshi Miura (pic.) as a Chairman of the FUND Committee.

First of all, let's see the decision on the FUND adopted by the GA (General Assembly) of the ELFO 1st of January, 2021 as one of the goals of 5 years, which reads:



Satoshi M.

Creation of FUND

A. a revenue source is membership fee; investment from members, donation etc.

B. Uses of the FUND are mainly for:

- a. battling coronavirus;
- b. creation of ELAB (Earth-Loving Amicable Bank)
- c. creation of ELFU (Earth-Loving Friendship University)

We the ELFO think that PPP (Private Public Partnership) is the best for the above-said ELAB and ELFU, so that we are very pleased if many partners, including States, are willing to be our partners.

A. a revenue source

I propose as follows:

a. **From membership fee:** 10% of membership fee will be used for the FUND.

b. **From investment:** each ELFO-investor may conclude a contract with some person or an autonomy independently from the FUND, but may also conclude an investment contract with a FUND Committee (FC).

c. **From donation:** a donor may donate, specifying use of donation for some purpose, but at least 10% of donation shall be shared with the FUND. I made a donation of 5,000\$ to the ELFO for personnel expenses, but 500\$ will be given to the FC.

d. **From a State or an autonomy:** If they think that our ideas are good and useful for them, they may be willing to cooperate with the ELFO. The more FUND, of course, the better for them. So that the FC must make energetic efforts to increase the FUND.

What State or autonomy is willing to cooperate with us? How about sounding, firstly, States of **FILFA, IELFA, JELFA, MELFA, NELFA**, and States from

which VIPs and Diplomats join us?

B. Uses of the FUND

a. battling coronavirus: In the GA of the NELFA the members deliberated and adopted decision. There are 2 important conceptions: one of them is 5 years TYPICAL Contract, and the other is its supplementary steps. Sse MMs of Nepali edition.

I propose that in the ELFO also we apply 5 years TYPICAL Contract and its supplementary measures with necessary qualification.

b. creation of ELAB (Earth-Loving Amicable Bank)

Though ELFO members make efforts to invite capital for the ELAB, it will be risky and ineffective to try to create many ELABs at the first stage. So that one of the best choices is to creat it in one country, and if it has more or less capital for creating its braches abroad, to widen its activities there, and later to let such branches be independent.

c. creation of ELFU (Earth-Loving Friendship University) The way of thinking this matter is the same with the ELAB: Though ELFO members make efforts to invite capital for the ELFU, it will be risky to try to create many ELABs at the first stage. So that one of the best choices is to creat it in one country, and if it has more or less capital for creating its braches abroad, to widen its activities there, and later to let such branches be independent.

Because there is United Nations University in



Tokyo, I proposed that Japan would not be a candidate for inviting the ELFU. In the UN University there is online courses.

d. ratio of capital among 3 sectors

I propose that the FUND would be devided to 3 sectors equally more or less. If some sector of them contains difficult elements, its progress will be slow, and its rate of the FUND may become lower.

Agenda item N.6 ELAC Courts and Judges

Staff's Post

Up to present time the GA (General Assembly) recognized establishment of several categories of Courts and their Presidents and Vice-Presidents.

Firstly, I propose to the GA that these Presidents and Vice-Presidents are responsible, first of all, for administrative matters of their Courts, provided that they may be Chief Judge, a Vice-Chief Judge, or a Judge if the General Assembly recognizes them.

Secondly, I want the 2nd GA to recognize more Judge candidates for the following Courts:

A.Supreme ELAC: At present the following members are its Vice-Presidents:

1. **Prof. Dr. Sreenivasulu from India**
2. **Adv. Waheed Ahmad from Pakistan**
3. **Vacant from Africa**
4. **Vacant from American continent**
5. **Vacant from Europe**

An ELAC Member may recommend oneself as a candidate not only for a Vice-President, but also for a Judge of the Supreme ELAC. So far as Judges are concerned, it is possible that from one country plural candidates appear.

Registry: At present Adv. **Chitranjali Negi** is Vice-Registrar. **I want to appoint some members as a Vice-Registrar and many members as its staffs. Please recommend oneself.**

B. Regional ELAC: This time I want to promote firstly **ELAC of South Asia** (ELACSA) . Here I want members to recommend oneself as a Vice-President of the ELACSA or its Judge. So far as Judges are concerned, it is possible that from one country plural candidates appear.

1. Afganistan, Vacant
2. Bangladesh, Vacant
3. Bhutan, Vacant
4. India, Vacant
5. Maldives (see a map), Vacant
6. Nepal, Vacant
7. Pakistan, Vacant
8. Sri Lanka, Vacant



C. National ELAC. This time I want to propose to study, among others, IELAC (Indian ELAC)

It is, of course, very desirable, first of all, to make up the **ELAC Statute**, which is, so to speak, Constitution of the ELAC. It is not clear, however, when it will be done.

On the other hand, there happen frequently on our Earth many unstable or dangerous phenomena. Considering nowadays' situation in and around the ELAC, I propose to try also to use means of settling conflict by **one Judge system** or **one Conciliator system** so as not to infringe domestic as well as international law. We may deliberate also **3 Judges system** or **3 Conciliators seytem** when we have a time for it.

If a given domestic law allows, they may be created in many cities of the country.

On the other hand, under the ELAC may be created such special Courts as bellow-mentioned:

a. ELFO Provisional Court; Vice-Presidents and Judges from countries are vacant

Creation of this kind of Courts is urgent because here and there happen frequently serious irreparable damages.

These courts may be created in many places. Let's create even one international Provisional Court as soon as possible,

b. ELFO Human Rights Court; At present **Dr. Md. Anamul Hoque** from Bangladesh is a Vice-President of this Court. Here also I want members to recommend oneself as Vice-President or its Judge. So far as Judges are concerned, it is possible that from

one country plural candidates appear.

One Judge Arbitration Court

This kind of court may be created in many places in a country if domestic law permits. For futher proposal in this respt you will see them later.

c. ELFO Territorial Boundary Court; At present I, **Rikio Kaneko**, am its Vice-President. Vice-Presidents and Judges from countries are vacant.



One Judge Arbitration Court

Though there may be many cases where only one Jusge settled a conflict, I, Rikio Kaneko, know 4 such cases.

1.Island Palmas case; One Judge Prof. Max Huber, (pic.) a Swiss lawyer and diplomat, settled Palmas case within **3 years and 2 months.**)

The aforementioned cases concern international conflict, but such a category of ad hoc or permanent arbitration court, including thoses of domestic conflict, may be creaded in many places theoretically.

But at present time suffice it to say that we can be satisfied with 1 or 2 courts because it would be comparatively easy and we could create soon.

Here I, Hon.Prof. of Sapporo University, am ready to be an ad hoc Judge of One Judge Arbitration Court.

In this respect I ask the current GA to recognize the creation of One Judge Territorial Arbitration Court (OJTAC), the ad hoc Judge of which is Hon.Prof. of Sapporo University.

Policy of the OJTAC

1. The OJTAC, one Judge of which is Hon.Prof. of Sapporo University, will be created at the date when the GA decides its adoption of proposals posed by President Rikio Kaneko.

2. On that day the ELFO, not its President, will appoint Rikio Kaneko as President of the ELFO. (Because it is a little strange that I appoint me.)

From that day I am always ready to talk with parties to any territorial conflict, and receive any document concerning a given territorial dispute.

3. The OJTAC will have jurisdiction only over a territorial conflict, on which both parties have agreed to submit the case to the Court. The parties to the conflict shall make up such a document as called compromise.

4. If parties to a conflict send me promptly documents concerning legal facts, I will also try to settle it for a short time, if possible, within one year.

5. Judicial costs depend upon an agreement among the President and parties to the dispute. The OJTAC shall be based on the self-supporting system, so the ELFO will not be financially responsible for the OJTAC.

d. ELFO Administrative Court. This is a Court which has a function to settle internal a dispute between ELFO members and a dispute concerning a member.

In the future many contracts will be concluded among, first of all, among investors, philanthropists, and autonomies. In these contracts it is desirable that a conflict between parties to it should be settled by the ELFO Administrative Court.

Vice-Presidents and Judges from countries are vacant.

One Judge Arbitration Court

President's and Vice-Presidents' seat is vacant.

OJHRAT

OJHRAT is an abbreviation of One Judge Human Rights Arbitration Court. I suppose that most of States around the world will permit us the ELFO to locate such an OJHRAT in their State.

If you are interested in it, please ask ministry of judicial affairs of your country. They will answer, "Yes, you may, please", even adding, "Thank you so much!" if you present such a document as follows:

Policy of the ELAC OJHRAC

An Earth-Loving Friendly Organization (ELFO) has as one of the Principal organ the Earth-Loving Amicable Court (ELAC). In January 2021 the General Assembly of the ELFO adopted the following Policy on the ELAC OJHRAC (One Judge Human Rights Arbitration Court) to be created in many places around the world under the ELAC.

1. The OJHRAC, one Judge of which will be a competent ELFO-Judge or Advocate, may be created in many places around the world when a given State permits creation of such OJHRAC or such creation is allowed by law of a given State in advance.

2. From the day when it is clear that there is no problem regarding creation of the OJHRAC, it may begin to talk with parties to a conflict, and receive any document from the party.

3. The OJHRAC will have jurisdiction only over a human rights conflict of domestic and international character, on which both parties to it have agreed to submit the case to the OJHRAC. The parties to the conflict shall make up such a document as called compromise.

4. If parties to a conflict send promptly documents concerning legal facts, the OJHRAC shall also try to settle it for a short time, if possible, within 6 months.

5. Judicial costs depend upon an agreement among the President and parties to the dispute. The OJHRAC shall be based on the self-supporting system, so the ELFO will not be financially responsible for the OJTAC.

I have honor to send my greeting to Your Excellency and our wish to invite you warmly to our ELFO (Earth-Loving Friendly Organization), to an Interstate Council.

I am ELFO President, an Hon. Prof. of Sapporo University (international law and relations), and together with my 1200 of the ELFO members (many Diplomats, a former Prime Minister, a former Candidate for President and other members) established in January 1st day 2021 an innovative inclusive ELFO of universal character, and we want to promote friendship among nations, trying to make our precious Earth better in many fields.

These VIPs and Diplomats are STARS of hopes in our groups of Earth-Loving Family, having special many votes, in accordance with population concerned, reflecting interests of one's country and of our precious Earth. (Charter, Article 8).

To promote these process, the ELFO pays much attention, firstly, to 'friendly relations among private

organizations and common people through personal intercourse, tourism, home stay, ML, mail magazines, Skype, Line etc. (Charter, Article 1, paragraph 1)

ELAF (Earth-Loving Amicable Festival) is one of our interesting projects, but we were obliged to start with e-ELAF due to coronavirus. We are happy if the ELAF or ELAP (Earth-Loving Amicable Party) is also to be opened in your country. (Please see attachment.)

Secondly, "To contribute to maintaining peace and peaceful settlement of conflicts" (there paragraph 2). And the ELFO Charter lays down establishment of Earth-Loving Amicable Court (ELAC), which will have harmonious supplementary functions in relation to unperfect aspects observed now in judicial systems.

In January 14, 2021, as for the ELAC, the 2nd ELFO General Assembly decided, as its first step, to create a Territorial Arbitration Court (TAC) and many Human Rights Arbitration Courts (HRAC) of also supplementary character in many cities around the world when their location is allowed both in international law and at the same time by a given State.

The TAC and the HRAC have jurisdiction over a conflict when parties to it agree to submit their conflict to the Court on the basis of compromiss. In this resoect I am very grateful if Your Excellency can send me a message on the following 2 points:

- A. if your State has a territorial problem or not; and if the problem seems to be settled early;
- B. if your State recognizes location of the HRACs or not.

From the bottom of my heart I sincerely wish your Excellency or a former Head of State will join us. Please see the other attachments, and you will understand more that our ELFO meets the demands of 21st century. It would be my great pleasure to receive your affirmative answer, which all the ELAF members will be glad at.

Agenda item N.7 Territorial problems

Article 58 (Primary functions) 1 The Council has the following functions:

- a. to research national borders and boundaries regarding which there is a clear agreement and there is not such an agreement;*

I propose, firstly, that the Council would study those territorial and boundary problems among ELFO-States, sending a message to Heads of States in which ELFO President mentions TAC (Territorial Arbitration Court).

Secondly, I propose that we ask conflicting parties to settle their dispute by peaceful means, neither resorting to national emotion nor use of force, that if they cannot settle the conflict by diplomatic negotiation, the parties submit the case to international conciliation, arbitration or judicial settlement, and that if the conflict is of small scale, our TAC may settle it.

Thirdly, let's ask IELFA to embody its Territorial Sector. So far as Nepali Territorial Sector is concerned, there are already some members.

Agenda item N.8 Others

A. Revision of Charter

1. Term of office of this year is one year

I appointed almost all the members without meeting and talking with them. So sometimes it happens that the appointment was unsuitable, and I want all the members to understand me, and to set up one year term of office so far as the current term is concerned, exactly speaking to the end of this year.

Article 15 (Interstate Council) 1 In the provisional period, as for a State where a State Head is not a Councilor, former Heads of State, former candidates for a Head of State, **a present and a former Ministry of Foreign Affairs**, a present and a former diplomats as well as members Solidarity Council may be a Councilor, and the Council may be opened only by these Councilors.

2. A present and a former Ministry of Foreign Affairs, and a present and a former diplomats has as much votes as a Head of State when the latter is absent from the Council.

3 A former State Head has 30 % of votes which a present State Head may have. Each former candidate for a Head of State has 20 % of votes which a present State Head may have.

In January 2021 the General Assembly of the

ELFO adopted the following Policy on the ELAC OJHRAC (One Judge Human Rights Arbitration Court) to be created in many places around the world under the ELAC.

Now on the basis of the said Policy, I propose to adopt it with necessary qualifications:

National or Reginal ELAC, where a single Judge or plurul Judges sit,

1. A national or a reginal ELAC, where a single Judge or plurul Judges sit, may be created in many places around the world when a given State permits creation of such Courts or such creation is allowed by law of a given State in advance.

2. The ELAC may have jurisdiction not only over territorial and human rights problems, but also all legal conflicts, on which the Court and conflicting parties agree to the settlement of the dispute.

You see, the ELAC is of inclusive character: it may have jurisdiction both over a conflict of domestic law and international law.

3. From the day when it is clear that there is no problem regarding creation of such a Court, it may begin to talk with parties to a conflict, and receive any document from the party.

4. These ELAC Courts will have jurisdiction only over a conflict of domestic and international character, on which both parties to it have agreed to submit the case to the Court. The parties to the conflict shall make up such a document as called compromise.

5. If parties to a conflict send promptly documents concerning legal facts, the Court shall also try to settle it for a short time, if possible, within 6 months.

6. Judicial costs depend upon an agreement among the President of the Court and parties to the dispute. These Courts shall be based on the self-supporting system, so that the ELFO will not be financially responsible for the said Courts.

Facts-finding work is very important both in domestic law and in international law, so that ELFO President Rikio Kaneko proposes to set up FRC (Facts-Researching Committee), and appoint as its members our ELA-Dip. Amr Mahisin, a Diplomat في Ministry of Foreign Affairs of Egypt.



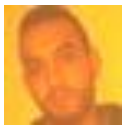

It would be very good if Diplomats could adjust their States interests by themselves. But even within the ELFO it would not so easy to agree even to find facts concerning the renaissance dam, because each Diplomat has one's own work besides the ELFO.

This time I propose, therefore, to lighten considerably Diplomats' functions within the FRC: A member Diplomat may only transmit a document to one's MFA (Ministry of Foreign Affairs). Of course, they may express their opinion in the FRC if they like.

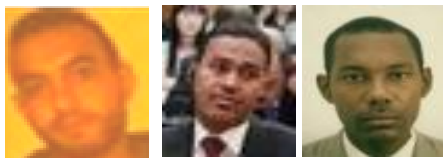

2. If Parties to the present conflict cannot settle it by diplomatic negotiation, we hope that the case will be submitted to International Court of Justice.
3. Anyway we wish that Parties to the present case and concerned persons refrain from warlike words, threat of force, much more war.

PROPOSAL concerning Renaissance dam

Our dear member-Diplomat [Amr Mahisin](#) was very apprehensive of worsening situation concerning construction of the Renaissance dam, which may lead to war, and our ELFO GA (General Assembly) paid attention to it, knew seriousness of conflict, and in May the 3rd, 2021 the GA adopted unanimously the following 3 Articles:

A. Interim Court

Here and there legal rights in domestic as well as international law are violated, many of them are irrevocable. States wage war, for example, sometimes suggesting even even nuclear war!! So that creation of the Interim Court is urgent. But as the action from the leaders of the ELAC is so slow that I will present my idea about it as follows:

The Interim Court shall only conduct preparatory affairs and preparatory trial of a case submitted to the Court, and not examine any question of its jurisdiction and the merit, provided that the Court may recommend Provisional Measures or Urgent measures to contesting parties.

Firstly, the IC can recommend Provisional or **Urgent Measures** to the contesting parties. By “Urgent Measures” we mean measures of a provisional nature designed to meet matters of paramount urgency which may be decided by the President alone or on the basis of Judges’ answers to a questionnaire submitted by them.

The President of the Court shall indicate or recommend urgent measures as soon as possible, among others, as for the following acts:

a an act or its preparation which is clearly against international law and which is condemned by international society and the United Nations.

b. an act, its preparation or suggestion which is probably against international law but realization of which would clearly aggravate the circumstances of the Earth or Cosmos.

c. an act, its preparation or suggestion which tramples down lives and fundamental rights of many Citizens as a result of belligerent acts no matter which party is aggressive; and

d. preparation which is probably against international law, and which would influence upon vested rights and make impossible recovery of the present state probably or perfectly if the preparation would be carried out.

Secondly, even if the IC is not able to express its own conclusive opinion on legal facts nor legal principles and rules to be applied to a given case, it may request actors, conflicting parties or specialists to give one’s opinion or evidence and, if the IC itself is ready, the Court may investigate the case.

Any individual can bring a case before the IC

NB2. They may get aid from the central budget as follows:

1. When they succeed in inviting a person to join its national ELFA (Earth-Loving Friendly Association) or the ELFO, it can get aid, the amount of which is equivalent to the person's membership fee.

For example, supposing that a Nepali individual or organization succeeded in inviting a Diplomat, the inviting person will get remuneration of 9 \$ (because a Nepali Diplomat's membership fee is 10\$). In this case

the inviting person can receive **additionally**

2. **An inviting person will have considerable free hand.** While a given national ELFA cannot lay down rules concerning concrete detailed regulations, the person may begin such invitation activity as one likes.

For example, even one person may try to invite all the kinds of members, not only one's nationals, but also foreign peoples. It is desirable and effective, however, that one begins with inviting one's nationals. Supposing that among members (of less than 66% of PPP) only one Nepali person is willing to invite all the kinds of members of the above frame, the person will get 6,750\$ (3,500\$ + 3,500\$ × 90%).

It seems, however, that one cannot monopolize such good system. It is probable that some other incumbent members will appear. Of course, you may conclude an agreement with them concerning areas of invitation or kinds of members to be invited etc.

a Welfare and Medicine Council, a Humanitarian Aid Council, a Communications and Transportation Council, a Resources and Environment Council, an Energy Council, an Educational, Scientific and Cultural Council, a News and Information Council, a Tourism and Accommodations Council, the Sports and Games Council, and the Youth Council.

5. The Earth-Loving Amicable Court has jurisdiction only when both conflicting parties reached compromise to submit their case to the Court.

Article 5 Membership fee

1. The membership fee is determined, taking into account the purchasing power parity (PPP) of each country.
2. The annual membership fee for common members is based on the daily meal fee.
3. The free system for ML members may not apply for a certain period of time and for a certain type.
4. Membership fees shall be used so as not to violate international and national law.

Article 6 Incorporation

1. After 5 years at the latest, present Organization will become a legal person.
2. The location of the Organization shall be in Sapporo city.

Article 7 Final provisions

1. The contents of this agreement are specifically defined by the Charter of the Earth-Loving Friendly Organization and its bylaws.
2. The English and Japanese texts of this Covenant shall be taken as the authentic text, and their meanings shall be interpreted in a harmonious manner.
3. These texts will be kept in the HOUSE for Peace, Welfare and Friendship in Sapporo.

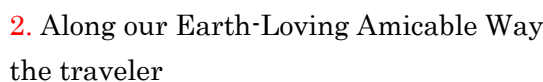

2. The CELAF shall be composed of more than 5 members.
3. While the CELAF is not created, the CELS (CELES) may act for the former.

i. Organizations has the bellow-mentioned right to vote in accordance with the number of its members:

i 5 votes are given to an Organization with more than 10,000 members;

ii 4 votes are given to an Organization with more than 10,00 to less than 10,000 members;

iii 3 votes are given to an Organization Deputy with more than 100 to less than 1,000 members; and

iv 2 votes are given to an Organization with more than 10 to less than 100 members; and

v 2 votes are given to an organization with less than 100 members.

Ammemdmnt (addition):

Article 8 (The right to vote) 1 At the time of deliberation and decision in the General Assembly members poll different votes in accordance with their kinds, in principle, as follows:

(a~g omission)

h. 5 votes are given to a judge, an advocate, professor. a Banker, an Investor, a Medical Doctor, a Journalist and a President of an Organization and so on.

i. Organizations has the bellow-mentioned right to vote in accordance with the number of its members:

i 30 votes are given to an Organization with more than 100,000 members;

ii 25 votes are given to an Organization with more than 10,000 to less than 100,000 members;

iii 20 votes are given to an Organization Deputy with more than 1,000 to less than 10,000 members;

iv 15 votes are given to an Organization with more than 100 to less than 1,000 members; and

v 10 votes are given to an organization with more than 10 to less than 100 members.

vi 2 votes are given to an organization with less than 10 members.

Agenda item N.2.

Administrative Court

As time passes it is more possible that among
ELFO members happen sometimes disharmony,
unfriendly actions or conflicts. So it is desirable to
create in advance an administrative court as was
decided by the GA. But we could not see any expected
draft Statute, I determined to work on it.

President's proposal regarding a Statute of the
Administrative Court of the ELFO (ACELFO) is as
follows:

1st draft of the ACELFO

STATUTE OF THE ADMINISTRATIVE COURT OF THE EARTH-LOVING FRIENDLY ORGANIZATION

For the purpose of maintaining and developing
our ELFO friendly and peacefully among members
our Earth-Loving Friendly Organization (ELFO)

adopted the following Articles of Statute of the
Administrative Court of the Earth-Loving Friendship
Organization (ACELFO or Court).

Article 1 Composition of the Court

The Court shall be composed of five members,
who shall possess judicial experience. Only three
members may **sit in any particular case**.

Article 2 Jurisdiction

The Court shall be competent to hear and pass
judgement upon applications alleging the following
matters:

- a. a member's unfriendly speech and behavior
- b. non-observance of contracts of employment or
appointment of members;
- c. non-observance of commercial contracts;
- d. non-observance of our Charter and rules.

Article 3 Application of norms

The Court shall apply:

- a. The Charter of the Earth-Loving Friendly
Organization and its detailed rules
- b. international conventions, whether general
or particular, establishing rules expressly
recognized by the contesting members;
- c. international custom, as evidence of a
general practice accepted as law;

Article 4 Written procedure

1. The written proceedings shall consist of the
communication to the Court and to the parties of
memorials, counter-memorials and, if necessary,
replies; also all papers and documents in support.

2. Written and oral procedure mau be conducted
through the Internet.

Article 5 Costs

Unless otherwise decided by the Court, each
party shall bear its own costs.

HQ of Council of Resources and Environment

President proposal:

1. ELFO Headquater of Council Resource and Enviroment (HCRE) will be created in Nepal.
2. Its branch will be located in a mini State in Pacific Ocean.

4. Certain amount of budget will be compiled for the HRCE and its branch.

Agenda item N.5

Organizational enrol and Aid

Regarding entry of 50,000 members of Nepali Vegan Society (VS), I President Rikio suggest to the GA to adopt the following proposals of mine:

1. Firstly, 50,000 members of the Nepali VS will be enrolled as central ELFO members, who don't have to send membership to the ELFO.
2. Secondly, at the same time the above members will become automatically a member of the NELFA (Nepali Earth-Loving Association), where they shall pay the membership dues.
3. In accordance with Charter, each of the said 50,000 members has not one vote, but in stead of them the Nepali VS as an Organization has 25 votes. (Article 8 which was amended just in NOV 2, 2021)
4. Each member of the VS, therefore, will not vote, in principle, respectively. Their Representative.



Rudra Poudel (pic) will poll 25 votes in the GA (General Assebbly), representing the VS, provided that each member has right to speak.

- 5. Even if Repr. Rudra Poudel does not express his opinion, the VS’s vote shall be regarded as the same with President’s “Yes” or “No”. Because the latter is the former’s Representative.
- 6. The members of the VS may be a member in an organ other than the GA. It is desirable that they become a member of these organs harmoniously. So far as 22 Councils are concerned, about 2,200 persons of the VS will enter these Councils respectively.
- 7. Mr. Rudra Poudel shall appoint his 22 sub-Repr. of the VS members of each Council. Each sub –Repr. has 25 votes. If he or she does not express yes or no, it is regarded as the same with that of Mr. Rudra Poudel. If he also does not say any word, it is regarded as the same with his Representative Mr. Rikio Kaneko.

Organizations’ Membership Fee

I, Rikio Kaneko found a bit of embarrassing rule concerning organizational annual membership fee.

Question: how much shall the Vegan Society (VS) pay its membership fee? At present there is only one rule in a table of annual dues (see p.2). The rule, however, shall be interpreted so that it concerns only a given President, and does not mean that his or her organization is an ELFO members.

In order to evade confusion, here I want to illustrate a draft annual membership fee, which will be applied not only to the VS, but also to to all the other organizations. My new proposal is as follows:

I To delete, from existing table (p.2) of annual dues, the item concerning the ‘President of an Organization’, whose dues will be included in the wholistic ‘Organzational annual membership fee’ to be made up this time.

II To consider the number of members of a given organization. The more members, the more

dues of the organization.

III A Table of annual membership fee President’s 1st Draft is as follows:

Nepali PPP is within 1%~33%, and Nepali VS’s members are within 10,000~99,000, so that its annual membership fee is 100 &.

Suffice to say that at present we will see if it works well or not. Though VS shall pay 100 &, they will receive more than that sum from the central Budget of the ELFO as is mentioned below:

Remuneration of 290% of membership fee

ELFO member knows “Remuneration of 90 % of membership fee for an incumbent member, PPP of whose country is 1~33 %, and of 70%, PPP of whose country is 34~66 %.” (Decision of the GA of June 22, 2021) In this case the 90% or 70% of remuneration may be used for one’s private purpose.

As there was no good reaction wishing to receive 190% of membership fee, then I proposed:

- 1. 290% clause, provided that it will applied to incumbent members, PPP of whose country is 1~33% (for example Nepal)
- 2. Additional aid will be adjusted as seen in the bellow table.

NB1 Blue number is sum of money to be sent from the central budget of the ELFO to an inviting individual, an organization or a group for welfare or for defeating corona virus. It is 3,500 \$ in all

Ex.1. Exemplary explanation of 1,300& of above table: 1,300\$ is fund for inviting Diplomats whose membership fee is 10\$. For example, a Nepali member or any member of any ationality may try to invite a Diplomat whose membership is 10& within 1,300& fund.

Ex.2. A Nepali individual or an organization may try to invite a Indian Diplomat (Membership fee 20\$) or MP (16\$) within fund of 100 and 200 respectively.

NB2 Nepali Example They may get aid from the central budget as follows:

When they succeed in inviting a person to join its national ELFA (Earth-Loving Friendly Association) or the ELFO, it can get aid, the amount of which is equivalent to the person's membership fee.

For example, supposing that a Nepali individual or an organization succeeded in inviting a Diplomat, the inviting person will get remuneration of 9 \$ (because a Nepali Diplomat's membership fee is 10\$). In this case the inviting person can receive additionally 20\$ from the central ELFO budget. In all 29 &

NB3 Free hand An inviting person will have considerable free hand. While a given national ELFA cannot lay down rules concerning concrete regulations, the person may begin such invitation activity as one likes.

For example, even one person may try to invite all the kinds of members, not only one's nationals, but also foreign peoples. It is desirable and effective, however, that one begins with inviting one's nationals. Supposing that among members (of less than 66% of PPP) only one Nepali person is willing to invite all the kinds of members of the above frame,

the person will get 6,750\$ (3,500\$ + 3,500\$ × 90%).

It seems, however, that one cannot monopolize such good system. It is probable that some other incumbent members will appear. Of course, you may conclude an agreement with them concerning areas of invitation or kinds of members to be invited etc.

Fair distribution of Remuneration

Besides the Vegan Society (VS), there are some other individual or organization which wants aid for welfare and defeating coronavirus.

The total amount 3,500 \$, however, will flow to Mr. Rudra Poudel if neither other individual nor organization succeed in inviting people to join ELFO Family. I, President of the ELFO, am a little bit apprehensive of the money flow regarding 2 point:

- A. In case the ELFO has not enough money
- B. If there would be or not dissatisfaction in the VS
(I will write more in detail next time.)

Actual Payment

There are 2 kinds of payment regarding the VS:

- A. Payment to the VS as an organization and
- B. Payment to an individual VS member.

A. Payment to the VS as an organization

1. When the VS presents 50,000 members' list and pays its membership fee 100& to the NELFA (Nepali Earth-Loving Association), Mr. Rudra Poudel has right to receive 90 \$ as remuneration from the NELFA because he succeeded in invitinag an organization to join ELFO member.
2. As soon as the ELFO knows the above payment, it sends 100\$ to Mr. Rudra Poudel as the first half of payment of 200\$ for welfare and defeating coronavirus. He must open his bankbook in Paypal.
3. The ELFO will send him the other 100 \$ after he has acomplished the work to appoint 22

sub-Representatives for 22 ELFO Councils. When a given sub-Representative is inactive, Mr. Rudra Poudel shall appoint another VS member.

B. Payment to an individual VS member.

1. When a VS member succeeded in inviting a person to join our ELFO member, and the new member paid annual membership fee, the VS member may receive from the **ELFO account** in Nepal.
2. The said ELFO account consists of the **rosened part** of membership fee table. (See p.2). The VS member who succeeded in inviting a person to join our ELFO member will receive remuneration from an accountant appointed by the ELFO.
3. While the **ELFO account** is deficit, the invitation activity in this sector shall be stopped.

NB. Paypay has something to do with Nepal and India, please search through the Internet.

Agenda item N.6

A House for Peace, Welfare and Friendship

Charter, Article 53 lays down:

1. A Member-State shall encourage so that a HOUSE for Peace, Welfare and Friendship or Earth-Loving Oasis of comprehensive character be built in a State concerned, which a friendly autonomy or other subject might control and manage irrespective of the ratio of the Member-State investment.



On the other hand, there is no Article in our Charter as for the ELFU (Earth-Loving Friendly University), so that to create a HOUSE for Peace, Welfare and Friendship shall be regarded at least as important as creatinig.

Agenda item N. 7

Finance of the ELFO

President Rikio Kaneko's proposal (king's blue):

A. Annual membership fee of members who have not their ELFA or club.

There are many countries where neither national ELFA (Earth-Loving Friendship Association) nor a club is organized. So long as they are unorganized, members shall pay their membership fee to the central account of the ELFO.

B. Annual membership fee of Dilomats of international organizations.

It is decided in accordance with PPP of their countris, not by population related to the organizations.

C. Annual membership fee of new members who enter our ELFO by June 30, 2022.

They shall pay full sum of their membership fee without discount. It means that a new member who will enter the ELFO during July 1, 2021~December 31, 2022 may whith half ofone's annual fee.

Agenda item N. 8

Procedure of the GA

GA Chair Irina Karpekina's proposal (rosy part):

A. Right to present agenda item, bill or proposal.

Up to present time all the bills (agenda items, their concrete contents) have been made up only by an energish ELFO President Rkio Kaneko. Now several Principal organs began to function with a Chief in each of them. It is obvious that the President cannot draft all the bills as before. He is 79 years old.

I am the 2nd member who dared to present my idea about a bill to be deliberated in the ELFO in order to lighten very heavy burden on President's shoulders. I propose the followings:

- a. Every member of our ELFO has a right to present to the GA one's draft agenda items and its concrete contents (bill).
- b. Every Chief will try to make up a bill and present it to one's organ, consulting in advance the ELFO President.
- c. ELFO President may decide whether to deliberate or not a given agenda item, adjust agenda items among organs.

1. *It is ELAs who decide its continuation and functions or the disband of this group.*
2. *Even if ELAs continue to exist, they will not have any privileges in the ELFO.*
3. *ELFO Secretariat and interested persons shall update many old docum as soon as possible.*

B. Preparatory opening of a bill (a proposal)

1. President, any Chief of an ELFO organ, and any member of the ELFO may send one's bill to the concerned organ, and the bill may be opened in advance before deliberation.
2. From that moment any member may send question or opininon to the proposer, who is responsible to answer them even before opening meeting.
3. Such preparatory opening of the bill continues opened more than 3 days, GA Chair may decide adoption of the bill on the 3rd day at 20:00 if there is no objection.

President proposal was adopted by the GA unanimously in DEC 9, 2021.

C. Annocement to open an assembly or meeting

- 1) An assembly or meeting through the Internet will begin at 10,00 in the morning by Japanese time, and it may be adopted next day if there is no objection by 20:00.

Agenda item N.9. ELFO relations to ELAs

The other day President sent you his Proposal which reads as follows (italic):

Agenda item N.1. Ammendment of the Charter.

President Proposal:

The last part of the Charter will be as follows:

Article 100 (Location and Authentic text) 1. The General Assembly shall determine every 25 years the location of the headquarters of the Organization.

1. In the present Organization for 25 years the English and Japanese texts are equally authentic, and the Chinese, French, Russian, Spanish and Arabian texts are subsidiary.

An additional clause on donation

Bellow-mentioned List of **Donation** is an indivisible part of the present Charter. Donors' names shall be carved in the **present** Charter and **ELFO** archives, thereafter being praised forever.



Thus I propose to the GA that the President may add donator's name to its list without recognition by the GA though "an additional clause on donation" is "an indivisible part" of the Charter.

At any time any donator may contribute more money than the original donation.

Honorable Member

I also propose to the GA that the members, who has paid 5 years membership fee in advance, would be praised as an honorable member of the ELFO, provided that other kinds of Hon. Member may be created. (DEC 27,2021)

Any member having contributed considerably to the development of the ELFO, even if has not paid 5 years membership fee in advance, may also be recognized as an Honorable member.

The Deputies Council is composed in all 26 Deputies, while the DD (Department of Deputies) will consist of numerous Parliamentarians and other deputies from many countries around the world. And it will be necessary to create many committees as provided for in Article 44. I propose to set up the following Commissions corresponding to a Principal organ of the ELFO:

1. Commission for the General Assembly;
2. Commission for the Solidarity Department;
3. Commission for the Religion and Ethics Department;
4. Commission for the Deputies Department;
5. Commission for the a Department of Peace;
6. Commission for the Department of Friendship;
7. Commission for the Department of a Judicial Affairs;
8. Commission for the Department of Territories and Boundaries;
9. Commission for the an Economic Social Department;
10. Commission for the Finance and Industry Department;
11. Commission for the a Human Rights Defense Department;
12. Commission for the Department for Employment and Labor;
13. Commission for the Department of Welfare and Medicine;
14. Commission for the Department for Humanitarian Aid;
15. Commission for the Department of Communication and Transport;
16. Commission for the Department of Resources and Environment;
17. Commission for the Department for Conservation of Resources;
18. Commission for the an Energy Department;
19. Commission for the an Educational, Scientific and Cultural Department;
20. Commission for the Department of Tourism and Accommodations;
21. Commission for the Department of Sports;
22. Commission for the Youth Department;

The names of these Commissions are the same with those of the ID (Interstate Department). As there are so many VIPs and Diplomats in the ID, the GA (General Assembly) decided to set up such 22 Commissions there.

Agenda items 1 and 2 were adopted.

President explanation: Emuneration system for incumbent members began in Nepal, by which they can get a certain remuneration when they succeed in inviting people to join ELFO Family. High amount of remuneration is applied to members of low PPP. At present they will get remuneration as follows:

1. A member, PPP of whose country is 1%~33%, can get 90% of membership fee of a new member.
2. A member, PPP of whose country is 34%~66%, can get 70% of membership fee of a new member.
3. A member, PPP of whose country is more than 67%, can get 20% of membership fee of a new member.

In order to further members' income for welfare and defeating coronavirus, our GA (General Assembly) adopted 290% Clause (see at page 44 of the URL: <http://mopw.org/ga7-jan.%202022.pdf>)

What does '290%' mean? For example, a Nepali member, the PPP of whose country is within 1%~33%, can get not only 90% of membership of a new member (for one's private use), but also its 200% from central budget of the ELFO (for purpose of welfare and defeating coronavirus). It means that an incumbent member, the PPP of whose country is within 1%~33%, can get **remuneration of 290%** of membership fee of a given new member.

President's summary proposals

- A. an incumbent member, the PPP of whose country is within 1%~33%, can get remuneration of 290% of membership fee of a given new member.
- B. an incumbent member, the PPP of whose country is within 34%~66%, can get remuneration of 270% of membership fee of a given new member:
 - a. 70% remuneration from a membership fee;
 - b. 200% of it from the central ELFO budget.
- C. If our member of an organization succeeds in inviting one's own or other organization, 90% or 70% of the organizational membership fee flows to him or her, but its 200% remuneration will be paid from ELFO budget to the organization as an aid for welfare and defeating coronavirus

The 2020 coronavirus pandemic in Sri Lanka is an ongoing viral pandemic of coronavirus disease 2019 (COVID-19), a novel infectious disease caused by severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2). As of 27 April 2020, 588 confirmed cases have been reported in the country with 7 deaths. On 3 March 2020, the first reported case involving a Sri Lankan origin outside Sri Lanka was reported in Italy. As of 23 March, forty-five quarantine centers have been built in the country by the Sri Lanka Army as a preventive measure to tackle the coronavirus pandemic. Nearly 3,500 people have been under quarantine in 45 quarantine centers which also include 31 foreigners from 14 countries.

As of 25 March 2020 Sri Lankan authorities have tracked down over 14,000 people who had contacted

the identified patients and had ordered self-quarantine for such people.
