The other day Mr. Alain Nkongnenwi sent us his message (p.2) on delegation to be sent to belligerents Russia and Ukraine. This was so important matter that we deliberated it in the 1st session of the 1st GA.

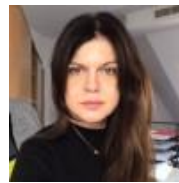
### Report N.3 Election of Leaders

I reported by my MM (Mail Magazine) that in June 15, 2022 I had met a Russian Diplomat in a banquet in Sapporo (pic.), and that greeting him, I had handed a pamphlet where you can notice a mention of our ICO and ICCRUW, and had asked him to receive our Delegation for Peace and Friendship between Russia and Ukraine.



*As it is unequal to send info only to one of the parties, I will send the same info to our Ukrainian Diplomat Ms. Natalia Radyvynchuk (in JUN 11, 2022 she joined our ELFO).*

## 1st GA Agenda Items

Pres. Rikio proposed the following agenda items, which the ICO GA adopted unanimously:

### Agenda item N. 1.

#### Temporal Chairperson of the ICO

No one recommended oneself as a Chairperson of the ICO. So as before, Mrs Irina Karpekina will be a temporal Chair of the ICO.

### Agenda item N.2

#### Fundamental policy of Conciliation.

When Pres. Rikio Kaneko announced his candidacy for ICO Presedent, he expressed his political opinion regarding this new international organization ICO. He proposed to the GA to adopt Clauses N.1~N.5, all of which our GA adopted unanimously:

## 1. The ICO must be a source of HOPEs

Our ICO as well as the ELFO must be always and everywhere a source of HOPRs for human beings. Human beings do both good conduct and bad deed. In these grey and rainy days, let us both ICO and ELFO march along peaceful and harmonious way, **For love, not hatred; by construction, not destruction; not dividing, but uniting people's hearts warmly.**

## 2. See people's distress

See people's sadness and unhappiness caused artificially by human work, which leads to many conflicts and even to war. In our heart we cannot be calm. Let us both ICO and the ELFO refrain from deeds which would increase people's anguish. **Remebering people's distress, hoping recovery, to all wishing happiness, health, success and calm family** (Earth-Loving Song), let's go with kind heart.

## 3. Life and Happiness are the first

Human beings are injuring or killing each other with or without justification. In any conflict the disputing parties may settle it reasonably and peacefully if they are ready to compromise on the basis of respect of peaceful settlement as stipulated by UN Charter, Art. 33 or in accordance with equity and goodness (ex aequo et bono). Common sense demands mutual compromise, ceasefire and conclusion of peace traty, neither mutual destruction nor killing precious lives.

## 4. Dangerous Escalation of Russo-Ulrainian War

If Russia and Ukraine continue war, and NATO supports Ukrainiane militarily, the world situation will be darker and darker, it may be possible that war may escalate into Ukrainian attacks of Russian territories (or even Moscow), anyway it is clear that more horrible destruction and loss of countless lives will be caused by such military choice.

## 4. Impartial and equitable approach

Both the ICO and the the ICCRUW must try to find peaceful settlement of a conflict or belligerency through impartial and equitable approach which means that a party compromises in some fields, and instead of them, the other party also compromises in some other sectors equitably and harmoniously.

## 5. Win and Win, not one belligerent's surrender

The ICCRUW should present to both of the belligerents such proposals by which two parties may not feel complete defeat. So that the ICCRUW should avoid proposal to be sent to one of belligerents, by which the ICCRUW recommends to surrender in the present war.

*Aforementioned 5 cluase are 5 fundamental principles pf the ICO and the ICCRUW. Besides them, we, especially the PAD (Peace and Amity Delegation), must formulate detailed concerning internal, external policy, and essential matters of conciliation:*

### ***A. Internale policy***

- 1. The PAD shall respect decision and recommendation.*
- 2. Members shall respect opinion of Dr. Leo Rebello when meeting goes on between the PAD and a belligerent, because he is Chief of the PAD.*

### ***B. External policy of this time***

- 1. Impartial attitude: the PAD refrain absolutely from partial or unequiqble attitude.*
- 2. Fair and amicable aproproach: when a belligerent leader or authorities express their opinion which criticizes or comdemns the other belligerent, Dr. Leo Rebello may comment on the given matter as his "private opinion", but shall never criticize or comdemn his dialogist.*

### ***C. Essential matters***

*The 8<sup>th</sup> ELFO GA adopted as 'Detailed content of conciliation' the followings:*

#### ***I . Principles of conciliation***

- a. A conciator shall try to find neutral equitable conditions to which belligerents are most likely to agree.***

- b. Conciliator shall not mention lawfulness or unlawfulness of a given action of belligerents while conciliation goes on.*
- c. Conciliator shall study in advance relevant facts and opinions of both belligerents equally.*
- d. Conciliator shall study in advance relevant facts and opinions concerning belligerents equally, trying to find matters to which they are most likely to agree early.*
- e. A conciliator shall respect instruction from the authorities of the Organization.*

## *II. Embodying the contents of cease-fire*

*My ideas are to propose to cease fire in such a time as the belligerents agree to:*

- ① while both of belligerents are negotiating, sitting face to face;*
- ② while both of belligerents are negotiating through online;*
- ③ From 00:00~08:00 in the morning*
- ④ X-mas day from 00:00~24:00;*
- ⑤ 1<sup>st</sup>~3<sup>rd</sup> of New Year;*
- ⑥ Besides them the ELACC may propose and welcome any agreement on cease-fire partly or wholly at any time and in any place.*

*I want the PAD very much to study the following essential important matters of conciliation in advance!!*

*III. Nonaccession to NATO*

*IV. Territorial Problems.*

*V. Humanitarian corridor*

*VI. Non-use of ABC weapons*

## *Agenda item N. 3.*

### *Peace Delegation to belligerents*

Our ELFO member Mr. Alain Nkongnenwi (below pic.) sent to Mrs. Irina Karpekina his message which reads as follows:



*Hello Irina-K,*

*Trust you are well. I just wanted to ask when we are to start the peace mission between Russia and Ukraine since we haven't made a concrete decision on the date, budget, team, visa application for those who will need one, duration etc.*

*I believe these are some of the key elements we need if we want to move from the excitement conversation to the practical peace talk between these two nations. Firstly, 90% and more of the world's population have spoken and will keep talking about the current situation but I believe what makes us different is in the application of what we speak.*

*From my viewpoint, this commission has as objective to put a stop to the current war and not to talk more about the war without action. My proposal is thus:*

- 1. Fix a set date the team will go to Russia and Ukraine*
- . Ensure the budget that is put into place will facilitate the teams meeting with both presidents on individual basis and collectively.*
- 3. We should apply for visa as a team.*
- 4. We should have professionals in international Law as consultant, if we don't have experts in international Laws in our team.*
- 5. We should have a timeframe of less than a month to have talks with both parties and propose resolutions of the peace process.*

*These are some of the points we started talking (Edmario and I) before Edmario proposed I should*

*share these points with you and the team to ensure, we are all in Sync.*

I answer him here as follows:

*Dear Mr. Alain Nkongnenwi*

*Thank you for your email. From the bottom of my heart I wish your success in talk with belligerent Leaders. See your Questions and my Answers:*

*Q1: Fix a set date the team will go to Russia and Ukraine*

*A: It depends mainly upon Russian and Ukrainian Leaders' convenience as well as our delegation's good readiness. Delegation's study of situation is not satisfactory at present time.*

*Q2: Ensure the budget that is put into place will facilitate the teams meeting with both presidents on individual basis and collectively.*

*A: By the GA decision it is already agreed, in principal, as follows:*

*a.As for Amb. **Abraham Kitembo**, he will pay all his cost necessary for his visit, including transport, hotel, foods etc. Later the ELFO GA decided that half of income of the first fiscal year of his national ELFA will be used for his travel when it was established.*

*b. As for BELFA President Edmario Peixinho, he expressed his readiness also to pay all his and interpreter's costs for traveling there, the GA decided that half of the BELFA's income of this fiscal year will be used for him.*

*c.As for Dr. Leo Rebello, he will pay all his costs necessary for flying and staying there.*

*I propose that the BELFA subsidises your costs. The BELFA will decide it finally. Please try to open the BELFA GA.*

*Q3: We should apply for visa as a team.*

*A: It's too early. You know, it is not clear if they receive our delegation or not.*

*4. We should have professionals in international Law as consultant, if we don't have experts in international Laws in our team.*

*A: Of course, it is very diserable. See scholars at yesterday's MM.*

*5. We should have a timeframe of less than a month to have talks with both parties and propose resolutions of the peace process.*

*A. Of corse, we must make up a concrete schedule.*

*Dear Alain Nkongnenwi, I am pleased if you will study the history of negociation on cease-fire and peace between Russia and Ukrain. By all means our Peace Dealegation (PD) and its **each Peace Ambassador should know very well the history of cease-fire negotiation and mediation.***

*Dear Alain, please prompt reply to me. These matters are very important. Let's go ahead as fast as we can.*

In June 14, Mr. Alain Nkongnenwi sent his answer to Sapporo:



*Sorry for the late reply, I didn't receive your email but I just saw your response in one of the attached files a minute ago.*

*I will be glad If BELFA subsidies/assist me with the cost. I recently started reading some peace deals and negotiations articles and documents recently and will be happy keep to read more.*

*I believe we can send official request to the president of Russia and Ukraine to request for audience in regards to the War. In our request, we should try to include a date or period we will like as part of the proposal (that way, if they are not comfortable with our proposed date, they can suggest ahead of time).*

*I also do agree we can't just go there without notifying them of our intentions and coming.*

*Thank you for your paying attention to the war and peace between belligerents. Dr. Leo Rebello is very very busy with election of Indian President. So that I ask you to study more in detail about negotiation of cease-fire, equitqble compromise, some models of peace treaty etc.*

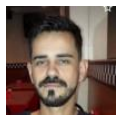




## *PAD's personal sphere and costs*

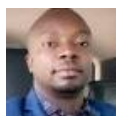
*Personal sphere of the PAD may be widened by ICO President Rikio Kaneko's recognition, who wishes big delegation. At present the following members are recognized by the GA.*

*BELFA Pres. Mr. Edmario, his interpreter, a BELFA member Alain Nkongnewi, Amb. Kisembo, and a candidate for Indian President Dr. Leo Rebello will be sent to meet Belligerent Top Leaders.*



*They would be sent to Ukraine and/or to Russia as an ELFO Peace and Amity Ambassador.*

*Amb. Abraham Kisembo may visit also Moscow for conciliation between belligerents as our ELFO Peace and Amity Ambassador by his own costs.*



*A candidate for Indian President Dr. Leo Rebello also will be sent to Russia and Ukraine also by his own costs.*



*A half of the income of the BELFA (Brazilian Earth-Loving Friendly Asociation) and the future UELFA (Ugandan Earth-Loving Friendly Association) will be used for the costs for BELFA Pres. Mr. Edmario and Amb. Kisembo respectively.*

### **Agenda item N. 4.**

#### **Additional rules to Charter**

My proposa is to add **rosy phrase** to the present Article 7:

### **Art. 7. General Assembly**

1. The General Assembly is composed of all the Members of the Organization.

2. The main functions of the General Assembly include the following matters:

- a. to deliberate and adopt a draft PROPOSAL on conciliation to be sent to the conflicting or billegerent parties;
- b. to propose them such steps as may mitigate

tension between them;

- c. to elect President and a Chairperson, **provided that there is no candidate for a Chairperson, President may appoint a member as the Chair.**
