Hon. Pres. Rikio says, "In nature living things are busy with their work, you see beautiful flowers blooming here and there, but due to wars tears and rain appear in numerous people in their eyes and heart around the world. If you consider maximum of happiness of all human being, not of specified group, it is clear we should not encourage to pour oil into fire, but cold water for making their brain cool."

Ergent STATEMENT on Gaza

Pres. Edmario, his Acting Pres. Titus and 2nd Pres. Kisembo in charge of foreign affairs could not announce Urgent Statement promptly in face of catastrophic situation around Gaza, and Hon. Pres. Rikio began immediately to draft it, and in Oct. 30, 2023 posed it to both General Assembly the ELFO and the ICO (International Conciliation Organization).

According to new 24 rule of deliberation, both GAs of the ELFO and ICO are to be regarded as having adopted the emergent Statement though I did not declare its adoption. It is my interpretation of new rule of 24 prompt deliberation. And I Irina Karpekina decide that it was adopted in Oct. 31, 2023 provisionally. Final decision will be at the time of closing of current General Assemblies. The Statement adopted on Oct. 31, 2023 reads as follows:

Joint STATEMENT by ICO and ELFO concerning Gaza Situation

We, co-senders of present Joint Statement, have honor to introduce us. The one is Hon. Prof. of Sapporo University Rikio Kaneko, President of the ICO (International Conciliation Organization), and the other is a Brazilian Edmario Peixinho, President of the ELFO (Earth-Loving Friendly Organization). Both of our Organizations aspire after world peace and amity, and have made efforts to restore peace and friendship among nations concerned, including Russia and Ukraine, and sent our Proposal to Indian and Nepali Government concerning border conflict.

This time ICO and the ELFO decided to send to Your Government and Hamas our joint Statement of the ICO and the ELFO for contributing to promotion of peace and friendship. We are happy if your Government and Hamas understand the statement even partly which was adopted unanimously in October 31, 2023 by the both of General Assembly of the ICO and the ELFO, which declares as follows:

We request the belligerent Israel and Hamas

1. to stop immediately war, and not to touch weapons for killing any more;
2. to begin negotiation promptly by the Internet or on the table;
3. to respect a principle of mutual reasonable compromise;
4. to try to agree to general or partial truce in time and place;
5. to submit contesting matters to international conciliation if belligerents are not able to settle them;
6. to submit, if belligerents cannot agree to conciliation, legal problems to the International Court of Justice;

We request the United Nations

- a. to ask both of belligerent Israel and Hamas to stop war immediately, never encouraging use of force;
- b. to pay utmost consideration to save peaceful inhabitants, especially, children, women, and hostages;
- c. to consider the most important principal of the greatest happiness for all human beings, not special group;
- d. to be the best good office, the best mediator, the best conciliator by creating UN Conciliation Committee;
- e. to propose to the belligerents a comprehensive compromise on the basis of equity or ex aequo et bono;
and
- f. to request Advisory opinion from International Court of Justice concerning legal matters.

1. Creation of many Arbitration Courts & Conciliation!!

You can remember that Secretary Hope Watanabe (pic.) proposed to the ELFO GA to adopt below mentioned many kinds of **OJAC (One Judge Arbitration Court)**, and afterwards Hon. Rikio Kaneko added **TJAC (Three Judge Arbitration Court)**.



Not only this, he also proposed **OPAC (One Person Amicable Conciliation)** as well as **TPAC (Three Persons Amicable Conciliation)**. As there was no objection to it, I decided the adoption of it.

- N.1. OJBAC (One Judge Border Arbitration Court)
- N.2. OJSAC (One Judge Sea Arbitration Court)
- N.3. OJHRAC (One Judge Human Rights Arbitration Court)
- N.4. OJRAC (One Judge Refugee Arbitration Court)
- N.5. OJCAC (One Judge Commerce Arbitration Court)
- N.6. OJIAC (One Judge Investment Arbitration Court)
- N.7. OJIPAC (One Judge Intellectual Property Arbitration Court)
- N.8. OJCAC (One Judge Criminal Arbitration Court)
- N.9. OJTAC (One Judge Terrorism Arbitration Court)

As for means of settlement of border conflict, today both ELFO and the ICO recognized 4 forms: **OJBAC**; **TJBAC**; **OPABC** (One Person Amicable Border Conciliation); and **TPABC** (Three Persons Amicable Border Conciliation). It is the same with other legal sectors (N.2~N.9)

2. Rules on Presidents and other important Staffs

More simplified and speedy deliberation of the agenda items

As there was no objection, the other day I decided adoption of the below mentioned rules by the ELFO and the ICO:

1. When one matter or an agenda item with clear content is posed to the General Assembly, the Chair may decide it after 24 hours for deliberation if there is no objection to it.
2. In such case the adoption of the matter or agenda item may be announced at the time of summarization of a given round of the General Assembly.

Then Hon. Pres. Rikio proposed to insert these rules in the **Rules on Presidents and other important Staffs** as seen in an attachment, adding new rules adopted by our GAs. As there was no objection, I decided its adoption speedily in accordance with a new 24 hours rule.

2. Provisionally 3 Presidents of ELFA were elected!!

I asked several times below mentioned candidates to send send me their oath and political opinions (open promise with their compatriot members) in vain. I request them again and again to do. The GA decided that the bellow mentioned **3 candidates would be President of their ELFA at the time of my receiving their political opinion (policy) and Oath.**

In according with **Rules on Presidents and other important Staffs**, present election is administered as follows (Article). A candidate wins election, provided the following conditions are satisfied:

- a. The member will send to the ELFO GA one's determination (political opinion or policy) to be President of a national ELFA.
- b. No opponent candidate appears within 10 days after the notification, by the GA Chair, of the 1st candidate's above determination to GA members.
- c. The GA shall decide procedure when more than 2 candidates appear.
- d. Without presenting political opinion or policy and Oath any candidate shall not be regarded as having won election.

4. Candidate Mr. Datu for President of the NELFA!!

Dear NELFA Pres. ex-Amb. Yuba Nath, will you please send your greeting to Amb. Mr. Datu, who is inclined to be NELFA President, tell him your wish?

Dear ELFO Pres. Edmario and ELFO Acting Pres. Titus, will you please send your greeting to Amb. Mr. Datu, who is inclined to be NELFA President, tell him also you wish? And tell me please if Nepali members want to administer election by NEAC (National Election Administration Commission), or they or you want CEAC (Central Election Administration Commission) preside the presidential election. 1. Rules on Presidents and other important Staffs

There was no objection to Hon. Pres. Rikio's new draft Rules on Presidents and other important Staffs, so today I decide its provisional unanimous adoption by GAs of the ELFO and the ICO (International Conciliation Organizaton). It is "provisional" in the sense that it will be decided finally at the end of the current General Assembly.

These Rules are so important that I asked Hon. Pres. Rikio to show introduction and all the text with his explanation and comment on Articles:

Rules on Presidents and other important Staffs

October 11, 2023

ELFO Hon. Pres. Rikio Kaneko

Introduction

Our ELFO had its **Rules on Presidents and their concerned Staffs** (click [here](#)), afterwards I proposed to rename it as **Rules on Presidents and other important Staffs**, because it reflects more exactly contents of many Articles therein.

Currently our ELFO Family has 2 international Organizations, namely: the ELFO and the ICO (International Conciliation Organization) and several national ELFAs (Earth-Loving Friendly Association).

The ELFO adopted a new system of PRESIDENT of 3 HEADS, but these 3 HEADs (1st Pres., 2nd Pres., and 3rd Pres.) are not accustomed to the new system yet, so its movement is very slow as a tortoise, so I am obliged to do many things for them. Sooner or later they may move faster. One of the causes was that their functions were not clearly stipulated. So I and GA Chair Irina Karpekina presented clauses to be added to the Rules on Presidents.

The old original Rules on these leaders were simple ones having only 17 Articles.(Click here [Rules on Pres.](#)). And GA Chair decided in [JAN 6, 2023](#) the adoption of the new Rules. But our experiences told you that more elaboration was far better than the former Rules, so that I and GA Chair Irina Karpekina proposed jointly to the GA the additional phrases (*Rosy italic*) to the 2nd Rules. (*Italic King's blue* is my comment, and [blue sentences](#) are her comment.) And then the GA of the ELFO and the ICO adopted the ammended Rules in [JAN 16, 2023](#) which is recorded in our web-site [here](#).

Considering slow development of national ELFA (Earth-Loving Friendly Association), the GA adopted additional rules which are written with [green sentences](#). And in [SEP 29, 2023](#) I showed you my new proposal or amendment with [red phrases](#) to keep harmonious development of our ELFO FAMILY.

And in [October 09, 2023](#), considering current appearance of many candidates for President of national ELFA, and feeling it necessary to elaborate Articles on election, I presented my wholesome draft [Rules on Presidents and other important staffs](#) which were adopted today (OCT 11, 2023) and which you see at the following pages.

I am very grateful to our all members of the ELFO FAMILY for their understanding the importance of the present Rules, and I expect that in future more and more positive Presidents domestic and international and other leaders will appear, moving our ELFO FAMILY faster with HOPEs and LIGHTs along a Earth-Loving Amicable Way, singing happily Earth Loving Songs!!

Rules on Presidents and other important staffs

Considering that in our ELFO FAMILY there are already many kinds of Presidents, and that in future there will appear more and more Presidents in our FAMILY, now it is necessary to elaborate rules concerning Hon. President, Presidents, Acting Presidents, Vice-Presidents, Advisors, Consultants, Assistants, Chairperson of the General Assembly, and Election Administration Committee etc.

In December 25, 2022 the General Assembly (GA) of the Earth-Loving Friendly Organization (ELFO) and the GA of the International Conciliation Organization (ICO) adopted unanimously the “Rules on Presidents in ELFO FAMILY” as is seen in the URL: <http://mopw.org/rules%20on%20pres..pdf>

Present Rules on Presidents and other staffs are results of our wishes to develop the ELFO FAMILY more friendly, harmoniously and effectively without bureaucratic color by dividing many complex functions among competent collaborators willing actually to contribute to making our FAMILY and Planet better.

Chapter 1. General Rules

Article 1. At any time and in any place any ELFO member may suggest one's idea to develop ELFO FAMILY, to create a subsidiary organ for promoting friendship and peace among nations, and may announce one's willingness to be ELFO President, Acting President, a Vice-President, or any other staff.

Any positive member may propose to create a subsidiary organ, expressing one's willingness to be a head thereof.

Article 2. Present Rules may be applied, with necessary qualifications, to status of important staffs of ELFO MAMILY: namely, the ICO (International Conciliation Organization), and many national ELFA (Earth-Loving Friendly Associations) etc.

Chapter 2. Hon. President of the ELFO

Article 3. President, who was recognized by the ELFO GA as having rendered great contribution to the development of the ELFO FAMILY, may be Hon. President of the ELFO.

Article 4. There may be 2 kinds of Hon. President. The 1st category of the Hon. President may continue to have its former competence to act when incumbent President or other staffs cannot realize one's functions as is expected, while the 2nd category of Hon. President has not, in principle, such rights and any duties.

Former ELFO Pres. Rikio Kaneko was recognized as the 1st category of ELFO Hon. President because he had stated he would be so if there would no objection, and his contribution to our ELFO was very great and actually he is Representative of overwhelming majority of ELFO FAMILY members. (Irina K.)

Please pay due attention to the aforementioned important rule which reads as follows: "The 1st category of the Hon. President may continue to have its former competence to act when incumbent President or other staffs cannot realize one's functions as is expected". Present situation seems to be at such stage. Communication between new Presidents is rare due to inconvenience of the 1st President's very restrictive channel.

Article 5. Hon. Presidents and other members may suggest the post (status) of a new member whom they invite to join the ELFO FAMILY, provided that President will appoint him or her later officially. In case of absence of the official appointment, the new member shall be regarded as having the post suggested by the inviters.

Such procedure will lighten the Presidents' burden considerably. Daily I, Hon. Pres. Rikio, and Irina Karpekina is succeeding in inviting Diplomats or personalities to join the ELFO with suggesting their position. See, for example:

P.S. Here is my "Present" to you for Happy New Year!! Please see an attachment at pp. 5~8. There are many vacant seats where a suitable member may sit. I am very glad if you are willing to receive my "Present" of seat of Consultant for 3rd President Ajay Singh from India. He will appoint you officially. I am looking forward to your prompt reply.

Article 6. Hon. Presidents of both categories may continue to have right of vote provided for in ELFO Charter, Article 8. Hon. Presidents are regarded as a member of the ELFO FAMILY even after their retirement without membership fee.

The Article 8 reads: So long as a member does not express yes or no, his or her Representative shall be regarded a mandatory, and his or her yes or no shall also regarded as the same with that of Representative.

Article 7. Hon. President of both categories may, rather are expected to, invite many VIPs, Dignities, Diplomats and other personalities to join our ELFO FAMILY, and remuneration will be paid to them alike as to other members in accordance with rules, **provided that essential system of this remuneration shall not be changed.**

Chapter 3. Presidents and Vice-Presidents of the central ELFO

Article 8. Incumbent President and Vice-President will continue to remain as present position so long as new President and Vice-President do not appear and, even if they are elected, are not recognized by incumbent President by Certificate.

Article 9. If one member recommends oneself as a candidate for President or Vice-President, presents an oath that he will actually perform one's roles expected by our ELFO FAMILY, and join an open forum conducted by ELFO President, they will be regarded as having

won the election. In the open forum former President, Hon. President and other members may participate.

Article 10. If no member stands as a candidate for the vacant seats, 2nd prolonged election will be conducted in 14 days after the scheduled 1st election.

Article 11. In 2nd prolonged election any suitable member may be candidate for them, declaring oath that he will actually perform his roles expected by our ELFO FAMILY. In the open forum former President, Hon. President and other members may participate.

Article 12. Plural members may declare one's candidacy for Presidents or Vice-Presidents, provided that they will announce their political opinion and join an open forum conducted by ELFO President or **Hon. President**. Such a candidate may be regarded as elected automatically if there does not appear an opponent candidate.

Article 13. Under system of PRESIDENT of 3 HEADS, 2nd and 3rd Presidents have rights of appointment of their Acting Presidents, Advisors, Consultants and Assistants, and staffs of their subsidiary organs. All the other staffs shall be appointed by 1st President, with reservation of Article 5.

Chapter 4. Presidents' Functions under PRESIDENT of 3 HEADS

Article 14. The 3 Presidents shall respect the following rules:

- a. They shall pay attention to friendly cooperation and harmonious division of works among them under 1st President's leadership, if it is impossible, under 2nd President's leadership;
- b. They shall keep good communication among them, and if any of them cannot answer the other President, his or her Acting President or an assistant shall answer provisionally; and
- c. 1st President may, in his or her own judgement, may announce President's Declaration or Statement, while both the 2nd President and the 3rd President may, with 1st President's **or GA's** approval, make a Declaration in its name.

ELFO Charter, Article 22 stipulates that "President may, in his or her own judgement, may announce

President's Declaration, while each Head of the primary organs may, with President's approval, make a declaration in its name." In the aforementioned paragraph (c) you notice 'or GA's' which allows the 2nd and the 3rd President to propose to the GA adoption of their Declaration if the 1st President did not agree to it.

Article 15. The 1st President under system of PRESIDENT of 3 HEADS may have such general functions as provided for in the ELFO Charter, provided that the 2nd and the 3rd Presidents have the functions laid down in Article 16 and Article 17 respectively.

One of the standard dividing 2nd President's and 3rd President's functions is necessity of external correspondence and unnecessariness of external correspondence. The former matters belong to functions of 2nd President, while the latter matters belong to the 3rd President.

Article 16. 2nd President has, among others, the following functions:

a. to invite many kinds of persons to join our ELFO FAMILY, namely; a State, a present and former Head of State, a present and former Diplomat, an Autonomy (Self-Governing Community), an domestic and international Organization, and many kinds of natural persons;

b. to introduce a proposal (a bill) to the GA (General Assembly) after approval with the 1st President, provided that a proposal not accompanied with financial outcome may be introduced straight to the GA.

c. to make up one year's plan to be introduced in the GA, calling for cooperation with ELFO FAMILY, provided that the 2nd President shall make up in advance its contents as clear as possible.

d. to be present in Interstate Department, Solidarity Department, Territorial and Boundary Department, and in other Department when they deliberate very important matters.

e. to act for 1st President while neither he or she nor Acting President cannot perform their roles.

Article 17. 3rd President has, among others, the following functions:

a. to keep and develop horizontal good communication among members, using emails, Zoom, Skype, Whatsapp, Twitter, making MM (Mail Magazine), conducting ZAP (Zoom Amicable Party) etc.;

b. to create and develop national ELFA (Earth-Loving Friendly Association), helping them at the first stage by presiding 1st meeting or GA;

c. to call for promotion of activities and development of the Principal organs of the ELFO, at the same time, hearing their wishes;

d. to make up one year's plan, calling for cooperation with ELFO FAMILY, provided that the 3rd President shall make up in advance its contents as clear as possible;

e. to be present in Principle organs of the ELFO when the 3rd President thinks it is good for both sides.

Chapter 5. Acting President

Article 18. Considering that almost all the Leaders of ELFO MAMILY are extremely busy with their personal affairs and social activities, each President of our ELFO FAMILY, besides that of court of justice, shall have an Acting President.

It implies that each President of national ELFA shall have his or her Acting President.

Article 19. When President does not keep good communication with ELFO members, Acting President may send info, talk with, them by one's judgement.

Article 20. Acting President may present one's ideas to ELFO members in President name with his or her consent as well as in one's own name. In the latter case Acting President may not get allowance from the President.

Article 21. Acting President may appoint ELFO members as Vice-Presidents, Advisors, Consultants, and Assistants who are to be under one's President so long as the latter does not appoint them. *(See vacant posts in attachment at pp. 2~5)*

Article 22. Acting President may promote many kinds of events in President's name with his or her consent as well as in Acting President's own name.

Article 23. When the GA judges that present Acting President's inauguration as President is far better than a given existing presidency, the Acting President may inaugurate as President immediately without Certificate provided for in Article 8.

Chapter 6. Advisors, Consultant, and Assistant

Article 23. An Advisor has a right to recommend some steps to President even if the latter does not ask the first to do so. President appoints an Advisor Section Head and its staffs.

Article 24. A Consultant has not such right as an Advisor has, and recommends some steps to President if the latter asks the former to do so. President appoints a Consultant Section Head and its staffs officially with reservation of Article 5.

Article 25. While having free time, an assistant will help President perform routine functions. President appoints an Assistant Section Head and its staffs.

Chapter 7. Chairperson of the General Assembly of the ELFA

Article 26. Chairperson may receive any member's proposal (bill) on agenda item, and in his or her judgement may decide the priority of deliberation, provided that ELFO 1st President has 1st priority in choosing the order of agenda items, shall propose the order promptly if any.

Article 27. Not only Chairperson, but also any ELFO member may ask President to introduce proposal (bill) with elaborated contents.

Article 28. When 1st President or Acting President does not express one's wish on priority of agenda items within 24 hour from their announcement by Chairperson, their order shall go as the Chair chose. When the 1st President wishes to withdraw a matter from deliberation, he or she shall explain the situation about it.

Article 29. Regarding introduction of proposal (bill), the 1st category of Hon. President has the 2nd priority after the 1st President, provided that if the latter has not presented a concurrent agenda items, the former's proposal goes automatically.

As soon as Hon. President or 1st President introduce their proposal, it shall be regarded that deliberation began even without Chair's declaration on commencement of the GA, and any member may express one's opinion.

Such simplified procedure will accelerate deliberation and early adoption of decisions. If we set up bureaucratic documental restrictions, we will loose many times in vain. See reality, now I am writing the present Draft "Rules on Presidents and their concerning staffs" without consulting the 1st President (he is not so communicative). If I asked him to review my draft, and if he did not answer me for a long time (I sent him 11 messages without his answer), what would happen? Rule-making process would be as if it were such very slow movement of that of earthworm.

Article 30. Only the 1st category of Hon. President and 1st President may send their draft agenda items directly to the concerned members, not through the Chairperson. In this case it is not necessary for Chairperson to declare the beginning of the deliberation.

You know already such an example: I'll not send specially present Draft Rules only to GA Chair Irina Karpekina, but straight to all of ELFO members including her, asking her as follow, for example:

Dear GA Chair Irina Karpekina, I ask you to decide adoption of my proposal at 20: 00 of JAN 2023 if there is no objection to it.

Article 31. Period of deliberation may be restricted, in principle, to 2 days regarding one or some agenda items if there is no objection to it or if there are only some members who are against it. If it is very urgent matter, deliberation may be restricted to 24 hours.

Such case happened recently for the first time, when it became clear that Dr. Ms. Tamara. A. told me about her sudden visit to Africa and meeting African Presidents. I asked her to hand them our 4th Proposal on conciliation between Russia and Ukraine.

Article 32. When overwhelming majority of votes are “Yes”, it is not necessary for a Chairperson to announce the number of “Yes” votes. **When there is no objection, the agenda item is regarded as having been adopted unanimously.**

Almost every day a new face or faces join our central ELFO FAMILY or national local ELFA (Earth-Loving Friendly Association). It is actually impossible to ascertain exact number of our members at the time of adoption of a given decision.

Article 33. The minutes of each General Assembly shall be certified by the 1st President, provided that the latter may not certify each decision on each agenda of the former, **may certify** only the final summery minutes of each General Assembly.

If we taked bureaucratic step that each decision on agenda item shall be certified at the time of its adoption, rule-making process would very slow as an earthworm.

Article 34. **Irrespective of many different dates of adoption of agenda items in a given session of a given round of General Assembly, these items shall be regarded as having adopted finally at the date when President recognize the minutes.** The minutes of each General Assembly shall be opened on its web-site.

Chapter 8. Election Administration Commission

Article 35. Election may be conducted by Internet, Fax, email etc.

Article 36. A Central Election Administration Committee (CEAC) may be composed of 2 members which shall be recognized by the GA. A National Election Administration Committee (NEAC) also may be composed of 2 members which shall be recognized by the GA of its NELFA.

Article 37. GA’s decision is prior to CEAC’s.

Article 38. President of a national ELFA may ask the Central Election Administration Committee (CEAC) to administer its national election without its national as a member of the CEAC, or may ask to add his or her national to the CEAC.

This rule reflects present week solidarity among members of NELFAs. Some of NELFAs have not organizational force even to create one's national EAC.

Article 39. When an elected person's winning is perfectly clear, it is not necessary for the CEAC or NEAC to totalize all the votes in accordance with the category of votes.

For example, when only a few was against a candidate, while overwhelming members voted for the candidate.

Charppter 9. ELFA's Presidents and other important staffs

Article 40. As for the 1st election of President of a national ELFA (Earth-Loving Friendly Association), the central ELFO GA Chairperson may administer the election with ELFO President or Hon. President.

Article 41. Where a national ELFA is not established, a member may be President of that ELFA, provided the following conditions shall be satisfied.

a. the member will send to the ELFO GA one's determination (political opinion or policy) to be President of a national ELFA.

b. no opponent candidate appears within 10 days after the notification, by the GA Chair, of the 1st candidate's above determination to GA members.

c. The GA shall decide procedure when more than 2 candidates appear.

d. Without presenting political opinion or policy and Oath any candidate shall not be regarded as having won election.

Article 42. A candidate for President of an ELFA shall present, in principle, the following Oath:

I take the oath that I will perform always friendly and peacefully my roles stipulated in the Constitution of our ELFA, appoint important staffs, open the General Assembly at least

2 rounds a year, keeping good communication with members and the ELFO, trying to make our ELFA to be as independent as possible. .

2. A candidate may add some phrases to the above said Oath.

The one of the first steps to be taken by the 1st Presidents of an ELFA is as follow:

They may go ahead without instruction from the central ELFO along Earth-Loving Amicable Way as they like because ELFO Tops and Secretariat are always very very busy. If they have a time, they may already express your opinion to your compatriots.

Article 43. It is also obligatory to for President of national ELFA to appoint one's Acting President. Nevertheless central ELFO may also appointe its Acting President for any ELFA. The ELFO and the national ELFA shall decide the division of roles between national and central Acting Presidents.

Article 44. Central ELFO may appoint Acting chief of each sector of a given ELFA, provided that each ELFA has such right. The ELFO and the national ELFA shall decide the division of roles between national and central Acting chiefs.

Chapter 10. Final Rules

Article 45. These 'Rules on Presidents and other important staffs' shall be effective at the date of October 11, 2023, shall be opened on our web-site.

2. Provisionaly 3 Presidents of ELFA were elected!!

Now you see the hottest article written by our Pres. Edmario:

Hello, my dear fellow members of ELFO, ICO and BELFA. I hope everyone is well, healthy, blessed and safe. I wish you a great, blessed week of abundance, abundance and happiness. I prophesy infinite blessings.

Let's together, the ELFO family, cross the milestone of achieving a world peace treaty between nations in the face of the catastrophic collapse of the war in Ukraine. Remember, ELFO family, our goal and objective is to exterminate the end of nuclear weapons in the world.

War in Ukraine overshadows NATO naval exercises in the Baltic Sea.

The Ukraine war has injected a dose of grim realism into the North Atlantic Treaty Organization's (NATO) annual naval exercise in the Baltic Sea, with Western forces training for the first time on how to react to a possible Russian attack on the region.

The two weeks of military exercises there take place in the seas off Latvia and Estonia, NATO members that border Russia to the east and have been more exposed to threats from Moscow since Russian forces invaded Ukraine last year.

The exercises began on September 9th. In total, 30 ships and more than 3,000 military personnel from all NATO countries in the Baltic region are taking part in the action, as well as Sweden -- which will soon join the group -- and other allies such as the United States, Canada, the Netherlands, Belgium and France.

The forces are carrying out amphibious operations, sea-to-land attacks and ensuring the security of routes in the Baltic.

German Rear Admiral and director of the exercises, Stephan Haisch, stated that the Russian presence in the Baltic Sea, including frigates and a spy vessel, is normal and expected, but that this year the alliance's actions have moved away from artificial scenarios to get closer reality during the exercises.

"For many years we had an artificial scenario. Now, we are closer to making a realistic sense of it, in the geography, in the partners and in the opponent. So, it is now more realistic than in the past," Haisch said aboard the north ship -American Mesa Verde.

Captain Maris Polencs, Latvia's naval commander, said the country needs to develop technology for laying and removing sea mines because of the Russian invasion of Ukraine. "We are beginning to see that mines will be a real threat in the Baltic Sea if a similar conflict occurs in this region," he said.

This is the first exercise of this magnitude that the German Navy -- which has the largest fleet in the Baltic -- commands from its headquarters in Rostock. In the event of a conflict with Russia, Germany is ready to grant the facilities to NATO.

Finland joined the alliance this year, and Sweden's entry is expected to be approved soon. The Russian invasion of Ukraine radically changed the strategic posture in the Baltic Sea, most of whose coastline is shared by nations known as neutral since Napoleonic times.

With the new entries, practically the entire Baltic coast will be NATO territory, with the exception of the few Russian lands and the Kaliningrad exclave, sandwiched between Poland and Lithuania.

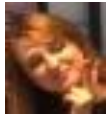

Members know that at present time we pay much attention to tourism and accommodation business, and in September 8, 2023 Hon. Resident Rikio sent to ELFO members his draft **Rules on BNB Business and Hotel Business** (this page). As there was no objection, I decide that our GA adopted the Rules as follows:

Rules on BNB Business and Hotel Business

In accordance with ELFO Charter and in order to contribute to the peace and amity among nations by tourism, regarding creation of accommodation, the General Assembly (GA) adopted the following Rules.

Done in Sapporo in September 12, 2023.

Article 1. When ELFO members construct accommodation, sale rooms, flats or other space, and/or have something to do with it, these member-sellers shall try to introduce the accommodation to ELFO FAMILY.

Article 2. These rooms, flats, and spaces which ELFO members own may be named as Earth-Loving Oasis or a HOUSE for Peace, Welfare and Friendship if the concerned parties agree to it.

Article 3. Our ELFO shall promote not only homestay type lodging, but also investment type (owner absent-type) lodging, and hotel-type lodging, provided that the ELFO itself will not be, in principle, an actor of buying, selling, investing, transferring money, issuing check etc. in its name.

Article 4. Unless contrary to domestic laws, our ELFO adopts domestic and international standard of brokerage of 1%~5% to be paid to a broker by a seller, and of 1%~3% to be paid to the broker by a member buyer. If an ELFO member with an intention to be a broker talks directly with a possible buyer, and the latter talks

afterwards with the seller, brokerage shall be paid by the buyer when a contract is concluded between them.

Article 5. Real percentage of brokerage will depends upon an agreement between a seller and a broker, on the one hand, and between the broker and a buyer, on the other hand.







Other flats or space on the floor where he will live remain in the name of other families, companies (domestic and international), San Paulo city (if it is interested in PPP: Public and Private Partnership) and others.

2) Does ELFO have a bank account in Brazil or a legal representative?

Answer: At present time our central ELFO hasn't it there. I suppose that the BELFA (Brazilian Earth-Loving Association) has not in its name.

3) What is the payment method? (*In conversation, you mentioned that it would be through an investment bank from Japan and another part coming from Washington, DC, please confirm me)

Answer: You must not expect that ELFO will buy many flats or much space. I think ELFO itself will not buy a flat, but cooperate with you and member-economists considerably and unimaginably. Our ELFO has such potential power. You misunderstand me, writing, "In conversation, you mentioned that it would be through an investment bank from Japan and another part coming from Washington, "

I explained that Japanese governmental financial agency or banks are ready to aid Japanese people to buy or build a house, giving them capital, and wished you to use such kind of aid if in Brazil is such financial helper. As to Dr. President Tamara of the Capital Investment Holding Group in Washington DC I simply mentioned a possibility of her assistance. Let's talk with her about it.

3) How many apartments are there to be purchased? Would there be an idea regarding this investment?

Answer: In middle or long term all the space on the floor where Edmario will live are to be purchased by BELFO members and/or ELFO members from other countries.

4) In this morning's video (evening) I understood that there is how Mr Edmário told me about an idea of 'payment within a period of 5 years? If this is the case, what would be the form of payment, how? Down payment + 60 months?

5. It shall absolutely forbidden to make a nuclear surprise attack.
6. If a belligerent State is obliged to do it, in advance she shall open her ultimatum before all the world.
7. At that time both belligerents shall stop fighting promptly, any State or person shall not instigate nuclear war, on the contrary, encourage general truce.

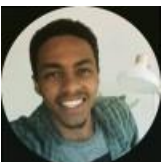

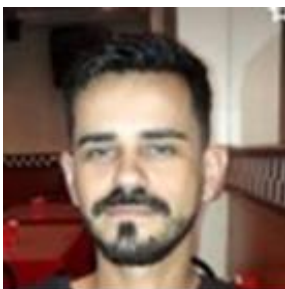

Question 1: What are the urgent steps for ICO to do now?

Hello, my dear ICO family members. I hope everyone is well and healthy. The urgent steps for ICO to take now would be to manage the organization with a network of world leaders, celebrities and high profile personalities to support us with the projects and demands of new sanctions with the end of the Ukraine war with the end of nuclear weapons.

Question 2: What are some of the medium and long term important points?

Have numbers of personalities in the ICO who can contribute to savings accounts and support the ICO with cultural projects and funds.

Question 3. Are you thinking of new items or ideas to propose to conflicting states?

Yes . I think about coming up with new ideas and new items for the situation of interstate conflict catastrophe collapse demand situation. I believe that when new ideas arise, they help propagate new demands with the UN foreign relations rapporteurs to prevent the worst catastrophe of the end of the planet in the third world war between states in conflict.

Question 4. How to invite States from neutral States to join us or cooperate with us?

Calling on heads of state to participate in our meetings via zoom and elaborate articles requested via email. We need to unite with neutral states. Based on the history of peacekeeping and conflict resolution activities of the Organization of the United Nations (UN), we analyze how this institution reacted to the proliferation of intra-state armed conflicts during the 1990s, multidimensionality of these conflicts, which to some extent are not as new as they may seem to have imposed a series of difficulties on the traditional peacekeeping mechanisms of the UN, which until then had been restricted to sending unarmed or weakly armed soldiers to maintain peace between States, based on the foundations of respect for sovereignty, impartiality, consent of all parties to the conflict and use of force only in self-defense.

From the study of the conceptual and operational changes of UN peacekeeping missions in the 1990s, we point out the difficulties faced by this organization to adequately respond to the intra-state conflicts, as well as discussing the limits of its performance in relation to the principles traditions of the Westphalian system – sovereignty, independence and non-intervention.

Question 5: How about trying to show a draft peace treaty for Russia and Ukraine?

It 's good to have a new project in hand. The objective of this work is to analyze how the Organization of United Nations (UN) reacted to the change of international conflicts in the post-Cold War (GF), specifically to intra-state armed conflicts that trigger humanitarian crises that predominated in the war scenario of the 1990s. The multidimensional nature of these conflicts, which, to a certain extent, are not as new as they may seem, has imposed a series of difficulties to traditional United Nations peacekeeping and conflict resolution mechanisms, hitherto restricted to sending unarmed or weakly armed soldiers to maintain peace between

States on the basis of respect for sovereignty, impartiality, consent of the parties to the conflict and use of force only in self-defense.

When we mention “United Nations” or “UN” we are not referring to a singular political institution or world government with supranational authority. We refer us to an intergovernmental political forum whose purpose is to maintain peace and security and which is based on the tripod of sovereignty, political independence and non-intervention in the internal affairs of States. As much as the preamble of the UN charter invoke “we, the peoples of the United Nations”, there is no doubt that States are central actors in the architecture of that organization. Decisions on peace and security rest with the States international institutions, which in turn were centralized in the body specially created by the victorious powers of World War II to address these matters.

Question 6. Can you maintain good communication between 3 presidents?

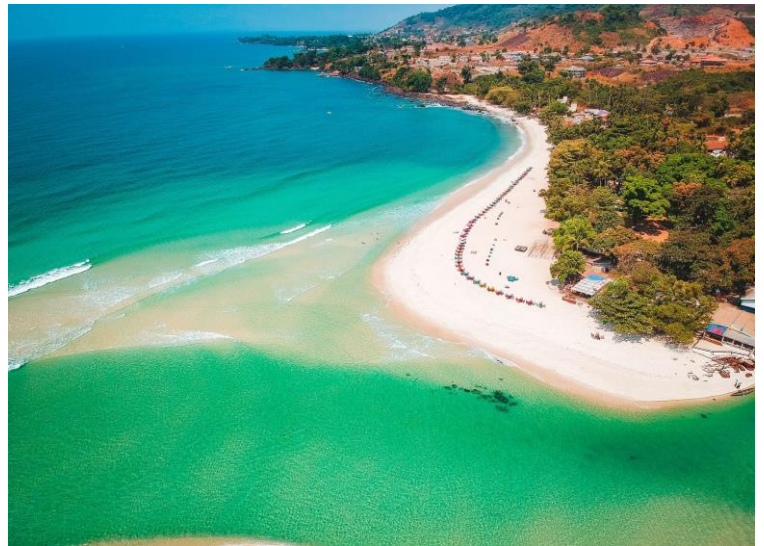

1. Both belligerents agree to never use a mass destruction weapon at any place so far as the enemy belligerent does not use it.

2. When a Head of State or some authorities declare serious military action with severe words, they shall answer to any questioner that use of the ABC weapon will not be included in this action.

3. If there a doubt happens as to use of ABC weapons, the concerned State shall permit international inspection to be organized by the United Nations.

Dear ELFO members, what good ideas can you send me in order to update this very important N.4 clause **Non-use of a mass destruction weapon**? It is clear that it is absolutely necessary to avoid nuclear war.

Hello, my dear friends and brothers of the ELFO family. I hope everyone is well, healthy and safe. We will march with hope, faith and determination for the purpose of the peace treaty between nations. Together we are stronger.

We are in catastrophic and miserly times. I count on the proposal of all world leaders to implement projects to meet the demand for world peace with new UN assemblies.

Mr. Putin sends message to Poland: "Attacking Belarus will mean an act to Russia". Russian leader says Warsaw covets Belarussian and Ukrainian lands and claims part of Poland's territory was "Stalin's gift" to the country. President Vladimir Putin accused, this Friday (21), Poland of having territorial ambitions in the former Soviet Union and said that any aggression against neighboring and ally Belarus would be considered an aggression against Russia.

[In 1939] Poland was abandoned by its western allies, was thrown into the German war machine and formally lost its independence and statehood, which were restored largely thanks to the Soviet Union. It was thanks to the Soviet Union, thanks to the measures taken by Stalin, Poland obtained substantial territories in the West German lands. That's a fact," he said.

Putin said there were reports in the press of plans for a Polish-Lithuanian unit to be used for operations in western Ukraine - part of which in the past belonged to Poland - and ultimately to occupy territory there. It is known that they also dream of Belarussian lands," he said, also without providing evidence. Moscow would react to any aggression against Belarus "with all the means at our disposal", Putin told a meeting of its Security Council in televised remarks.

"As for the Polish leaders, quite possibly they are counting on forming some kind of coalition under the aegis of NATO to get directly involved in the Ukrainian conflict in order to wrest a good chunk of Ukraine for themselves," he said. "We are not going to get involved. But as for Belarus, it is part of the State of the Union. Aggression against Belarus will mean aggression against the Russian Federation. We will respond to this with all means at our disposal."

The Warsaw Security Committee decided on Wednesday (19) to move military units to eastern Poland after members of the Russian mercenary force Wagner arrived in Belas, state news agency PAP reported, quoting its secretary this Friday.

I cordially and politely draft Ukraine war demand new article. My dear friends of the ELFO FAMILY, remember our goal is to maintain the peace treaty with the end of nuclear weapons and with the sanctions of transitional agreements between countries and nations.



Russian President Vladimir Putin said this Thursday (13) that Ukraine's accession to the North Atlantic Treaty Organization (NATO) could exacerbate international tensions. "I am convinced that this will not improve Ukraine's security and, in general, will make the world more vulnerable and provoke additional tensions on the international stage," said the Russian president. The phrase was a response to the rapprochement of the transatlantic military alliance with the former Soviet republic.

NATO said it would invite Ukraine. Earlier this week, there was a meeting of the leaders of the countries that are part of NATO in Vilnius, Lithuania. There the 31 members said that Ukraine would join NATO at some point, but they did not define when membership would take effect.

According to Jens Stoltenberg, NATO secretary general, the invitation for Ukraine to join the group will be given "when the allies agree that there are conditions for it". That is, it will not be while there is a war in the country. First, he considered, it is necessary to secure victory against Russia.

'Wagner Group simply doesn't exist': Putin invited mercenaries to join Russia's army after rebellion.

The president of Ukraine, Volodymyr Zelensky, did not like the lack of definition and criticized NATO's intentions: "Vague words about 'conditions' are added even to invite Ukraine. It seems that there is no willingness either to invite Ukraine to NATO or to make it a member of the alliance," said the president.

Attacks against Ukraine. Russia launched air strikes for the third consecutive night on Thursday. Kiev Mayor Vitali Klitschko announced that a person's body had been found after a fire broke out in a residential building, but did not link the flames to the Russian attack. The Ukrainians claimed they managed to block part of the Russian attacks by shooting down 20 Russian strike drones and two cruise missiles overnight.

4. Continuation of election of ICO PRES. of 3 HEADS !! 国際調停機構 3 頭会長の選挙の継続、まだ手続が未完 Appearance of more candidates wanted もっと会長候補が出現されたい

Ukrainian war is becoming more serious and terrible, but though there are 3 candidates for PRESIDENT of 3 HEADS, they haven't completed the procedure yet. They must present their Political Opinion (Promise), Oath, and answer to questions in an Open Forum. All of them have not replied their answers in the Open Forum and again I ask them to reply ASAP at least to the questions posed by Hon.Pres.Rikio. I talked with Hon.Pres.Rikio, who said that there are some reasons why Open Forum is necessary:

- ① The ICO is not a place of play, but for serious entity which influences life or death of human beings, so candidates must respect rules adopted unanimously by the ICO GA.
- ② It is clear only expression of one's intention to be ICO President is not enough for being ICO President. Dr. Leo Rebello announced only his wish to be President of 2023-2025.
- ③ It is also clear that candidates' Political Opinion (Promise) and Oath are also not enough for being elected ICO President. It is possible that their Political Opinion may be unfair, unsuitable to conciliation, so electors want to discuss with them.
- ④ Through Open Forum electoral members can hear candidates's opinion more in detail, and choose more accurately in accordance with one's thought.

5. Open Forum for Candidates for ICO Presidents!!

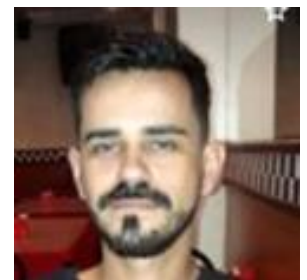

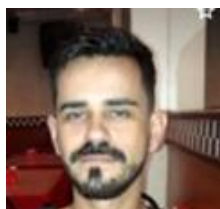

The draft Rules on ICO Presidents and their concerning staffs

Considering that in our ELFO FAMILY there are already many kinds of Presidents, and that in future there will appear more and more Presidents in our FAMILY, now regarding our International Conciliation Organization (ICO) it is necessary to elaborate rules concerning its Hon. President, Presidents, Acting Presidents, Vice-Presidents, Advisors, Consultants, Assitants, Chairperson of the General Assembly, and Election Administration Committee etc.

Present Rules on Presidents and their concerning staffs are results of our wishes to develop the ELFO FAMILY more friendly, harmoniously and effectively without bureaucratic color by dividing many complex functions among competent collaborators willing actually to contribute to making our Planet better.

Chapter 1. General Rules

Article 1. At any time and in any place any ICO member may suggest one's idea to develop the ICO for promoting friendship and peace among nations, and may announce one's willingness to be ICO President, Acting President, a Vice-President, or other important staff.

Article 2. XXXXX

Chapter 2. Hon. President of the ELFO

Article 3. President, who was recognized by the ICO GA as having rendered great contribution in the development of the ICO, may be Hon. President of the ICO.

Article 4. There may be 2 kinds of Hon. President. The 1st category of the Hon. President may continue to have its former competence to act when incumbent President or other staffs cannot realize one's functions as is expected, while the 2nd category of Hon. President has not, in principle, such rights and any duties.

Article 5. So far as new members invited by Hon. President are concerned, the latter may suggest the post (status) of the formers, provided that President will appoint them officially. In case of absence of the said official appointment, these new members are regarded as having the post suggested by Hon. President.

Article 6. Hon. Presidents of both categories may continue to have right of vote provided for in ELFO Charter, Article 8. Hon. Presidents are regarded as a member of the ELFO FAMILY even after their retirement without membership fee.

The said Article 8 reads: So long as a member does not express yes or no, his or her Representative shall be regarded a mandatory, and his or her yes or no shall also regarded as the same with that of Representative.

Article 7. Hon. President of both categories may, rather are expected to, invite many VIPs, Dignities, Diplomats and other personalities to join our ELFO FAMILY, and remuneration will be paid to them alike as to other members **in accordance with rules**.

Chapter 3. Presidents and Vice-Presidents of the central ICO

Article 8. Incumbent President and Vice-President will continue to remain as present position so long as new President and a Vice-President do not appear and, even if new President is elected, are not recognized by incumbent President by Certificate.

Article 9. If only one member recommends oneself as a candidate for President, presents an oath that he will actually perform one's roles expected by our ELFO FAMILY, and joins an open forum conducted by ICO President, the person will be regarded as having won the election. In the open forum former President, Hon. President and other members may participate.

Article 10. If no member stands as a candidate for the vacant seats, 2nd prolonged election will be conducted in 21 days after the scheduled 1st election.

Article 11. In 2nd prolonged election any suitable member may be candidate for them, declaring oath that he will actually perform his roles expected by ICO. In the open forum former President, Hon. President and other members may participate.

Article 12. Plural members may declare one's candidacy for Presidents, provided that they will announce their political opinion and join an open forum conducted by ICO President. Such a candidate may be regarded as elected automatically if there does not appear an opponent candidate.

Article 13. Under system of PRESIDENT of 3 HEADS, 2nd and 3rd Presidents have rights of appointment of their Acting Presidents, Advisors, Consultants and Assistants, and staffs of their subsidiary organs. All the other staffs shall be appointed by 1st President, with reservation of Article 5.

Chapter 4. Presidents' Functions under PRESIDENT of 3 HEADS

Article 14. The 3 Presidents shall respect the following rules:

- a. They shall pay attention to friendly cooperation and harmonious division of works among them under 1st President's leadership, if it is impossible, under 2nd President's leadership;
- b. They shall keep good communication among them, and if any of them cannot answer the other President, his or her Acting President or an assistant shall answer provisionally; and

c. President may, in his or her own judgement, may announce President's Declaration or Statement, while both the 2nd President and the 3rd President may, with President's or GA's approval, make a Declaration in its name.

ELFO Charter, Article 22 stipulates that "President may, in his or her own judgement, may announce President's Declaration, while each Head of the primary organs may, with President's approval, make a declaration in its name." In the aforementioned paragraph (c) you notice 'or GA's' which allows the 2nd and the 3rd President to propose to the GA adoption of their Declaration if the 1st President did not agree to it.

Article 15. The 1st President under system of PRESIDENT of 3 HEADS may have such general functions as provided for in the ICO Charter, provided that the 2nd and the 3rd Presidents have the functions laid down in the present Rules, Article 16 and Article 17 respectively. **One of the standard dividing 2nd President's and 3rd President's functions is necessity of external correspondence and unnecessariness of external correspondence.** The former matters belong to functions of 2nd President, while the latter matters belong to the 3rd President.

Article 16. 2nd President has, among others, the following functions:

a. to invite many kinds of persons to join our ICO, namely; a State, a present and former Head of State, a present and former Diplomat, an Autonomy (Self-Governing Community), an domestic and international Organization, and many kinds of natural persons;

b. to introduce a proposal (a bill) to the GA (General Assembly) after approval with the 1st President, provided that a proposal not accompanied with financial outcome may be introduced straight to the GA.

c. to make up one year's plan to be introduced in the GA, calling for cooperation with ELFO FAMILY, provided that the 2nd President shall make up in advance its contents as clear as possible.

d. to be present in Interstate Department, Solidarity Department, Territorial and Boundary Department, and in other Department when they deliberate very important matters.

e. to act for 1st President while neither he or she nor Acting President cannot perform their 9 roles.

Article 17. 3rd President has, among others, the following functions:

a. to keep and develop horizontal good communication among members, using emails, Zoom, Skype, Whatsapp, Twitter, making MM (Mail Magazine), conducting ZAP (Zoom Amicable Party) etc.;

b. to create and develop regional or national ICOs, helping them at the first stage by presiding 1st meeting or GA;

c. to call for promotion of activities and development of the Principal organs of the ICO, at the same time, hearing their wishes;

d. to make up one year's plan, calling for cooperation with ELFO FAMILY, provided that the 2nd President shall make up in advance its contents as clear as possible;

e. to be present in Principle organs of the ICOP when the 3rd President thinks it is good for both sides.

Chapter 5. Acting President

Article 18. Considering that all the ICO Presidents are extremely busy with their personal affairs and social activities, each ICO President shall have an Acting President.

Article 19. While President does not keep good communication with ICO members, Acting President may talk with them by one's judgement.

Article 20. Acting President may present one's ideas to ICO members in President name with his or her consent as well as in one's own name.

Article 21. Acting President may appoint ICO members as Vice-Presidents, Advisors, Consultants, and Assistants who are to be under one's President so long as the latter does not appoint them.

Article 22. Acting President may promote many kinds of events in President's name with his or her consent as well as in Acting President's own name.

Chapter 6. Advisors, Consultants, and Assistants

Article 23. An Advisor has a right to recommend some steps to President even if the latter does not ask the first to do so. President appoints an Advisor Section Head and its staffs.

Article 24. A Consultant has not such right as an Advisor has, and recommend some steps to President if the latter asks the firster to do so. President appoints an Cosultant Section Head and its staffs.

Article 25. While having a free time, an Assistant will help President perform routine functions. President appoints an Assistant Section Head and its staffs.

Chapter 7. Chairperson of the ICO General Assembly

Article 26. Chairperson may receive any member's proposal on agenda item, and in his or her judgement may decide the priority of deliberation, provided that ICO 1st President has priority in choosing the order of agenda items, shall propose the order if any. When the 1st President wishes to withdraw a matter from deliberation, he shall explain the situation about it.

Article 27. The 1st category of Hon. President has the 2nd priority after the 1st President, provided that if the latter has not presented a concurrent agenda items, the former's proposal goes automatically.

Such simplified procedure will accelerate deliberation and early adoption of decisions. If we set up beaurocratic documental restrictions, we will lose many time in vain.

Article 28. Only the 1st category of Hon. President and 1st President may send their draft agenda items directly to the concerned members, not through the Chairperson, or may send it firstly to the Chairperson.

Article 29. Period of deliberation may be restricted, in principle, to 2 days if there is no objection to it, or if there are only some members who are against it.

Article 30. When overwhelming majority vote “Yes”, it is not necessary for a Chairperson to announce the number of “Yes” votes.

Article 31. The minutes of each General Assembly shall be certified by the 1st President, provided that the latter may not certify each decision on each agenda at the time of its decision. The date when an agenda item was adopted is regarded as provisional, and the last closing date of a given GA shall be regarded as a final official date of adoption of a given agenda item.

If we taked beaurocratic step that each decision on agenda item shall be certified at the time of its doption, rule-making process would very slow as an earthworm.

Chapter 8. Election Administration Commission

Article 32. Election may be conducted by Interntet, Fax, email etc.

Article 33. A Central Election Administration Committee (CEAC) may be composed of one or 2 members which shall be recognized by the GA. A Regional or National Election Administration Committee also may be composed of 2 members.

Article 34. President of a regional or national ELFA may ask the Central Election Administration Committee (CEAC) to administer its election.

This rule reflects present weak solidarity among members of NELFAs.

Article 35. When an elected person’s winning is perfectly clear, it is not necessary for the election committee to totalize all the votes in accordance with the category of votes.

For example, when only a few was against a candidate, while overwhelming members voted for the candidate.

3. Election of Tanzanian TELFA President



A Tanzanian **Amb. John Felix** (pic.) expressed his readiness to be President of the TELFA (Tanzanian Earth-Loving Friendly Association). Please see my correspondence with him below. As an election administrator, therefore, I want to conduct election of TELFA President. Somewhere ELFO rules must be. I tried to find it for many hours in vain. So this time I want to administer the present election as follows:

1. If another Tanzainan member wants to be President of the TELFA (Tanzanian Earth-Loving Friendly Association), he or she shall send me one’s wish to that effect within 10 days (**by June 30, 2023**)

2. 1st Candidate Amb. John Felix also shall send me his Political Opinion (Policy or Promise to TELFA members) within 10 days (**by June 30, 2023**)
3. If there is no opponant besides the 1st candidate, the latter will be regarded as having won the election. If another candidate appears, GA Chair as election administrator may decide the rules.
4. Open forum will be opened where any ELFO members may ask questions to a candidate for President of the TELFA under Chair of ELFO President Edmario or Hon. Pres. Rikio Kaneko .

N.B. 1 Rules on President, Article 37 reads as follows:

Article 37. GA's decision is prior to CEAC's. The GA may conduct election of President of national Earth-Loving Friendly Association without organizing CEAC, provided that ELFO GA shall respect, first of all, wish of a given national ELFA's wish.

N.B. 2 Provisional Rules on President:

- A. Incumbent President and Vice-President will continue to remain as present position so long as new President and Vice-President do not appear.
- B. Concerning aforementioned vacant seat, election will be conducted 5th of January 2023 year under the present EAC.
- C. Any suitable member may be candidate for them, declaring oath that he will actually perform his roles expected by our ELFO FAMILY.
- D. Such a candidate may be regarded as elected so automatically if there does not appear an opponent candidate within 2 days after the 1st candidate.

4. Peace as “the tranquility of order”--- E.P.

Hello Mr. Rikio kaneko and all the brothers from ELFA, BELFA and ICO.

I draw up the blunt terms of readable responsibilities that I will be willing to assume the presidency of the ICO as the new president.

However, at this moment I am in need of support from the Brazilians at BELFA to sponsor an editorial department.

I need a team that believes in my dreams and in the dreams of every brother diplomat, celebrity, artist and personality of ELFA and ICO with the end of nuclear weapons in the world and with the sanctions decree of world peace.

They want for themselves and for the world, and most will certainly answer: peace! Saint Augustine already stated that it was “such a noble good that, even among mortal and earthly things, there is nothing more pleasing to the ear, nor sweeter to desire, nor superior in excellence”.

However, especially in the last century, the desire for peace has increased so much that it has taken on different contours.

Longed for but not achieved. The two world wars left profound consequences on men, due to their violence and capacity for destruction. As if that were not enough, the most terrible of them ended in 1945, Soviet communism continued to frighten many Slavic and Eastern peoples, and the world witnessed new confrontations, especially in Asia and Africa.

In the period known as the Cold War, despite the apparent absence of a formal clash, the United States and the Soviet Union fought an arms race that pointed to, sooner or later, a nuclear conflict of drastic proportions. Something similar happened on the threshold of the third millennium, with the appearance of terrorism on a large scale.

It is not surprising, therefore, that the ideal of peace emerged as a goal to be achieved among men, tired of blood, death and destruction. What response could the world make to such calamities? Treaties, agreements between States and meetings of the greatest powers on earth, with the commitment to preserve peace, were and continue to be carried out.

These efforts brought, in addition to encouraging promise, a crucial question: would the expected results be achieved? Or were they vain attempts to realize a chimera? Not long after these events began, people like the renowned Dominican theologian Fr. Victorino Rodríguez would already give a negative answer to such questions: “The UN was constituted to guarantee peace among nations. The year 1986 was proclaimed the International Year of Peace. However, the desired peace is not achieved: neither the Messianic peace in which the Gospel germinated, nor the Octavian peace in which Law developed; nor when the dissuasive power of nuclear defense seemed enough for men to stop waging or fomenting war”.

Such was the world's concern that they gave peace even new meanings, far from the truth. In the 1960s, for example, the hippie movement echoed its best-known motto: “peace and love”. Skillfully manipulated, this slogan made us believe that its achievement consisted in the pure absence of war and the full satisfaction of carnal pleasures.

Faced with this situation, we must ask: after all, how to understand true harmony? How to conquer it? God Our Lord said: “Peace I leave with you, my peace I give you. I do not give it to you as the world gives” (Jn 14, 27). What is the peace that Christ gives us that the world cannot offer?

Peace, tranquility and order

Saint Augustine defines peace as “the tranquility of order”.

These two elements combine very closely. Strictly speaking, the two are so linked that they are practically inseparable; if dissociated, they tend to become a caricature of themselves.

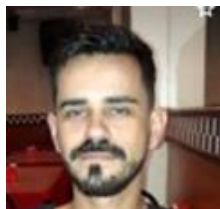

2. Proposal on OJTAC to India and Nepal!!

As there were many "Yes" votes and no objection to the ELFO Hon. Pres. Rikio's proposal below-mentioned, today I decide its adoption by the GA (General Assembly) of the ELFO and the ICO. This proposal will be sent to Indian and Nepali Governments:

We, co-senders of present Proposal have honor to introduce us. The one is Hon. Prof. of Sapporo University Rikio Kaneko and President of the OJTAC (One Judge Territorial Arbitration Court), the 2nd is a Brazilian Edmario Peixinho, President of the ELFO (Earth-Loving Friendly Organization), and the 3rd is ~~XXXXXX~~, Pres. of the ICO (International Conciliation Organization).

We are pleased that Indian nor Nepali Government, regarding their border conflict, was not against our 1st Proposal (April 15, 2023) that if both conflicting States want our ICO to conciliate between India and Nepal, the ICO will do it with pleasure.

The General Assemblies (GA) of the ELFO and the ICO, however, deliberated this matter again, and judged that possibly not only Nepali Government, but also Indian would be interested in our conciliation or arbitration, and that Conclusion by conciliation with great efforts and long

term is not binding upon conflicting parties, while award by arbitration is obligatory upon them, so that trial of arbitration seems to be more significant than conciliation, regarding border conflict between India and Nepal.

Before we sent you the 1st Proposal, our ELFO had already prepared for the system of One Judge Territorial Arbitration Court (OJTAC) in order to settle the border conflict as early as possible, on the other hand, securing fairness and objectivity.

First of all, please see *The Rules of One Judge Territorial Arbitration Court*. You will understand that actually many jurists and dignities participate in making award, so that *Pres. Rikio Kaneko's* subjective award is precluded. Even all the ELFO members of about 1800 will have a vote *or votes, in accordance with ELFO Charter*, for correcting my award.

Pres. Rikio says that he will try to settle this conflict within one year or at the latest 2 years.

May 4, 2023

The following was Decision of May 4, 2023 by the ELFO 11th GA on OJTAC:

Agenda item 11. One Judge Territorial Arbitration Court

Hon.Pres. Rikio Kaneko proposed to the 11th GA to adopt his Rules, which the GA did. In March 11, 2023 he proposed an additional clause (see Art.2, parag.2) and OJTAC's first activity of treating with border conflict between India and Nepal. (See see at the end of this agenda item) which also the GA adopted. In March 16, 2023 further he presented additional phrases to the same parag.2, rosy phrase), which the GA also adopted.

A. Border Conflict Between India and Nepal

The Rules of One Judge Territorial Arbitration Court

On 20th day of February, 2023 year General Assembly of our Earth-Loving Friendly Organization (hereinafter referred to as ELFO),

Attaching importance to establishing Earth community ruled by law,

Considering that there were some territorial cases which only one Judge decided,

Cooperating with our friendly International Conciliation Organization (hereinafter referred to as ICO)

Decided to adopt the following system of One Judge Territorial Arbitration Court (hereinafter referred to as OJTAC or Court)

Article 1. The OJTAC uses the Internet as much as possible, and shall contribute to development of digital lawsuit.

Article 2. The Judge (named also President) and Registrar shall be recognized by the ELFO General Assembly (GA), and when engaged on the business of the Court, shall enjoy diplomatic privileges and immunities in contesting States.

2. When President gets into difficulties and cannot engage on the business of the Court, the GA shall elect immediately a new President from among an ELFO Commission of International Law with a majority vote of nine tenths. If the majority vote does not reach the aforesaid level, a contesting party may withdraw from the Court.

Article 3. The seat of the Court shall be established at a place where President resides. This, however, shall not prevent the Court from sitting and exercising its functions elsewhere whenever the Court considers it desirable.

Article 4. The Court will consider

- a. Treaty
- b. Governmental agreements between conflicting parties
- c. international custom, as evidence of a general practice accepted as law;
- d. judicial decisions and the teachings of the most highly qualified publicists of the various nations, as subsidiary means for the determination of rules of law.

2. This provision shall not prejudice the power of the Court to decide a case *ex aequo et bono*.

Article 5. The official languages of the Court shall be English.

Article 6. Cases are brought before the Court by the notification of the special agreement (compromise) to the President of the Court. In the case the subject of the dispute and the parties shall be indicated.

Article 7. The Court shall have the power to indicate, if it considers that circumstances so require, any provisional measures which ought to be taken to preserve the respective rights of either party.

Article 8. The procedure shall consist of two parts: written and oral, provided that oral procedure shall be conducted by video.

Article 9. The hearing in Court shall be public on the Internet, unless the parties demand that the public be not admitted.

Article 10. Whenever one of the parties does not appear before the Court, or fails to defend its case, the other party may call upon the Court to decide in favor of its claim.

Article 11. The judgment shall state the reasons on which it is based.

Article 12. President's 1st draft award shall be sent to ICO Consulting Commission and to ELFO Commission of International Law for hearing **their** opinions, provided that a national of contesting parties shall not be a member of these 2 Commissions.

Article 13. President shall continue considering qualification of the draft award so long as more than one fifth (1/5) members of the aforementioned 2 Commissions are against it.

Article 14. President's qualified draft award shall be submitted to both ELFO General Assembly (GA) and ICO GA for hearing their opinions, provided that a national of contesting parties shall not be a member of these GAs.

Article 15. Considering opinions of these 2 GAs, President of the Court shall send the final award to the contesting States.

Article 16. The judgment is final and without appeal. In the event of dispute as to the meaning or scope of the judgment, the Court shall construe it upon the request of any party.

Article 17. Judicial costs depend upon an agreement among the President and parties to the dispute, provided that unless otherwise decided by the Court, each contesting party shall bear its own costs. The OJTAC shall be based on the self-supporting system, so the ELFO will not be financially responsible for the OJTAC.

2. Contesting States shall pay remuneration to their Registrars respectively.

Article 18. A jurist of international law or President of the Court may be a Registrar of the Court. Both Contesting States may appoint a Deputy-Registrar from among her public service personnel.

Article 19. A Deputy-Registrar may be removed from office if, in President's opinion, the incumbent has either become permanently incapacitated from exercising his or her functions, or has committed a breach of duty.

Article 20. The Court may give an advisory opinion on any territorial legal question at the request of contesting States. In the exercise of its advisory functions the Court shall further be guided by the provisions of the present Rules with necessary qualifications.

I, Rikio Kaneko (Ho.Prof. Sapporo University) was recognized by the GA as the President of the OJTAC.

B. Border Conflict Between India and Nepal

There are so many territorial problems in the world. And our ELFO FAMILY has contribute to settling some of them: issuance Renaissance dam problem; Palestinian problem; Territorial problems between Russia and Ukraine.

This time Hon. Pres. Rikio Kaneko proposed to the GA that ELFO FAMILY would pay attention to border conflict between India and Nepal. You can see the outline of the conflict in his attachment. Gist of our contribution to the matter is as follows (The GA adopted it later):

I . Notification by the ICO of its readiness to Conciliation

Our ICO and the ELFO will propose to Indian and Nepali Governments to try to settle their border conflict not only by negotiation, but also by other peaceful means provided for in UN Charter, Article 33. If both conflictiong Sates wants our ICO to conciliate between them, we will do it with pleasure.

II . ELFO's readiness to let the OJTAC function

When it becomes clear that both conflicting parties or one of them is not ready to submit it its border conflicts to peaceful means other than negotiation, then our ELFO GA will deliberate this matter and propose settlement by the OJTAC to Indian and Nepali Governments.

III. ICO Consulting Commission

President's 1st draft award shall be sent to ICO Consulting Commission and to ELFO Commission of International Law for hearing **their** opinions, provided that a national of contesting parties shall not be a member of these 2 Commissions. (Rules of the OJTAC, Art.12.)
