Summarization of the ELFO 14th General Assembly

April 15, 2024 ~ July 31, 2024

Now I summarize systematically decisions, recognition, recommendation of the ELFO 14th GA (General Assembly) as follows. In them are included items on other organs: the ICO and the OELO. So, the present summarization may be regarded of our FAMILY.

Chair of the ELFO General Assembly is Mrs. Irina Karpekina

I wanted some member to be GA Chairperson, but no one expressed one's readiness to be Chair, so I agreed to be regarded as GA Chair as before.

Ms. Afua sent me her draft agenda items mainly on financial affairs and website etc., then Hon. Pres. Rikio also sent 4 agenda items. I wanted the GA to deliberate situation of realization of GA's former decisions. And in April 27, 2024 Mr. Rikio made an urgent motion on additional rules to a draft Charter of the OELO.

In April 15, 2024 I declared the commencement of 2nd session of 14th GA (General Assembly), and firstly, agenda item on ELFO website proposed by ELFO 3rd Pres. Ms. Afua and the Urgent motion by Hon. Pres. Rikio were adopted as shown below-mentioned somewhere.

To Pres. Putin and Pres. Zelensky will be sent GAPNU

I decided adoption of ELFO Hon. Pres. Rikio Kaneko's draft treaty to be sent to Russian and Ukrainian Presidents the draft GAPNU (General Agreement on Permanent Neutralization of Ukraine) together with outline of draft peace treaty between Russia and Ukraine. The draft GAPNU reads as follows:

General Agreement On Permanent Neutralization Of Peaceful Ukraine

WE THE PEOPLES ON OUR PRECIOUS PLANET DETERMINED

to save succeeding generations from the scourge of war, especially catastrophic nuclear war,
to strengthen friendly permanent peaceful relations among peoples and States large and small, and

to promote better standard of life, not destroying human and material resources,

AND FOR THESE ENDS

to practice tolerance and live together in peace with one another as good neighbors around Ukraine,

to unite our strength to maintain permanent neutralization of Peaceful Ukraine and security thereof, and

to ensure that armed forces shall never be used permanently in Peaceful Ukraine excepting the case of self-defense,

HAVE RESOLVED TO COMBINE OUR EFFORTS TO ACOMPLISH THESE AIMS.

Accordingly, our respective Governments, Autonomies, Organizations, and Individuals have agreed to the present epoch-making General Agreement On Permanent Neutralization of Ukraine and do have honor to declare that hereby Ukraine has become permanently neutralized State, which can be proud of its historical role as a forerunner of progressive peaceful process leading to establishment of ONE World.

PART I . PERMANENT NEUTRALIZATION OF UKRAINE

Chapter 1. Purposes and Principles

Article 6. 1. The said United Nations, States, autonomies, organizations, and individuals have their Representative respectively.

2. A Representative of autonomies, organizations, and individuals shall be elected respectively in accordance with annex to the present GAPNU.

Chapter 3. Rights of Peaceful Ukraine

Article 7. Peaceful Ukraine has sovereignty, provided that she is permanently neutralized, and that her sovereignty may be restricted by other international treaties for the purpose of strengthening permanent neutrality of Peacefull Ukraine and

Article 8. 1. Peaceful Ukraine has right to maintain military forces only for self-defense.

2. When Ukraine wishes to follow policy of general and complete disarmament within Ukraine, all the parties shall support her.

3. Ukraine shall not regard such study as unfriendly, which will research Permanent Neutralization with her general and complete disarmament for the purpose of raising living standard of Ukrainian people and showing exemplary way leading to World Federation.

Article 9. Peaceful Ukraine may be a member of the United Nations, maintaining her honorary status of Permanent Neutral Peaceful Ukraine even if a war breaks out between member-States, or between a member-State and non-member-State as well as between non-member-States.

Article 10. 1. Peaceful Ukraine has right to be immune from military sanctions decided by the United Nations against aggressor or any State against which the United States is taking preventive or enforcement action.

2. Peaceful Ukraine has right to be immune, in principle, also from the other sanction decided by the United Nations

Chapter 4. Duties of Peaceful Ukraine

Article 11. 1. Peaceful Ukraine shall bind itself never to take up arms against any other State except for self-defense.

2. Peaceful Ukraine

Article 12. 1. Peaceful Ukraine shall never conclude or enter military alliance.

Article 13. 1. Peaceful Ukraine shall never enter into such international obligation as could indirectly involve it in war.

2. Peaceful Ukraine shall not take part in military exercise with any State's military forces.

Chapter 5. Acquire of territories

Article 14. Peaceful Ukraine may conclude a convention by which she can acquire, without cession of, new parts of territory with the consent of all the contracting States.

Here I took into account Ukrainian possibility that Ukraine can recover sovereignty over region which she may loose at the time of conclusion of peace treaty with Russia. It goes without saying that such alteration of sovereignty needs a new agreement among contracting parties of the treaty.

PART II . DEMILITARIZATION OF UKRAINE AND NEIGHBORING TERRITORIES

Article 15. If restrictive burden in respect demilitarization is heavy on Ukrainian shoulder, then to that extent, Russian burden will be also heavy.

Article 16. In Peaceful Ukraine such 3 non-nuclear principles shall be applied as: not producing nuclear weapon; not possessing it; and not allowing its entry into the country.

Article 17. Not only along the Russo-Ukrainian border, but also near from all the borders around her shall be created demilitarized zones with certain width of regional belt.

Article 18. A definite zone around an atomic station shall be demilitarized, and it shall never be a battlefield.

Article 19. Peaceful Ukraine and neighbouring States shall neither locate military objects within or near airports and seaports which are used exclusively for peaceful purposes such as exporting food.

Article 20. Peaceful Ukraine shall not use such a port for importing weaponry and other military purposes.

PART III. ORGANIZATION OF PALACE FOR PRMANENT EACE

Article 21 All the Parties to the present GAPNU shall make utmost efforts to change the areas destroyed by war into not arena of quarrels, but on the entire contrary, into a place of harmony, respect, love, truth, beauty, and HOPEs where spirit of peace, friendship, welfare, and cooperation rules.

Article 22. For the end declared in the preceding Article 21 an Organization for Palace of Permanent Peace (PPP) will be established in the capital Ukraine Kiev, where peace-loving States, peace-loving Autonomies (such as prefectures and cities), others organizations (such as NGOs and universities), and peace-loving individuals may collaborate in multi-international peaceful life, in many practical and theoretical fields.

Article 23. There are established as the principal organs of the PPP: General Assembly, a Security Council, an Economic and Social Council, a Territorial Council, a World Court, and a Secretariat.

This matter concerning the present Article is very important, and must studied by ELFO FAMILY at the beginning, then world-wide. I wish that if the PPP is composed of these five organs, they would be of supplementary character in relations the United Nations.

If the PPP is constituted so as to transform the United Nations, it is possible that there appear more or less States which are unwilling to join it. It is clear, however, that the United Nations must be transformed into far better organization which meets the demand of 21 century, which would abolish war completely, and which will be a source of bright HOPEs for all human beings.

Article 24. The some of the most important functions of the PPP are:

- a. to study to replenish the United Nations in military, political, legal, economic, and other fields by newer, better and more democratic ways, and to present its proposals to peoples around the world.
- b. to study ways for maintaining and strengthening permanent neutralization **not only** of Ukraine, **but also of other States** and to present its proposals to peoples around the world.
- c. to study peaceful settlement international and domestic conflicts, disarmament, international law and world law, several ways leading to One World, namely, the World Federation, and to present its proposals to peoples around the world.

The present Part 3 is very important matter. Deliberation leading to its conclusion may demand a long time. If so, point 24 or entire Part 3 may be deleted at the beginning stage.

PART IV. AMENDMENT

Article 25. Amendments to the present GAPNU shall come into force when they have been adopted by a vote of two thirds of the parties of the present GAPNU.

Article 26. General Conference of members of the GAPNU for the purpose of reviewing the present GAPNU may be held every 5 years.

PART V. RATIFICATION AND SIGNATURE

Article 27. The present GAPNU shall be ratified as follows:

- a. Regarding States, it shall be ratified by the signatory State in accordance with their respective constitutional process.
- b. Regarding Organizations, it may be ratified by signature attested by a notary public.
- c. Regarding Individuals, it may be ratified by signature also attested by a notary public.

Article 28. 1. The present GAPNU may come into force upon the deposit of ratification by Russia, Ukraine, the United Nations as an original member.

2. Other States, Organizations and Individuals may accede it by ratification.

Article 29. The present GAPNU shall remain deposited in the archives of the Government of Ukraine. Duly certified copies shall be transmitted by that Government to the other signatory States, Organizations and Individuals.

IN FAITH WHEREOF the Representatives of the Governments of Russia, Ukraine, United Nations, Organization, and Individuals have signed the present GAPNU.

DONE at the city of Kiev XX day of XX [month], twenty thousand and XX [year]

Points of Russo-Ukrainian Peace Treaty

Considering the decisions of the ELFO GA (General Assembly), ICO Pres. Rikio Kaneko proposes to the 14th ELFO GA to send Russian Pres. Putin and Ukrainian Pres. Zelensky the following points of the Russo-Ukrainian Peace Treaty (RUPT):

First of all, I want ELFO FAMILY members to see and understand matters to be talked with belligerents, which were adopted in 2022. Regarding these items, see pp.7~14 in a mail magazine “Rikio’s Message.N.186, OCT 06, 2022” (<http://mopw.org/pr.%20n186-con-start.pdf>)

Mr. Rikio chose some matters from among these items pertinent to the RUPT, trying to add some items to them. As of present time he presents to ICO and ELFO GA the following points to be sent to Russian and Ukrainian Presidents.

TREATY OF PEACE BETWEEN RUSSIA AND UKRAINE

PREAMBLE

WHEREAS peoples of Russia and Ukraine, freed from severe distress caused by war, and having hopes for evading from nuclear disaster, welcome from the bottom their heart restoration of peace and amity,

WHEREAS Russia and Ukraine are resolved that henceforth their relations shall be those of nations which, as sovereign equals, cooperate in friendly association to promote their common welfare and to maintain international peace and security, and are therefore desirous of concluding a Treaty of Peace which will settle questions still outstanding as a result of the existence of a state of war between them;

WHEREAS Russia and Ukraine declare its intention to remain as a member of the United Nations; in all circumstances to conform to the principles of the Charter of the United Nations; and in public and private trade and commerce to conform to internationally accepted fair practices;

WHEREAS Russia and Ukraine think it better to conclude bilateral peace treaty between both States independently of multilateral General Agreement on Permanent Neutralization of Ukraine (hereinafter referred to as GAPNU)

Russia and Ukraine have therefore determined to conclude the present Treaty of Peace, and have accordingly appointed the undersigned Plenipotentiaries, who, after presentation of their full powers, found in good and due form, have agreed on the following provisions:

PART 1. PEACE

Point 1. The state of war between Russia and Ukraine is terminated as from the date on which the present Treaty comes into force.

Point 2. The Russia and Ukraine recognize the full sovereignty of the both peoples over their territories and its territorial waters, provided that the international GAPNU is prior over domestic law of Russia and Ukraine.

PART 2. TERRITORIES

Point N.1. If Russia and Ukraine fail to settle territorial problems by peace treaty, they shall promise to continue to negotiate after its conclusion.

Point N.2. If both parties cannot settle the territorial problem for a long time by negotiation after conclusion of peace treaty, it may be several phases which our ICO may propose to Russia and Ukraine.

Point N. Russia and Ukraine may continue exclusive diplomatic negotiation for 10 years.

Point N.4. If they fail to settle territorial problems by diplomatic negotiation, they shall submit the case to an international conciliatory organization.

Point N.5. If Russia and/or Ukraine does not agree to conclusion of the said international conciliatory

organization, the case shall be submitted to the ICJ (International Court of Justice), asking it to deliver an advisory opinion.

Point N.6 If Russia and/or Ukraine does not agree the said advisory opinion of the ICJ, the case shall be submitted to the ICJ, asking it to deliver a judicial decision binding both of the parties.

Point N.7. Russia and Ukraine shall respect the decision of the ICJ, provided that they may alter the contents of decision if they agree to it.

Point N.8. While conciliation or judicial procedure goes on, Russia and Ukraine may negotiate at any time.

PART 3. SECURITY

Point N.1. Russia and Ukraine accepts the obligations set forth in Article 2 of the Charter of the United Nations, and in particular the obligations.

(i) to settle its international disputes by peaceful means in such a manner that international peace and security, and justice, are not endangered;

(ii) to refrain in its international relations from the threat or use of force against the territorial integrity or political independence of any State or in any other manner inconsistent with the Purposes of the United Nations;

Point N.2. (b) Russia and Ukraine confirm that they will be guided by the principles of Article 2 of the Charter of the United Nations, provided that XXXXXX.

Point N.3. (c) Russia and Ukraine recognize both States as a sovereign nation possesses the inherent right of individual self-defense.

PART 4. OCCUPATION

Point N.1 Russia and Ukraine shall withdraw their occupation forces from territory of the other party at least up to 80 % within 1 year after effectuation of the present peace treaty.

Point N.2. Even if some occupation forces of Russia or Ukraine remain, due to some situation, in territory of the other State, it does not mean that the occupant State has acquired sovereignty over such territory so long as both States have not agreed to that effect.

Point N.3. Nothing in this treaty shall, however, prevent the stationing or retention of armed forces in territory of the other party by agreements which have been or may be made between one or more of the concerned Powers.

Point N.4. All Ukrainian and Russian property for which compensation has not already been paid, which was supplied for the use of the occupation forces and which remains in the possession of those forces at the time of the coming into force of the present Treaty, shall be returned to the Ukrainian and Russian Government within the same 90 days unless other arrangements are made by mutual agreement.

Point N.5. Respecting rules of international law, occupant shall administer the occupied territory, not only in the interest of his own military advantage, but also for the public benefit of the inhabitants thereof.

PAET 5. POLITICO-ECONOMIC CLAUSES

Point N.1. Russia and Ukraine, within one year after the present Treaty has come into force, will notify the other party which of its prewar bilateral treaties or conventions it wishes to continue in force or revive, and any treaties or conventions so notified shall continue in force or by revived subject only to such amendments as may be necessary to ensure conformity with the present Treaty.

Point N.2. The treaties and conventions so notified shall be considered as having been continued in force or revived three months after the date of notification.

All such treaties and conventions as to which Russia or Ukraine is not so notified shall be regarded as abrogated.

Point N.3.

(a) Russia and Ukraine will recognize the full force of all treaties now or hereafter concluded by Parties to the General Agreement on Permanent Neutralization of Ukraine (GAPNU)

PART 6. CLAMS AND PROPERTIES

PART 7. SETTLMENT OF KOFLICTS

In case there appears legal problem regarding interpretation of some phrases, there must be an Article which provides method for settling the problem. It is desirable that when Russian and Ukrainian Government are not able to the problems neither by negotiation nor by conciliation, they choose, among others, judicial settlement by the International Court of Justice.

PART 8. FINAL CLAUSES

Decision by the ELFO GA for Reference

2. Ukraine will not join the NATO

As Ukraine once expressed her readiness not to join the NATO, it may be comparatively easy for the ICO to embody its equitable proposal to the belligerents. The ICO will search for the followings:

- i . What States should guarantee security of Ukrainian State?
- ii . Is it not better for the United Nations to be a contracting party of the said security treaty?

Permanent neutralization of Ukraine

In July 22, 2022 before all the ELFO FAMILY I dared to mention a way of neutralization of the Ukraine as one of the possible breakthroughs of negotiation for cease-fire and peaceful settlement of Russo-Ukrainian War.

If the ECOC (Executive Committee of Online Conciliation) were to propose it now, the Ukrainian Government would be more or less dissatisfied with such an idea. **It is equitable, therefore, that, to that extent, Russian side would make due concessions to Ukrainians.** Let's ICO talk about it.

A. ICO members' opinions

○**ex-Amb. Yuba Nath.** You know already his exclamation (JUL 22, 2022) regarding my idea about neutralization of Nepal and Ukraine. Nepal is similar with Switzerland in some respects. Our correspondence is as follows:

Rikio: *Thank you, Yuba Nath San. I hope that your country be permanently neutralized State which not only States but other entities guarantee.*

Yuba: *Resourceful, Intelligent, Knowledgeable, Intelligent and Open. This is RIKIO.*

Rikio: *Dear Yuba, may I open our conversation to the ICO and ELFO members? Because I want very much to talk among ELFO FAMILY about permanent neutralization of Ukraine. I suppose you'll agree to my ideas.*

Yuba: *ok*

○**Pres. of the BELFO Edmario Peoxinho.**

In JUL 23, 2022 he wrote, "I agree with the valuable perspectives and mindset of Mr. Rikio Kaneko on Ukraine's Neutrality and Vision."

Neutralization was great thema of the ICO GA (General Assembly), but no body was against neutralization of Ukraine.

B. Reasons for neutralization of Ukraine

1. As I said, a way of neutralization of the Ukraine may be "one of the possible breakthroughs of negotiation for cease-fire and peaceful settlement of Russo-Ukrainian War."

2. Militarization with modern weapons and strengthening military alliances are contrary to normalization of Earth-community and maintaining beautiful cosmos.

3. Considering history of human beings, use of armed forces and even threat by it were prohibited gradually, so, the way along which humankind march is disarmament and peaceful settlement of conflicts.

4. Such peaceful amicable way leads to ONE World, namely, World Federation where **every State shall be peaceful, and of neutralized character.** Permanent neutralized States or regions are forerunners of progressive peaceful process moving toward establishment of ONE World. **They can be even proud of it: they are in the van of the era!!**

C. Concept of permanently neutralized State

Here a permanently neutralized State means a State whose independence and integrity are for all future time guaranteed by an international treaty, under the condition that such State binds itself never to take up arms against any other State except for defence against attack, and never to enter into such international obligation as could indirectly involve it in war. (Oppenheim's international law, Vol. I . PEACE, 8th ed. Longmans, p.243.)

The neutralization may contain a possibility to conclude a convention by which a neutralised State can acquire, without cession of, new parts of territory with the consent of all the contracting States.

Here I took into account Ukrainian possibility that Ukraine can recover sovereignty over region which she lost it at the time of conclusion of peace treaty with Russia. It goes without saying that such alteration of sovereignty needs a new agreement among contracting parties of the treaty.

Separate treaty of neutralization. It seems better to conclude a treaty of permanent neutralization of Ukraine apart from a peace treaty between Russia and Ukraine because the former treaty involve more contracting parties, while the latter concerns, in principle, belligerent Russia and Ukraine though both treaties relate each other closely.

D. Equitable and good compromise

What will be the compromises between Russia and Ukraine from view points of equity and goodness (ex aequo et bono)? First of all, our ECOC will see the contents of obligations to be imposed upon Ukrainian State. If the treaty of neutralization stipulates such heavy obligations for Ukraine as disarmament, it is equitable that on Russian back would be also heavy burdens, to that extent. The converse is also true.

Here ECOC's task is to try to make up a draft convention as clearly as possible. Then it will be easier for the ECOC to propose several mutual compromises.

3. Demilitarization

Neutralization partakes politico-diplomatic and military character, while demilitarization partakes mainly military character imposing restrictions in respect of weapons and region. We are pleased if belligerents agree to following points.

1. If restrictive burden is heavy on Ukrainian shoulder, then to that extent, Russian burden will be also heavy.

2. In Ukraine such 3 non-nuclear principles are to be applied as in Japan for a long time, namely: not producing, not possessing and not allowing the entry of nuclear weapons into the country.

3. Along the Russo-Ukrainian border, will be created a **demilitarized zone** with certain width of

regional belt.

4. Our ICO proposes to Russians and Ukrainians to change the said zone into not arena of quarrels, but on the entire contrary, into a place where spirit of peace, friendship, welfare, and cooperation rules.

5. A definite zone (for example, 1km.) around an atomic station shall be demilitarized, and it shall not be a battlefield.

6. Ukraine and Russia shall neither locate military objects within or near a port which are used for exporting food, nor use such a port for importing weaponry and other military purposes.

5. Territorial problems

It may be very complicated process to settle these problems:

- A. It will be very good if Russia and Ukraine can conclude a peace treaty by themselves which would settle their territorial problems finally.
- B. It is possible, however, that even if they succeeded to conclude peace treaty which stops warfare, they could not agree to final settlement of territorial problems.

The several points below-mentioned concerns the just said case B, and are to be regarded as the ICO PROPOSALS to belligerents.

Point N.1

If Russia and Ukraina fail to settle territorial problems by peace treaty, they shall promise to continue to negotiate after its conclusion.

Point N.2

If they cannot settle the territorial problem for a long time by negotiation after conclusion of peace treaty, it may be several phases which our ICO may propose to Russia and Ukraine.

Point N. 3

Our ICO proposes the 10 years for diplomatic negotiation. This period is for autonomy of diplomatic negotiation between Russia and Ukraine.

Point N.4

If they fail to settle territorial problems by diplomatic negotiation, they shall submit the case to an international conciliatory organization. (As to our ICO, the GA will decide if it is ready to receive the case)

Point N.5

If Russia and Ukraine agree to conclusion of the said international conciliatory organization, it is very good.

But if one of them does not agree to it, the case shall be submitted to the ICJ (International Court of Justice), asking it to deliver an advisory opinion.

Point N.6

If Russia and Ukraine agree to conclusion of the said advisory opinion of the ICJ, it is very good. But if one of them does not agree to it, the case shall be submitted to the ICJ, asking it to deliver a judicial

decision binding both of the parties.

Point N.7

Russia and Ukraine shall respect the decision of the ICJ, provided that they may alter the contents of decision if they agree to it.

N.B. While conciliation or judicial procedure goes on, Russia and Ukraine may negotiate at any time.

6. Food (wheat) problems

In order that Ukraine provides African countries with food, especially Ukrainian wheat, we the ICO proposes followings:

1. Ukraine and Russia shall neither locate military objects within or near a port which are used for exporting food, nor use such a port for importing weaponry and other military purposes.
2. Russia and Ukraine will neither attack such a peaceful port so long as other belligerent observes the aforementioned rules, nor attack a ship carrying such humanitarian food.
3. A Commission for Exporting Food to Africa (CEFA) will be created. It shall be composed, among others, of permanent member of African Union, United Nations, Russia, Ukraina, and Turkey.

11. Prisoners

Our ICO proposes as follows:

1. From humanitarian point of view, belligerents shall facilitate exchange of prisoners as much as possible.
2. When a Russian troop or organ brings an Ukrainian civilian to Russian authorities, they shall inform Ukrainian authorities of the civilian name, address, profession etc. as soon as possible.

12. Aid and reparation

Money should be used not for destruction, but for construction and rising a leve of life ASAP

The problems of aid and reparation for Ukrainians are also very important, I presented my ideas to the ICO GA, which adopted the bellow-mentioned proposals of mine unanimously. Fortunately No ICO members expressed any doubt.

“Personally I want almost all the States around the world to aid Ukrainians to restore their level of life. I suppose that Ukrainians’ standard of living rapidly and horribly declined after commencement of Russo-Ukrainian War. Before the war Ukrainian PPP (purchasing power parity) was 51 % as is seen in the below table.

**Fiji 56%; Bhutan 55%; Jordan 54%; Jamaica53%; Ukraine 51%; Eswatini 51%; Belize 50%;
Philippines 49%; Morocco 48%;**

I hope that all the Sates should help Ukrainians restore former level of life. What States, to what

extent, and how many years should aid Ukrainians? Here it is desirable to apply some objective economic and social indications. One of my ideas is adoption, by the ICO GA, of followings.”

Thus I sent my proposals to the GA, which also adopted them unanimously:

1. **WIN-and-WIN relations**. Aid and reparation will be rendered on basis of win-and-win relations, not a victor nation-and-a defeated nation.

2. Almost all the States of the world should aid Ukraine until she restores her PPP to 50%;

3. SHARE (ratio) of aid by each State for Ukraine will be proportionate with (a) her military expenditure or (b) the increased budget part of the past military expenditure which was caused by Russo-Ukrainian War.

4. On the basis of Win-and-Win spirit both Russia and Ukraine renounce mutually right to claim reparation for damages caused by war, provided that Russia shall also aid Ukraine in accordance with the preceding paragraph 3.

5. The State which went to default or the States whose PPP is less than 50% may be exempted from the aforesaid aid.

14. ICJ for settling legal problems

War must be ended by conclusion of peace treaty. In case there appears legal problem regarding interpretation of some phrases, there must be an Article which provides method for settling the problem. It is desirable that when Russian and Ukrainian Government are not able to the problems neither by negotiation nor by conciliation, they choose, among others, judicial settlement by the International Court of Justice.

Website of ELFO FAMILY

1. **Ms. Afua may obtain a good quality Website, at her own expense, with great graphics and features.** (**Ms. Afua, thank you so much. I suppose all the ELFO members are very glad at your volunteerism**) It will operate in English. It will have some members log in to engage on site. Ms. Afua suggests that Ms. Afua herself, **Hon. Pres. Rikio, Japanese specialist Mr. Kunihiro Matsumoto and Satoshi Miura** as administrators of the website will upload and publish.

2. GA Chair Mrs. Irina (or suitable candidate) will then notify member of news by email or via the website. This will contribute greatly to ELFO image and branding and attract people.

3. Email marketing campaigns can be sent via the website application, by Mrs. Irina and maybe others by agreement, may be automated.

Provisionally Agenda item N.1 was adopted in April 29, 2024

Charity drives

Ms. Afua may operate charity drives not only in South Africa, but also around the world and then inform the media so she can raise awareness about ELFO. (Very good!! Thank you very much!! Then I will sing Earth-Loving Songs written by me gratis, hahaha!! It's not joke, and someone will play guitar when I sing. We can do such charity drives not only virtually, but also actually in New York or Genieve where it is easier for members to gather.)

Provisionally Agenda item N.2 was adopted in May 1, 2024

Sponsors

1. Ms. Afua proposes joining the list of Sponsors for financial events in the USA and Europe, and maybe others, at her own discretion and expense to raise awareness on ELFO. For example, she says she can sponsor something (maybe the lunch or drinking glasses or writing stationery) at financial conferences where investors are meeting in America and list ELFO as a sponsor, at her own expense (she will pay the sponsorship). It's also very good!

2. ELFO will be named as one of the sponsors and ELFO name and logo will be advertised to very important people and Bankers. Morally we can do it.

Provisionally Agenda item N.3 was adopted in May 1, 2024

Bank account

1. Ms. Afua will open a **bank account** for ELFO that ELFO can use for its matters. **ELFO has its central bank account in Paypal.**
2. She will make the first monetary contribution and other members can also donate money to the bank account.
3. When we do ELFO projects that raise funds, then the money can go to ELFO bank account. She will administrate the account to monitor things since she will open the account. Then some of the bank transaction documents can be available for scrutiny by ELFO heads for the sake of transparency.

ELFAS

Ms. Afua will register **ELFAS (Earth-Loving Friendly Association in South Africa)** as an NGO in South Africa. She will use her company office address, which is a very nice location for the ELFAS address and registration. There will be boardroom access for meetings. She will pay for this. ELFAS will have a professional image. **This is also very good proposal of hers!!**

Provisionally Agenda item N.5 was adopted in May 1, 2024

Investors

When President Edmario invited Ms. Afua to join ELFO, she mentioned that **she would be able to bring investors to ELFO.** Over the years her **sister, Ayane**, and she have worked with investment banks, and financial institutions for her own company to do capital raises and on debt and equity financing deals. This is the network she intends to leverage for ELFO to grow. **(That's also very good!! Practical talks are going on regarding some members' projects, and I wish that Ms. Afua will be a party to these MOU.)**

Deal and commission

1. Projects and companies that Ms. Afua deems acceptable for her investors (which are financial companies based in the USA, Europe and Asia) and the investors agree to fund with debt and equity, (Grammatically I cannot understand the underlined sentence. Will you please rewrite it?)
2. The person who brings to Ms. Afua the opportunity will earn a **commission**, she also earns a commission and she will negotiate a small commission money goes ELFO by being transferred to the ELFO bank account that I open. ELFO money will be used for ELFO matters. (Dear Ms. Afua, I am very glad if you can show me an example regarding Mr. Ivo's projects. He and Mr. Ivo will be very glad if you are ready to be the 1st runner stipulated there in the MOU.)
3. ELFO kindly notes that it's Ms. Afua's discretion which projects and companies to take to her investors because she has their funding criteria. She has the right to decline referring a deal or opportunity.

Mr Edmario's São Paulo bnb project

Hon. Pres. Rikio proposes not deliberate this agenda item this time due to Pres. Edmario's possibility to live in a foreign country.

1. Ms. Afua will evaluate **Mr Edmario's São Paulo bnb project** to check viability for investors and arrange due diligence, give criteria for investors and see how the São Paulo project can be viable to investors. (Dear Ms. Afua, such step seems to be good. Regarding his project, I have talked for several months, so let's consult sometimes each other.)
2. If it meets investor criteria, then she will let us know, because she works with bigger companies and not small individual investors. So

these companies are very strict because of their investment regulations and laws in their country.

3. But also if Mr. Edmario has some middle market Brazilian companies that need debt and equity financing (What does it mean?), then if my investors find them acceptable, then it is good because he will get a commission and a small amount of money of such a deal that her investors fund she proposes is **donated to ELFO**. (Due to my poor English understanding, I want another simpler explanation.)
4. That's why she proposes publishing a website that will convey the best image for ELFO to investors and sponsorship of events that will impress investors and very important people. (Yes, conclusion is great.)

Member Participation

1. Member participation does not have to be ZAP only. Ms. Afua believes that members should be encouraged to engage on ELFO matters via several mediums on social media, on the website she offered, and in general member participation. (Yes, that's right.)
2. **Members should be able to do teamwork on ELFO matters.** Perhaps one can reach out to members to gain their involvement. She proposes a member relationship management that is similar to CRM customer relation management in the business world. **She believes we will get more out of our members this way.** Yes, I agree with her.

Draft Charter of the OELO

Charter of Organization of Earth-Loving Oases

We the supporters of the Organization of Earth-Loving Friendly (hereinafter referred to as OELO)

recognizing that economic cooperation among its members is very important for heightening their standard of living and that of members of ELFO FAMILY, wishing to realize idea of Earth-Loving Oasis (hereinafter referred to as ELO) which is provided for in the ELFO Charter, Article 3,

determined to unite our efforts to promote members' investment and loan activities, ELFO General Assembly decided to create the independent OELO as a member of the ELFO FAMILY and adopted its Charter of the Earth-Loving Oases Organization which reads as follows.

Done in Sapporo in January 1, 2024 (revised FEB 16, 2024)

Chapter 1. Purposes

Article 1 (Principal Purposes) The purposes of Organization of Earth-Loving Oases (hereinafter referred to as the OELO or Organization are as follow.

1. to contribute to promoting member's Earth-Loving Oasis project by helping them make up its plan and invite investment or match up supply to demand.
As for ELOO Charter see: (<http://mopw.org/elo%20n9%20char%20n%20form.pdf>)
2. to contribute to proper operation of business and ensuring cooperative relationships with private lodging business operators, private lodging manager, private lodging intermediaries.
3. to research international management of residential lodging, guesthouses, monthly inns, inns, and hotels, resort and seek ways to realize them.

4. to contribute to revitalizing members' regions by inviting investment and by promoting effective use of rooms, houses, building and land there.

Here, we are talking about effective use not only in the accommodation field, but also in other colorful fields.

5. to contributing to establishment of systematic and collaborative cultural housing and accommodation facilities, taking into account the global system.

It would be great if we could get cooperation from local governments, and if possible from the Japanese government, in making this global oasis, but it is impossible to get all at once, so we will first deepen cooperation with many companies.

Chapter 2. Organs

Article 2 (Principal Organs) The main organs of the Organization shall be President, 3 VIPs, a Board of directors, Departments, and a Secretariat.

Article 3 (President) 1. The President shall supervise the Organization, submit proposals to major organs, and appoint Organization officers.

2. President may act externally regarding a given situation by writing evaluations, proposals, statements, requests, etc.

Article 4 (3 VIPs) The three VIPs, consisting of the President, Vice-President, and Chairman of directors, shall decide on various matters while the Board of Directors is out of session.

Article 5 (Board of Directors) The Board of Directors may elect the President and Chairperson and make decisions on important matters of this Organization.

Article 6 (Departments) The Organization shall establish a lodging business operator department, a lodging manager department, a lodging intermediaries department, investment department and other necessary departments.

Article 7 (Secretariat) 1. The Secretariat will perform administrative tasks such as document preparation, communications, rosters, and accounting.

2. The Secretary General and Vice-Secretary may be paid a small amount of remuneration.

Chapter 3. Invitation of members

Article 8 (Invitation) 1. Any ELFO and OELO member may invite investors, bankers, and money lending people (hereinafter referred to as Cooperators or moneylenders) to join the ELFO and the OELO.

3. A Loanee's guarantor, a broker and an advocate **who will concern transaction within the framework of the present Charter** shall be an OELO member.

4.

3. All the OELO members shall be a member of a mother ELFO.

3. When people agreed to be an OELO member, their names shall be registered immediately in a General List (GL) where Cooperators, Loanees and interested persons may be listed.

Article 9 (Opening in a web-site) 1. An invitational text and an invitee's answers may be opened in a web-site for the ELFO and the OELO.

2. Any member may invite no-member people to be a Cooperator exclusively for oneself. In this case their names may not be opened in the web-site.

Article 10 (Admission, appointment and expulsion) 1. If OELO President does not express opinion against registration of them for 3 days since opening their names in the List, they shall be regarded as having entered our OELO and as appointed by President as a member.

2. When OELO President, ELFO Hon. President or ELFO President regards an OELO member as unsuitable for it, that appointment and membership may be withdrawn.

3. When 2 of OELO President, ELFO Hon. President or ELFO President agree to expulsion of a member unsuitable to ELFO FAMILY, the member may be expelled from the OELO.

Chapter 4. Cooperation between the ELFO and the OELO

Article 11 (The ELFO's multilateral help) 1. The ELFO as a mother organization of the ELFO FAMILY will help the OELO grow as much as it can in many fields.

2. The ELFO or the OELO may receive reflecting income from their members economic activities, and shall encourage such steps.

Article 12 (The OELO's duty) The OELO's duty to the ELFO is, among others, to pay ELFO members' annual dues for as many members as possible, using savings system of a bank or investment scheme of OELO members.

Chapter 5. General Assembly

Article 13 (Composition) 1. General Assembly (hereinafter referred to as GA) shall consist of such Cooperators, Loanees and other members ready to promote the idea of **Earth-Loving Oasis** (ELO). The members whose main purpose are to pursue profits may remain as a member without portfolio.

2. Chairperson of the OELO General Assembly has, in principle, such competence as ELFO Chairperson has. (See <http://mopw.org/rules%20on%20pres.n3.pdf>)

3. One member may be a Chairperson of the OELO and the ELFO at the same time.

Article 14 (Decision-making) 1. Will of the OELO may be decided, in principle, by OELO General Assembly.

Article 15 (Right to vote) Each OELO member has right to vote in accordance with a mother ELFO Charter, provided that if a member does not vote “Yes” or “No”, it is regarded as the same with that of the Representative who invited him or her to enter the OELO **and who is defined in Article 40.**

Article 16 (Meeting through the Internet) Meeting of the OELO may be conducted, in principle, through the Internet.

Chapter 6. PRESIDENT of 3 HEADs

Article 17 (Lack of powerful candidate) Considering pressure of many works on OELO President, it may adopt system of PRESIDENT of 3 HEADs while a powerful candidate for OELO President does not appear.

Article 18 (Division of works among 3 Presidents) The 3 Presidents have the following functions.

1. 1st President shall be responsible for general affairs of the OELO.
2. 2nd President shall be responsible for foreign affairs of the OELO.
3. 3rd President shall be responsible for internal affairs of the OELO.

Article 19 (Division of functions between 2nd and 3rd Presidents) One of the standard dividing 2nd President's and 3rd President's functions is necessity of external correspondence and unnecessariness of external correspondence. The former matters belong to functions of 2nd President, while the latter matters belong to the 3rd President.

Chapter 7. Rights and Duties of the OELO and the ELOC

Article 20 (Rights) 1. The General Assembly and its subsidiary Earth-Loving Oases Consultation (ELOC) composed 11 members have the right to make rules concerning the OELO.

2. ELFO Hon. President and its President may present its idea or proposal to the OELO which may be adopted by the OELO General Assembly.

Article 21 (Obligation) Neither the OELO nor ELFO itself, in principle, will be a financial subject of moneylenders, and both of them will not be responsible for any member's obligation.

Chapter 8. General List of Cooperators and Loanees

Article 22 (General List) Every Cooperator and Loanee shall present their application to the OELO Secretariat in accordance with the present Charter and application form.

Article 23 (Applicants' preparatory duty) 1. At the 1st stage an applicant may present a message or incomplete application which may be opened in the web-site.

2. From the 2nd stage each applicant shall pay attention to points in the application form which are incomplete and seen with red phrases, and shall make one's application perfect.

Article 24 (Unnecessary items for application) While application is not in accordance with the present Rules, it may not be opened in the ELFO web-site. When an applicant sends materials unnecessary for application, the Secretariat may not keep it in custody.

Chapter 9. Relations among Cooperators and Loanees

Article 25 (Notification) When an applicant wants to begin talk on transaction with another applicant, the former shall notify Secretariat of the other partner's name.

Article 26 (Multilateral choice) A Cooperator may lend money to plural Loanees. Likewise a Loanee may borrow money from plural Cooperators.

Article 27 (Autonomy of parties of a contract) Irrespective of conditions mentioned in an application each party to transaction may amend them within frame of the present Charter.

Chapter 10. A Loanee and Memorandum of Understanding

Mr. Ivo may encourage Cooperators' early determination of their investment by refunding on the basis of an agreement, irrespective of the time of conclusion of the present MOU, to 1st runner of the investment, additional 3 % of the sum, to 2nd runner additional 2 %, to 3rd runner additional 1 %.

Article 28 (Draft MOU) A Loanee or a Cooperator is responsible for presenting the 1st draft MOU (Memorandum Of Understanding). If it is burdensome for ~~the Loanee~~ ~~them~~, ~~he or she~~ they may entrust any ELFO member as an assistant with making it up by a contract.

Article 29 (ELFO Model of MOU) Parties to a project shall examine a draft MOU made up in accordance with ELFO model attached to present Charter. Unless otherwise agreed, ELFO Model MOU is supposed to be the 1st draft MOU.

Article 30 (Opening the MOU) When any concerned partner presents a draft MOU, it shall be opened in the ELFO website or in a message to concerned parties. It may be opened to all ELFO members.

Article 31 (Assistant's immunity) When a Cooperator and a Loanee conclude a MOU and other contract, any party to it is responsible for one's duty and act finally, and shall not impute one's responsibility to one's assistant, the OELO, or the ELFO.

Chapter 11. Loanee's Duties

Article 32 (ZAP) 1. If a Loanee wants investment of more than 1, 000, he or she will have duty to create one's domestic or international ZAP (Zoom Amicable Party) aiming at creation of FM and Radio.

2. The Loanee has a duty to join the ELFO central ZAP for 30 minutes at least once a week, and if it is impossible, let some member join it.

3. When the ZAP grows into a FM, a Radio or a TV company, he or she may be its staff.

Article 33 (One's National ELFA) 1. If a Loanee wants investment of more than 10, 000, he or she will have duty to establish one's national ELFA (Earth-Loving Friendly Association).

2. The said Loanee may ask one's patriot to be President of the national ELFA.

Article 34 (One's National or local ELC) 1. If a Loanee wants investment of more than 100, 000, he or she will have duty to establish one's national or local ELC (Earth-Loving Company) or local ELC in accordance with rules in the ELFO FAMILY.

2. The said Loanee may ask one's patriot to be President of the national or local ELC.

Article 35 (Employment) A Loanee of the above genre will make an effort to employ one's national ELFO compatriot so that majority of workers be ELFO members.

Chapter 12. Broker

Article 36 (Definition) By the present OELO Charter a '*broker*' means an ELFO member who invited a person to join ELFO FAMILY and wants this invitee to invest in another member's project and who succeeded in matching the Cooperator with a Loanee.

Article 37 (10% to ELFO FAMILY) When the above said Cooperator send capital to the Loanee by a contract, the broker will get 1% of the remittance, provided that 10% of the broker's income shall be donated to the ELFO FAMILY.

Chapter 13. Representative and an Assistant

Article 38. (Definition of Representative) In the present Charter '*Representative*' means a member who succeeded in inviting a person to enter the OELO or the ELFO.

Article 39 (Representative and Assistant) 1. By the present Charter neither Representative nor an assistant to a Loanee or a Cooperator is a broker, provided that they shall donate 10% of their gain to the ELFO FAMILY.

Article 40 (Representative's right) 1. Representative has the right to vote for the invitee when the latter does not use the vote.

2. When a Cooperator and a Loanee have concluded a contract of loan, Representative may receive from them a certain amount of gain as reflecting interest at least 1% of total sum of loan.

~~3. 10% of the said gain shall be donated to ELFO FAMILY.~~

4. Representative shall not, in principle, a party to MOU (Memorandum Of Understanding).

Chapter 14. Assistant

Article 41 (Loanee's and Cooperator's assistant) Any ELFO member may be Cooperators' or/and Loanees' assistant by a contract who may, in their names, invite a new Cooperator or a Loanee.

Article 42 (Remuneration) Remuneration for an assistant shall be paid from Loan by at least 1% of the money which the Cooperator sends to the Loanee so long as it is in conformity with domestic law concerned. (For example, if an assistant in Loanee' name succeeded in inviting a Cooperator to send 100 & to a Loanee, he or she will receive 1 \$ from the capital 100 \$. Actually the Loanee will receive 99 \$.)

~~2. 10% of the said remuneration shall be donated to ELFO FAMILY.~~

Chapter 15. Amount of Loan and Refund

Article 43 (Limitless loan) 1. There is no limit of amount of money to be provided to a Loanee so long as the 1st and the 2nd guarantors together with security are proved by documents, which the Loanee may present after the date of application.

2. Guarantors for an applicant shall ensure their security by depositing a certain amount of money in a Cooperator (an investor, a banker etc.) **by SBLC or other means** with due interest to be paid to guarantors. In case the Loanee cannot refund loan, the deposit money with interest may be regarded as a part of guarantors' security.

3. Total sum of loan shall be shown with such a clean number as 1,000 \$ or 5,000 \$, 10,000 or 15,000 \$, 20,000 \$, 25,000 \$, 30, 000 \$, 35,000 \$ etc. without an odd sum which makes more difficult to count. Table of the above refund will be shown in an attachment to present Charter.

Article 44 (Limit of loan) An OELO member, who wants fund without any guarantor and security, may apply less than ~~100,000~~ **10,000** US \$ provided that exact and elaborated plan shall be presented within 6 months from the date of application.

Article 45 (ELFA) An applicant of more than 10,000 US, a national ELFA and ELC (Earth-Loving Company) shall present exact and elaborated plan.

Article 46 (Period of Refund) 1. In order to invite capital as much as possible for Loanees, period of refund, in principle, shall be 5 years which would make Cooperators (bankers or investors etc.) feel safer.

Article 47 (5% Interest on a Loan) Unless otherwise agreed and 5% interest is against domestic law of concerned party, 5% compound interest shall be applied among OELO members in general.

Article 48 (6~8% interest) A loanee may encourage Cooperators' early determination of their investment by refunding on the basis of an agreement, irrespective of the time of conclusion of the MOU, additional 3 % interest to 1st runners of the investment, additional 2 % interest to 2nd runners, and additional 1 % to 3rd runners.

2. When a Loanee fails to refund in a given year above-mentioned, unless otherwise agreed, the interest of that year will be 6%, and from the 6th year the 7% of interest will be applied to the refund. Any partner shall not regard Loanee's arrears as unfriendly.

Article 49 (International remittance) 1. Among OELO members international remittance of money shall be conducted through Paypal, and a receiver of money shall pay fee for the remittance of money, if not specially provided.

Chapter 16. Security and Guarantors

Article 50 (Object of security) 1. Object of security (or mortgage) may be property, money and/or negotiable instruments.

2. Object of security shall be free and clear, shall not be double mortgage.

Article 51 (Attestation by notary public) 1. Object of the security shall be attested by a notary public by Loanee's burden.

2. Authentication by the notary public shall be attested by reliable info or documents attached to the authentication.

3. When a Loanee makes one's immovable property lie in mortgage, names, addresses, email addresses etc. of some realtors nearest to the property shall be written in one's application.

Chapter 17. Assessment

Article 52 (Assessment by the OELO) 1. At any time when OELO President decides it necessary to assess a given project by face to face meeting, any party to the MOU shall welcome the President or his agent.

2. When Loan is more than 1 million US \$, it is obligatory for the President, as early as possible, to see the Loanee face to face and other persons and objects concerned.

3. Regarding the assessment of the Loanee's project, President shall make a report for the OELO Board of Directors and for Cooperators, which shall be opened in the OELO website.

Article 53 (Costs of President's stay) 1. Transport fee between President's country and the Loanee's, and other costs necessary for his staying there may be paid from loan money which received from Cooperators.

2. Total costs for the above travel and assessment shall be decided by the Board of Directors, considering PPP etc. The fees beyond the above costs shall not be paid from the loan.

Article 54 (Assessments by 10 grades) 1. The Board of Directors shall assess the Loanee's project on several points such as security, guarantors, refund, transport, place of object, profitability etc.
2. The Loanee may comment on the above assessment, proposing better steps.

Chapter 18. OELO membership fee

Article 55 (From the ELFO) When an OELO member paid membership fee, he or she may be a ELFO member and OELO's daughter organization without paying their membership fee. The OELO may collect equal membership fee without variation.

Chapter 19. Saving and Investment

Article 56 (Members' investment for membership fee) An OELO Cooperator may invite ELFO members to save their money in one's bank, or invest in investors plan, as a result, gaining profits and subrogating their membership fee.

Article 57 (3 steps) A member can use following rules on membership fee.

1. A member (named **A**) will send a certain amount of money (US\$ which sum is **B**) to a member-bank or an investor (named **C**);
2. The **C** will gain profits by using US \$ **B**, every year shall pay **A**'s dues to the ELFO Secretariat for **A**, interest to **A**, and shall repay all remainder to **A** at the end of contract period.
3. The said certain amount of money depends upon an agreement between **A** and **C**. It is desirable, however, that the amount would be enough for the members to pay continuously every year one's due, receiving interest.

Chapter 20. Inspection Committee

Article 58 (unfair use of loan) When a Cooperator complains of alleged unfair or unlawful use of loan to a Loanee or person responsible for account, the latter persons shall hear the other parties' opinion.

Article 59. It is desirable that the decision by majority of parties of the MOU be respected. If the Loanee is not satisfied with the said decision, it shall be submitted to procedure provided for in Chapter 16 of the present Charter.

Chapter 21. Settlement of conflicts

Article 60 (Use of OPAC or TPAC) Regarding a conflict between the Cooperators and a Loanee, it is very desirable, firstly, that they use ELFO system of OPAC (One Person Amicable Conciliation) or TPAC (Three Persons Amicable Conciliation).

Article 61 (Use of OJAC or TJAC) If one of the contesting parties cannot be satisfactory with award of the said conciliation, it is very desirable that they use OJAC (One Judge Arbitration Court), TJAC (Three Judges Arbitration Court).

Chapter 22. Finale Articles

Article 63 (Actual effect) Present Rules will be actually effective after the date of clarification of its lawfulness, completion of procedures, and compliance with domestic and international law. The date will be indicated clearly indicated later in the present Charter.

Article 64 (Non-responsibility of the ELFO) The OELO will not be responsible for transaction concluded before the above said date. Such negotiation and the transaction shall be regarded simply as a contract exclusively between them outside the limit of OELO.
