

# 3<sup>rd</sup> PROPOSAL to the 4 VIPs



*Joint PROPOSAL (N.3)*

*Recognized by ELFO FAMILY in February 22, 2025*

*Dear Messrs. Russian Pres. Vladimir Putin, Ukrainian Pres. Volodymyr Zelensky, the USA Pres. Donald Trump, and UN Secretary-General Antonio Guterres*

*We the ELFO (Earth-Loving Friendly Organization) have honor to send you our greeting and significant 3<sup>rd</sup> PROPOSAL on truce, restoration of peace and amity for the purpose of promoting to build one better world community.*

*Dear USA Pres. Donald Trump, we the ELFO has also honor to congratulate you on your inauguration as USA President, and are very pleased at your determination to end Russo-Ukrainian War, which is completely in accordance with our wish.*

*We the ELFO wish as before that Your Exc. change the present international situation into better world, especially regarding terrible and catastrophic Russo-Ukrainian War, making efforts neither to escalate war nor to increase hatred, rather searching compassionate reasonable compromise, ending immediately Russo-Ukrainian War.*

*We ELFO FAMILY have sent 5 times our conciliatory PROPOSALS to Russian Pres. V. Putin and Ukrainian Pres. V. Zelensky, considering each time a new given serious situation. (<http://www.mopw.org/r.%20only%20conci.%20241213.pdf>)*

*We ELFO FAMILY adopted ELFO Hon. Pres. Rikio Kaneko's draft Treaty on Permanent Neutralization of Ukraine (hereinafter referred to as TPNU, which was decided in August 2024, <http://www.mopw.org/treaty%20on%20ukranian%20per.%20neu.%20250218.pdf>) and this time also reconfirmed it again today February 22, 2025.*

*As we stated in the 2<sup>nd</sup> PROPOSAL, permanent neutralization of Ukraine may be much compromise for Ukrainians. If so, Russians and concerned nations as well as people interested in this matter must consider also due compromise from Russian side. We the ELFO, on the other hand, will study Russo-Ukraine Peace Treaty (RUPT), and we will try to consider the TPNU and the RUPT ex aequo et bono (equity and good).*

*We the ELFO decided, for the purpose of cherishing Hopes and Lights and strengthening peace and friendship among nations, to promote in Ukraine after war a project of PELPPA (Palace of Earth-Loving Permanent Peace and Amity). The PELPPA is related with a treaty of Permanent neutralization of Ukraine. (<http://www.mopw.org/uk-loanee-n2-241125.pdf>)*

*In February 19, 2025 our ELFO and its child ICO (International Conciliation Organization) adopted the following 3 points:*

**1. A decisive (critical) date.** *When shall belligerents stop war? Up to the present time, there is no rule in international law which indicates the date when belligerent should stop their war. Nevertheless it is desirable to make some norms or standards by which belligerents should not fight anymore or by which belligerents feel heavy oppression from international society aspiring after truce.*

*As such our ELFO and the ICO propose the date when it is clear, as a result of the UN decision or a questionnaire, that two thirds majority of States wish unconditional stop of war.*

*Irrespective of the said norm we wish the UN to conduct questionnaire in such respect.*

## **2. Legal effects of decisive date**

- a. Belligerents shall never fight anymore after the decisive date;*
- b. If one of belligerents stops war after the decisive day, it is categorically obligatory for the other to stop the war;*
- b. Status quo of occupied territories shall maintained, unless otherwise agreed by belligerents;*
- c. Occupied territories in Ukraine as well as in Russia shall be supervised by the UN;*
- d. Increase of the occupied territories after the decisive (critical) date shall never recognized by the United Nations or the States who voted for the decisive date.*

**3. Reasons for permanent neutralization.** *Why are neutralization of Ukraine, moreover permanent neutralization of Ukraine better and more significant than Ukraine’s accession to the NATO? Dear Your Exc., you can see one of the causes in the Preamble in the treaty on neutralization of Ukraine, which stresses, among others, that rather Ukraine “can be proud of its historical role as a forerunner of progressive peaceful process leading to establishment of ONE World.”*

Furthermore, in PROPOSAL to 2 belligerents our ELFO and ICO stated clearly reasons for justification of permanent neutralization of Ukraine. In a word our planet must go along away to perfect disarmament, especially of nuclear weapon, peaceful settlement of conflict, not strengthening antagonistic military alliances. Here our ELFO and ICO add 3 moments; *firstly*, if Ukraine tries to join the NATO now and also in future, more risky darker Russo-Ukrainian War will continue, and new category of more horrible and catastrophic war may break out due to following second moment, which leads possibly to the World War III.

*Secondly*, from viewpoint of geopolitics Russia cannot endure seeing such very close nation as Ukraine join the West, and be an opponent probable to direct weapon against Russia. It means that if Ukraine becomes a neutral State, international tension will mitigate. If Ukraine will be a permanent neutral State, it will be the safest and securest form, provided that *security of Ukraine shall be categorically guaranteed.*

*Thirdly*, we the ELFO FAMILY (as well as overwhelming majority of human beings, we suppose) rest on the principle of *the Greatest Happiness of All Human Kind*, neither of majority nor specific nations or groups.

All the people know, and overwhelming majority of the world feel, severe bad influence of war upon many spiritual and material aspects of their life. The Greatest Happiness of All Human Kind are hindered by belligerents. This iron principle is superior over the greatest happiness of the greatest majority or group.

Dear Messrs. Dignitaries, we are glad if our joint PROPOSAL (N.3) is more or less meaningful for you. Anyway we wish you be happy, successful as well as peoples around the world, stopping war, restoring peace!!
