In July 1, 2025 began the 6th session of 16th General Assembly

1. Who will be GA Chairperson?

It was decided that I Irina K. should be.

2. Who will be the ELFO FAMILY's important staffs of 2025?

I wish someone recommends oneself or others as ELFO's important staffs.

I decided that Hon. Prof. Dr. Duchess Letitia was elected as ELFO 2nd President for Foreign Affairs and as ICO President as there did not appear a concurrent candidate. **Thereafter she withdrew her membership, but remained as an observer.**

3. ELECTION of Presidents in our ELFO FAMILY!!

There are 2 kinds of Presidents in our ELFO FAMILY:

- A. Presidents of Organizations of the ELFO FAMILY, and
- B. Presidents of national ELFAs (Earth-Loving Friendly Association) in many countries.

A. Presidents of Organizations of the ELFO FAMILY

Every member of ELFO FAMILY must know that at the very beginning stage all the Presidents shall be ELECTED, not appointed. Please recommend oneself or others as a Presidents of ELFO FAMILY.

A. In MAY 26, 2025 Hon. Pres. Rikio Kaneko sent me his corrected idea on important Presidents' new position, but if you want to recommend yourself or others as President or other staffs, please feel free to send us your wish. The following was Mr. Rikio's corrected proposal:

1. Edmario will remain as 1st President of the ELFO

3. Kisembo remains as 1st President of the OELO
4. Edmario will be Acting President of the OELO
5. Edmario will be President of new NGO of ELFO FAMILY, namely, ELAFO.

B. Then, in May 28, 2025 Hon. Pres. Rikio sent me the second choice:

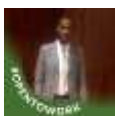

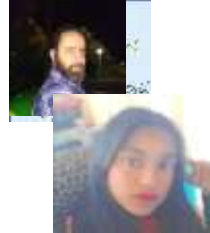

4. Now Mr. Rikio is ICO Hon. President

Ex- ICO President Rikio was a simple individual member in the framework of the ICO because Duchess Letitia replaced, while he has been moving most actively our ICO. Up to present times all the PROPOSALS have been drafted by him. And the other day I proposed, therefore, he would be approved as ICO Hon. President.

I decide adoption of my proposal as ELFO Pres. Edmario agreed with me, and there was no nay to my proposal.

5. ELFO's Goals and activities of 2025

Dear Edmario, I wished you would present them, only telling us points without explanation, with one line regarding each goal and activity. But you did not send me , so that Hon. Pres. Rikio summed them, and **I decided** as follows:

1. To invite 300 people to join our ELFO FAMILY
2. To hold ELFO 16th General Assembly (GA), 17th GA, 18th GA (SEP~NOV)
3. To send 6th ~9th PROPOSALS to all the HEADs of State
4. To conduct election of Presidents inf ELFO FAMILY
5. To make up MOUs on UN PELPAs in Africa, Arabia, and South America
6. To make up around 10 new MOUs on PELPA around the world
7. To create ELCO (EARTH-LOVING CHORUS ORGANIZATION)
8. To create ELIO (EARTH-LOVING IGO ORGANIZATION)
9. To create ELAFO (Earth-Loving Amicable Fellows' Organization)
10. To conduct the ZAP at 2 times belts: at 20:00 and other different time

Pres. Edmario sent the following items as ELFO Goals for 2025.

Participate in fundraising calls; Gain new supporters; Attract new volunteers; Implement new social projects; Maintain or increase the frequency of beneficiaries; Improve the retention rate of volunteers; Analyze the internal and external context of the NGO, identifying opportunities and threats; Set priorities based on the mission and available resources; Develop action plans that detail the steps needed to achieve the goals; Set specific targets that allow monitoring progress and adjusting strategies; How to evaluate impact; Cost per beneficiary; Beneficiary satisfaction rate; Social impact; Operational efficiency.

6. 3rd PROPOSAL to the 4 VIPs of Russo-Ukrainian War and succeeding PROPOSALs (See next agenda item)

7. 4th PROPOSAL to the 8 VIPs of Russo-Ukrainian War!!

Hon. Pres. Riko has been asking the ELFO and the ICO General Assemblies to adopt this agenda item promptly. And in Mach 11, 2025 I decided its adoption provisionally as Pres. Edmario agreed it and there was no nay to it.

The following is the final 4th PROPOSAL on truce and peace between Russia and Ukraine to be addressed not only to Russian Pres. V. Putin, Ukrainian Pres. V. Zelensky, the USA Pres. D. Trump, the UN Secretary-General Antonio Guterres, but also to English PM. K. Starmer, French Pres. E. Macron, Chinese Head of State X. Jinping, and Indian PM. N. Modi.

8. 5th PROPOSAL To All The World Heads Of State!

In March 28, 2025 ELFO Hon. Pres. Rikio asked me Irina to decide adoption of his draft Joint PROPOSAL (N.5) to **all the Heads of State**, which reads as follows:



Joint PROPOSAL (N.5)

On Truce of Russo-Ukrainian War and Restoration of Peace

Recognized by ELFO FAMILY in April XXXXX day, 2025

Dear all the Heads of State and Dear UN Secretary General Antonio Guterres!!

We the ELFO (Earth-Loving Friendly Organization) have honor to send you our greeting and significant 5th PROPOSAL on truce, restoration of peace, amity, Permanent Neutralization of Ukraine, and innovative norm of “decisive date” when belligerents should stop war legally.

Firstly, our ELFO FAMILY sent 5 times our conciliatory PROPOSALS to Russian Pres. V. Putin and Ukrainian Pres. V. Zelensky, considering each time a new given situation. The last text has its effect even now (please click [here](#))

Secondly, then our ELFO FAMILY thought it better to increase sphere of addressees more, and 4 time sent our updated PROPOSALS not only to the said warring Heads, but also to the USA Pres. Donald Trump, the UN Secretary-General Antonio Guterres, English PM. K. Starmer, French Pres. E. Macron, Chinese Head of State X. Jinping, and Indian PM. N. Modi. (click [here](#)) These texts have its effect even now. And I expect your Excellencies to read them.

This time we the ELFO wish all the world Heads of State to pay attention to our past effective PROPOSALS as well as present 5th PROPOSAL, and change the present dangerous international situation into far better world.

*We the ELFO FAMILY adopted unanimously draft of the **Treaty on Permanent Neutralization of Ukraine** (TPNU, which was decided in August 2024), and this time our ELFO FAMILY also reconfirmed its updated draft treaty in March 20, 2025 (Click [here](#)) and now. Regarding Permanent Neutralization of Ukraine, we are happy if you consider 9 points:*

1. An ideal and practical way of Neutralization of Ukraine may be a breakthrough of negotiation for truce and peaceful settlement of Russo-Ukrainian War. Otherwise, negotiation for

ceasefire may prolong. Permanent Neutralization of Ukraine is more stable than unilateral declaration of neutrality by Ukraine. The latter choice may open war again in risky situation.

2. Militarization with modern weapons and strengthening military alliances with tasks are contrary to demand of modern 21 century, normalization of blessed Earth-community and maintaining beautiful cosmos. Neutralization of States contributes to peaceful world community.

3. Considering history of human beings, use of armed forces and even threat by it were prohibited gradually, so, the way along which humankind march is disarmament and peaceful settlement of conflicts.

4. Such peaceful amicable way logically leads to ONE World, namely, World Federation where every State should respect each personality, be peaceful, and of neutralized character as all the autonomies (prefectures, cities, towns, village etc.) in a given country.

5. Permanent Neutralized States or regions are forerunners of progressive peaceful process moving toward establishment of ONE World. They can be even proud of it: they are in the van of the era!! We the ELFO FAMILY expect, from the bottom of our hearts, Your Exc. TOPs' epoch-making approval for our main idea of the present 5th PROPOSAL. (p.2 in [here](#))

6. Why is Neutralization of Ukraine, moreover Permanent Neutralization of Ukraine better and more significant than Ukraine's accession to the NATO? You can see one of these causes in the Preamble in the Treaty on Permanent Neutralization of Ukraine, which stresses, among others, that rather Ukraine "can be proud of its historical role as a forerunner of progressive peaceful process leading to establishment of ONE World."

7. If Ukraine tries to join the NATO now and also in future, more risky darker Russo-Ukrainian War will continue, and new category of more horrible and catastrophic war may break out which leads possibly to the World War III.

8. From viewpoint of geopolitics Russia cannot endure seeing such very close nation as Ukraine join the West, and be an opponent probable to direct weapon against Russia. It means that if Ukraine becomes a neutral State, international tension will mitigate. If Ukraine will be a Permanent Neutral State by treaty, it will be the safest and securest form, provided that security of Ukraine shall be categorically guaranteed.

9. Permanent Neutralization of Ukraine may be much compromise for Ukrainians. If so, Russians and concerned nations as well as people interested in this matter must consider also due compromise from Russian side. We the ELFO, on the other hand, study Russo-Ukraine Peace Treaty (RUPT), considering the TPNU and the RUPT ex aequo et bono (equity and good).

In April XXXXX, 2025 our ELFO and its child ICO (International Conciliation Organization) reconfirmed the following points, which both of the Organizations wish the United Nations to adopt:

1. A decisive (critical) date. When should belligerents stop war? It seems that up to the present time there is no rule in international law which indicates the date when a belligerent should stop their war. Nevertheless it is desirable to make some norms or standards by which belligerents should not fight anymore or by which belligerents feel heavy oppression from international society aspiring after truce.

As such a day our ELFO and the ICO propose the date when it is clear, as a result of the UN decision or a questionnaire, that two thirds majority of States (one tenths, or all the States

beside belligerents) wish unconditional stop of war. It is very effective if the UN Security Council decides resolution in general form that such decisive date is binding upon all the belligerent States or belligerent groups.

2. Legal effects of decisive date. *We expect the following effects:*

- a. Belligerents shall never fight anymore after the decisive date;*
- b. If one of belligerents stops war after the decisive day, it is categorically obligatory for the other to stop the war;*

We the ELFO, on the other hand, study **Russo-Ukraine Peace Treaty** (RUPT), considering the **TPNU and the RUPT ex aequo et bono (equity and good).**

In **April 22, 2025** our ELFO and its child ICO (International Conciliation Organization) reconfirmed the following points, which both of the said Organizations wish the United Nations to adopt:

1. A decisive (critical) date. When should belligerents stop war? It seems that up to the present time there is no rule in international law which indicates the date when a belligerent

should stop their war. Nevertheless, it is desirable to make some norms or standards by which belligerents should not fight anymore or by which belligerents feel heavy oppression from international society aspiring after truce.

*As such a day our ELFO and the ICO propose the date when it is clear, as a result of the UN decision or a questionnaire, that two thirds majority of States (one tenths, or all the States beside belligerents) wish unconditional stop of war. **It is very effective if the UN Security Council decides resolution in general form that such decisive date is binding upon all the belligerent States or belligerent groups.***

Regarding **Permanent Neutralization of Ukraine**, Hon. Pres. Rikio Kaneko proposed to send questionnaire to all the States around the world and asked the ELFO GA to adopt this proposal of his. **I decided** its adoption as there was no nay. See the 5th PROPOSAL where you see the questionnaire.

12. Promotion of PELPA

Hon. Pres. Rikio proposed to the GA that the ELFO and the OELO must promote the projects more ahead, that they would also promote MOUs for **Ms. Letitia, Ms. Sara, and Mr. Satoshi Miura (pic.)** because they were positive for promoting them, that member investors in MOU would be named, in principle, as lenders or loaner because it seems in this case there would be less restriction by law, that total sums of loan in Article 9 in the MOU is unbalanced, so that they need correction, that maximum sum of loan in Article 9 would be **200,000,000 US \$**, and that the ELFO and the OELO entrust him Hon. Pres. Rikio with correcting MOUs for a while until the effectuation of the MOUs.



13. Hon. Pres. Rikio's idea of UN PELPA adopted (APR 16, 2025)

In APR 14, 2025 he sent me the following message, asking to decide its adoption if there is no nay. As there was no objection, though there appeared dubious elements, **I decided** provisionally adoption of the following document:

According to UN SG Antonio Guterres's message, it is possible for the UN to finance 10 billion for our ELFO after its registration with the UN.

In order to make the UN's fund probable and to make our PELPA project more attractive, I ask ELFO General Assembly (GA) and the OELO GA to send to Mr. Antonio our idea that we are willing to promote our project of the PELPA in cooperation with the UN as follows, for example:

A. All the PELPAs around the Globe may be crowned with UN. So, UN PELPA in Brazil; UN PELPA in Sapporo, e.z.

B. The United Nations and their agencies may, of course, use the UN PELPAs around the world.

14. Due form prescribed for sending 6th PROPOSAL

In May 5, 2025 ELFO GA decided provisionally the said due form as follows:

Dear [President, Prime-Minister, or any addressee (Full name)]

I extend my sincere greetings to Your Excellency [you – in case of common people, for example] on behalf of the Earth-Loving Friendly Organization (ELFO) which I have the honour of presiding over and the International Conciliation Organization (ICO),

It is with deep respect and a profound sense of global responsibility that I share with you ELFO's 6th PROPOSAL concerning a truce, restoration of peace, permanent neutralization of Ukraine, and the introduction of an innovative concept – the “decisive date” by which belligerents should legally cease hostilities. (For 6th PROPOSAL please see an attachment or click [here](#)) We believe that the Permanent Neutralization of Ukraine can serve as a diplomatic breakthrough.

Over the course of this devastating conflict, ELFO has consistently pursued peaceful resolutions, issuing multiple conciliatory proposals to Presidents Vladimir Putin and Volodymyr Zelensky, then extending to Heads of State of the USA, the UK, France, China, India and Secretary-General of the United Nations. Now we call for all human beings to pay attention to our 6th PROPOSAL.

In addition, this time we propose a legal innovation: the “decisive date” – a specific, binding moment to be recognized by international community, by which all belligerents are expected to cease hostilities.

I respectfully urge you to consider our 6th PROPOSAL in full and to encourage your government's participation in the attached draft questionnaire, which aims to clarify global consensus on the key principles outlined.

Let us not allow this opportunity for peace to pass us by. History will remember those who stepped forward when the world needed healing.

15. Additional rule to the ELFO Charter!!

Hon. Pres. Rikio proposed addition of new rules to the ELFO Charter in order to avoid unsuitable external message and action, to maintain authority of the ELFO FAMILY. The red phrase is proposed to be added to existing Article 13, Para.3.

When Presidents and staffs express one's external opinion to non-member, they shall obtain recognition from the ELFO General Assembly in advance, provided that Chairperson of the General Assembly may permit them at one's own discretion when it is not so important item.

16. Creation of ELFO 3 VIPs Meeting

Hon. Pres. Rikio proposed to create ELFO 3 VIPs Meeting which is composed, in principle, ELFO Hon. President, ELFO President, and ELFO GA Chair, and which are competent to make provisional rule to be recognized at summery of that GA.

In June 6, 2025 I decided provisional adoption of the said proposal because there was no nay. And in June 11, 2025 he proposed to insert the rule in ELFO Charter, Article 6 as follows:

Article 6 (Principal organs) 1 There are established as the principal organs of the present Organization: President, a General Assembly, a Heads of State Council; a Solidarity Council, a Religion and Ethics Council; a Deputies Council; a Council of Peace, a Council of Friendship, a Council of a Judicial Affairs, a Council of Territories and Boundaries, an Economic Social Council, an a Finance and Industry Council, a Human Rights Defense Council, a Council for Employment and Labor, a Council of Welfare and Medicine, a Council for Humanitarian Aid, a Council of Communication and Transport, a Council for Conservation of Resources, an Educational, Scientific and Cultural Council, a News and Information Council, a Council of Tourism and Accommodations, a Council of Sports, a Youth Council, other Councils, Earth-Loving Amicable Court and a Secretariat.

Here you notice that a Council of Tourism and Accommodations is one of the many principal organs, but I am sure that the Council will play considerable role especially at the first stage of development of the FOCEF

2 Under each Council there will be established its department, door of which is open wide for those members interested in the field.

3 Under the General Assembly will be set up each national general headquarter, local headquarters, regional branches of amicable character.

4. *Under the General Assembly will be set up 3 VIPs Meeting which is composed, in principle, ELFO Hon. President, ELFO President, and ELFO General Assembly (GA) Chair, and which are competent to make provisional rule to be recognized at summary of that GA.*

I decided provisional adoption of the above additional rule on 3VIPs Meeting as there was no nay.

17. Budget of 2025

There are only a few of members, so we must study the best method of collecting it. Incomes of the ELFO are almost from Hon. President's donation. We must improve such situation.

18. Relations between membership fee and investment

In MAR 19, 2025 **I decided** adoption the following Mr. Rikio's proposal as there was no nay:

- that if a member loans in other members' project, his or her membership fee will be mitigated,
- that if a member-loaner loans more than 1,000 US\$ for another member's project, his or her annual membership fee will be immune for 20 years,
- that if a member-loaner loans more than 500 US\$ for another member's project, his or her membership fee will be immune for 10 years,
- that if a member-loaner loans more than 250 US\$ for another member's project, his or her membership fee will be immune for 5 years. and
- that if a member-loaner loans more than 100 US\$ for another member's project, his or her membership fee will be immune for 3 years.

23. Maintaining technical, cultural and scientific exchanges with other associations (*and similar entities, both national and foreign, and may participate in or promote joint activities.*)

20. Entering into agreements with any institutions to better achieve their purposes (*as well as to raise funds, with universities, colleges, foundations, private and public institutions, as well as other similar entities*).

24. Promoting national and international campaigns to raise awareness in society regarding the appropriate use of the Internet (*aiming at the protection of children and adolescents and the effective protection of Human Rights in the Information Society.*)

25. Edition and publishing of magazines, books, bulletins, booklets, (*promotional material, in addition to producing reports and technical notes with the aim of guiding public policies to combat and the actions of police authorities*)

26. Creation of Earth-Loving Chorus Organization (ELCO)

Hear from ELCO Earth-loving songs, making all minds feel better Planet,
Love and beauty uniting nations East, West, North and South all.

Besides the above shown song Hon. Pres. Rikio wrote many songs concerning ELFO FAMILY, which were recognised as ELFO songs.

Today (APR 22, 2025) I decided that Imagine by John Lennon is a song recommended by our ELFO FAMILY.
