Dear ELFO Pres. Rikio Kaneko, ELFO members and ICO fraternity, salutations

[July 07, 2022] with ELFO Pres. Rikio Kaneko's comment

I would like to request in addition to other members' views that time is of incense. We need to work out at least a tentative time frame as to when the PAD which I am part of will be traveling for mediation. This will also depend on whether our delegation has been accepted by the two Countries. I would like to inquire whether or not Ukraine and Russia have been contacted to set this Amity proposal in motion!

It seems to me that it is too early to inquire of belligerents about their readiness to receive our PAD (Peace and Amity Delegation) due to many unstable and ambiguous elements. Even Head of the PAD says no word of the date of departure and essential matters are neither studied nor agreed.

Let me also use this opportunity to encourage more members to make plans to join the delegation because it is very important. (Reddened by Rikio.K.)

I have seen the draft Peace agreement but we cannot afford to go with a preconceived mind into mediation. The trend the discussion will take will automatically inform the content of the agreement but to start with we need to spell the most crucial need to pave way for subsequent engagements with the two countries and this is the need for immediate cease fire.

Dear Amb. Kisembo, I suppose you mention Mr. Alain's draft agreement. I agree, in principle, to your opinion, but to try to prepare ex aequo et bono a draft peace treaty has also its own meaning because neither Russia nor Ukraine is able to show an equitable draft treaty. (We will not show the draft treaty to belligerents.)

I have said it before and I will say it again, **NATO countries need to back off this war to allow a cease fire.** (*Reddened by Rikio.K.*) The terms for a cease fire must be agreed upon by the two Countries which I believe the NATO question is part. Let us not speculate at this time how the mediation will look like but rather bring the two parties together to talk to each other, we are only facilitators, the war belongs to them. A peace agreement at this time will be an abortion of the process.

If Russia also back off this war, this will make cease-fire more probable. It's very important to consider cease-fire and restoration of peace from this view point. To ask only NATO and Ukraine to back off war and not to ask Russia to compromise equitably is not equal and right. Will you comment in this respect?

We should not wait for both Countries to invite us, for instance if Ukraine is willing to talk to us, let us invite them in a neutral Country such as India or China. Once we have had their concerns we can contact the other Country and invite them for their responses to the claims made against them. Then we can cause both parties to come together after we have studied their grievances from their own point of view for a solution to be reached. This is going to be a process and we must prepare knowing that it is not going to be a one off visit but a process.

This is one of choices which it may be realized with necessary qualification (correction). For example, when Pres. Zelensky visits India by invitation of Indian Government or an university, it is possible for Dr. Leo Rebello or DAD members will meet him.

In addition to our individual contributions we are willing to make, I request that a fund be constituted to manage this very important process. This cannot be left to a few of us willing to take the risk and sacrifice finances but ELFO should look at it as an activity the organization is ready and is going to focus on including meeting some costs because it is going to be very hectic and expansive. Having said that, I am personally committed to this cause, however we must prepare adequately so that we don't give up along the way.

At present time all the ELFO members must know that ELFO FAMILY is extremely very very poor baby Organization: in its bankbook, there is no money.

Wish to meet Pres. Putin regarding war and peace

The Honorable and President of ELFO Professor Rikio Kaneko. Salutations.

I am writing to seek your indulgence on a very sensitive matter concerning the ongoing Russia's war on Ukraine. First and foremost let me take this opportunity to appreciate you personally and the ELFO family for the steps taken so far and still being taken to voice out the message of peace.

I understand that Peace and reconciliation is a process and takes more than one approach to get it done. Being a Peace Ambassador at large and a Chief of the Solidarity Council of ELFO. I have thought it imperative to have a face to face meeting with President Vladimir Putin in Moscow.

I hereby humbly request you my ELFO President to use your powers and great connections and secure for me an appointment with Mr. Vladimir Putin at his earliest convenience. I will finance my own air ticket, accommodation and feeding if this trip is approved and secured by you Sir.

If given the opportunity to meet Mr. Vladimir Putin I would like to suggest the following to him on behalf of ELFO;

1. A ceasefire. I would like to point to Mr. Putin the fact that war cannot end if the parties involved don't show the willingness to speak to each other. But that can only be possible if peace is given a chance. To that effect I will ask Mr. Putin to agree to a cease fire such that we can push for amicable talks on the issues precipitating this war.

2. I would like to suggest to Mr. Putin that the civilians who have been caught amidst this war and don't have anywhere to go need a safe passage to a safe zone as the parties forge a head a way forward. For instance the people besieged in Mariupol need to be rescued before they perish.

Honorable Professor, one may wonder why I have chosen to speak to Mr. Putin face to face. I do not undermine what the world leaders are doing to bring the situation of war in Ukraine to an end. However, I believe that Mr. Putin in his own wisdom does not need the so called great nations of the world to lecture him on a Peace process because they are not neutral. Organizations like the ELFO which is not controlled by America as is the case with the United Nations should take a stand and be counted. Mr. Putin will listen to a neutral body and it is the ELFO that should carry this mantle. I hereby therefore offer myself to this cause.

I know that you believe as I believe that this war can be brought to an end if we cooperate and try to understand both parties without pointing fingers leaving a lone condemning.

My Statement on the Russo-Ukrainian War

The War in Ukraine has been complicated by international bodies who have got interest in this war. Truth be told, if we don't stand up for reality, we might be losing a point each day. Serious measures must be taken before we can see a full scale destruction in Ukraine.

We cannot talk peace while NATO Countries and the United States keep supplying weapons to Ukraine just to complicate the peace process. If NATO and the United States are not acting hypocritically towards the people of Ukraine, they should have by this time sent their Sons and daughters on the front line.

Why are they not doing this? In the end the war is used as a means for other nations to trade their weapons even though it is perceived as aid. The Country in question must pay in the long run. We have seen this enough in Africa over decades where war turns into an enterprise for other countries.

My humble submission is that:

1. Ukraine cannot talk peace with Russia while Mr. Zelensky is seeking for more military aid from foreign countries. This alone is a sign of resentment and readiness to fight and whoever is aiding Ukraine militarily is not for peace.

2. Ukraine should abandon fighting and surrender before mass extinction of Ukrainian people. It will be a shame for them to surrender after losing everything yet there's still more to redeem right now.

3. The Ukrainian commanders should take an initiative to speak to the Russian commanders on the field of battle and express their willingness to abandon fighting, the war will end if no one is shooting at each other.

4. The war policy in Moscow may not end now because Mr. Putin is not ready to loose in the public eye but the war on the front line can end if soldiers from either sides cooperate. It is them who are fighting and it is them who are dying, not their Presidents. None of Mr. Putin's children has died in this senseless war.

Where Diplomatic negotiation has failed to prevent Russian invasion to Ukraine, and now Russian armed forces seem to be superior overwhelmingly to Ukrainian forces there, I propose the following remedy of strategic approaches;

1. I appeal that in particular actions by the UN Security Council, its Secretary General, and of the UN Member-States are needed mainly in economic sector because international military reactions, especially war within Ukraine, is very dangerous from the first stage.

2. ELFO (Earth-Loving Friendly Organization) must constitute a team of Diplomats who will be tasked with a duty to talk with Countries that have diplomatic relations with Russia and Ukraine for the purpose of

- a) settling the present conflict peacefully and
- b) creating situation where Russian troops may evacuate from Ukraine.
- c) A team of Neutral Heads of State should be formed also for the aforementioned 2 purposes.

3. World leaders must not give up on peaceful means of solving conflicts as this effort is the only way to minimize collateral damage of property and loss of lives. Severance of diplomatic relations should be avoided by all means.

4. I suggest that ELFO should form an Emergency Response Team (ERT) which will be tasked with mobilizing Countries, the Civil Society and individual Companies and person to donate for war victims.

5. All NATO members including their partners should not send troops to Ukraine or backup this war militarily. If they do so, Russia will not relent and more lives will be lost. If Ukraine compromises in accordance with reason and principle of people's lives, this conflict is as good as over. But if Ukraine also choose the Military response, then the world must prepare for an economic disaster, fierce than what Covid 19 just unleashed.
