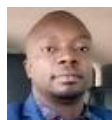

You know, currently there are several national ELFA (Earth-Loving Friendly Association). namely, **Mexican (MELFA)**, **Fijian (FELFA)**, **Nepali (NELFA)**, **Indian (IELFA)**, **Japanese (JELFA)**, **Brazilian (BELFA)**. Fortunately several candidates for President of national ELFA appeared.

Regarding election of Presidents I, Hon. Pres. Rikio Kaneko asked the GA to adopt, among others, my following proposal as these candidates had been already introduced for some weeks by messages and in web site to ELFO members. He proposed 5 points, which the GA adopted:

1. **Strengthening GA's competence.** Existing rule on GA's competence is simple: Rules on Presidents and their concerning staffs, Article 37 stipulates that "**GA's decision is prior to CEAC's.**" (Central Election Administration Committee) (<http://mopw.org/rules%20on%20presidents%20230204.pdf>) And I proposed a clause to be added to the said rule. So that Article 37 will be as follows:

Article 37. GA's decision is prior to CEAC's. The GA may conduct election of President of national Earth-Loving Friendly Association without organizing CEAC, provided that ELFO GA shall respect, first of all, wish of a given national ELFA's wish.

2. **Liberia.** Election will be conducted in Liberia with 2 candidates Mr. [Hilary B. Davies](#) and Mr. [Samson Sehgren](#). (See later material)
3. Ex. Amb. [Saula Sovanivalu](#) from Fiji; [Amb Emmanuel Lavalie](#) from [Sierra Leone](#); [Amb. BUGINGO Annanie](#) from [Rwanda](#); [Amb. Bachir NIANG SO](#) from [Central Africa](#) will be President of their national ELFA if a rival candidate does not appear by **[March 25, 2023](#)**.
4. This time election will be conducted in accordance with aforesaid Article 37, and the GA Chair will be responsible for administration of all the election above-mentioned.

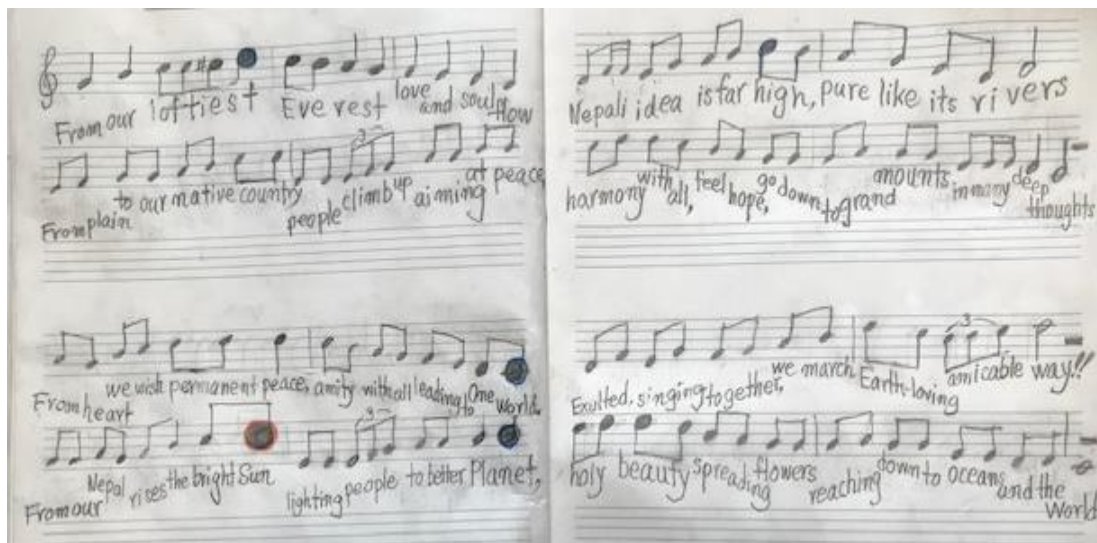

4. Additions to Rules on One Judge Territorial Arbitration Court

I propose to the 11th GA to adopt additional phrases (**rosy**) in order to make up the aforementioned Rules better and exacter.

The Rules of One Judge Territorial Amicable Court

On **20th** day of February, 2023 year General Assembly of our Earth-Loving Friendly Organization (hereinafter referred to as ELFO),

Attaching importance to establishing Earth community ruled by law,

Considering that there were some territorial cases which only one Judge decided,

Cooperating with our friendly International Conciliation Organization (hereinafter referred to as ICO)

Decided to adopt the following system of One Judge Territorial Amicable Court (hereinafter referred to as OJTAC **or Court**)

Article 1. The OJTAC uses the Internet as much as possible, and shall contribute to development of digital lawsuit.

Article 2. The Judge (named also President) and Registrar shall be recognized by the ELFO General Assembly (GA), and when engaged on the business of the Court, shall enjoy diplomatic privileges and immunities in contesting States.

Article 3. The seat of the Court shall be established at a place where President resides. This, however, shall not prevent the Court from sitting and exercising its functions elsewhere whenever the Court considers it desirable.

Article 4. The Court will consider

- a. Treaty
- b. Governmental agreements between conflicting parties
- c. international custom, as evidence of a general practice accepted as law;
- d. judicial decisions and the teachings of the most highly qualified publicists of the various nations, as subsidiary means for the determination of rules of law.

2. This provision shall not prejudice the power of the Court to decide a case *ex aequo et bono*

Article 5. The official languages of the Court shall be English.

Article 6. Cases are brought before the Court by the notification of the special agreement (compromise) to the President of the Court. In the case the subject of the dispute and the parties shall be indicated.

Article 7. The Court shall have the power to indicate, if it considers that circumstances so require, any provisional measures which ought to be taken to preserve the respective rights of either party.

Article 8. The procedure shall consist of two parts: written and oral, provided that oral procedure shall be conducted by video.

Article 9. The hearing in Court shall be public on the Internet, unless the parties demand that the public be not admitted.

Article 10. Whenever one of the parties does not appear before the Court, or fails to defend its case, the other party may call upon the Court to decide in favor of its claim.

Article 11. The judgment shall state the reasons on which it is based.

Article 12. President's 1st draft award shall be sent to ICO Consulting Commission and to ELFO Commission of International Law for hearing **their** opinions, provided that a national of contesting parties shall not be a member of these 2 Commissions.

Article 13. President shall continue considering qualification of the draft award so long as more than one fifth (1/5) members of the aforementioned 2 Commissions are against it.

Article 14. President's qualified draft award shall be submitted to both ELFO General Assembly (GA) and ICO GA for hearing their opinions, provided that a national of contesting parties shall not be a member of these GAs.

Article 15. Considering opinions of these 2 GAs, President of the Court shall send the final award to the contesting States.

Article 16. The judgment is final and without appeal. In the event of dispute as to the meaning or scope of the judgment, the Court shall construe it upon the request of any party.

Article 17. **Judicial costs depend upon an agreement among the President and parties to the dispute, provided that** unless otherwise decided by the Court, each contesting party shall bear its own costs. **The OJTAC shall be based on the self-supporting system, so the ELFO will not be financially responsible for the OJTAC.**

2. Contesting States shall pay remuneration to their Registrars respectively.

Article 18. A jurist of international law or President of the Court may be a Registrar of the Court. Both Contesting States may appoint a Deputy-Registrar from among her public service personnel.

Article 19. A Deputy-Registrar may be removed from office if, in President's opinion, the incumbent has either become permanently incapacitated from exercising his or her functions, or has committed a breach of duty.

Article 20. The Court may give an advisory opinion on any territorial legal question at the request of contesting States. In the exercise of its advisory functions the Court shall further be guided by the provisions of the present Rules with necessary qualifications.

My Former Messages

1. Rules on Hon. Pres., Pres., Acting Pres., Vice-Pres. etc. Adopted But further elaboration is necessary 会長規則さらなる明確化必要

Currently our ELFO Family has 2 international Organizations, namely: the ELFO and the ICO (International Conciliation Organization) and 6 national ELFAs (Earth-Loving Friendly Association).

The ELFO adopted a new system of PRESIDENT of 3 HEADS, but these 3 HEADs (1st Pres., 2nd Pres., and 3rd Pres.) are not accustomed to the new system, so its movement is very slow as a tortoise. They sent you only an inaugural greeting, so I am obliged to do many things for them. Sooner or later they will move faster.

One of the causes is that their functions are not clearly stipulated. So this time I and GA Chair Karpekina present jointly clauses to be added to the existing Rules on Presidents.

The old Rules on these leaders was simple ones having only 17 Article.(Click here [Rules on Pres.](#)). And GA Chair decided in [JAN 6, 2023](#) the adoption of the new Rules. But our experiences tell you that more elaboration is far better than the present Rules, so that I and GA Irina Karpekina propose jointly to the GA the following additional phrases (*Rosy italic*) to the 2nd Rules. *Italic King's blue* is my comment, and *blue sentences* are her comment.

Rules on Presidents and their concerning staffs

Considering that in our ELFO FAMIY there are already many kinds of Presidents, and that in future there will appear more and more Presidents in our FAMILY, now it is necessary to elaborate rules concerning Hon. President, Presidents, Acting Presidents, Vice-Presidents, Advisors, Consultants, Assistants, Chairperson of the General Assembly, and Election Administration Committee etc.

In December 25, 2022 the General Assembly (GA) of the Earth-Loving Friendly Organization (ELFO) and the GA of the International Conciliation Organization (ICO) adopted unanimously the “Rules on Presidents in ELFO FAMILY” as is seen in the URL: <http://mopw.org/rules%20on%20pres..pdf>

Present Rules on Presidents and their concerning staffs are results of our wishes to develop the ELFO FAMILY more friendly, harmoniously and effectively **without bureaucratic color** by dividing many complex functions among competent collaborators willing actually to contribute to making our **FAMILY** and Planet better.

Chapter 1. General Rules

Article 1. At any time and in any place any ELFO member may suggest one’s idea to develop ELFO FAMILY for promoting friendship and peace among nations, and may announce one’s willingness to be ELFO President, Acting President, a Vice-President, or other important staff.

As of JAN 10, 2023 there appeared already 2 members ready to be a candidate for the 1st President when next election will be conducted. I suppose sooner or later they will declare their candidacy.

Article 2. Present Rules may be applied, with necessary qualifications, to status of important staffs of ELFO FAMILY: namely, the ICO (International Conciliation Organization), and many national ELFA (Earth-Loving Friendly Associations) etc.

Chapter 2. Hon. President of the ELFO

Article 3. President, who was recognized by the ELFO GA as having rendered great contribution to the development of the ELFO FAMILY, may be Hon. President of the ELFO.

Article 4. There may be 2 kinds of Hon. President. The 1st category of the Hon. President may continue to have its former competence to act when incumbent President or other staffs cannot realize one’s functions as is expected, while the 2nd category of Hon. President has not, in principle, such rights and any duties.

Former ELFO Pres. Rikio Kaneko is to be recognized as the 1st category of ELFO Hon. President because he stated he would be so without any member’s objection, and his contribution

to our ELFO was very great and actually he is Representative of overwhelming majority of ELFO FAMILY members. (Irina K.)

Please pay due attention to the aforementioned important rule which reads as follows: “The 1st category of the Hon. President may continue to have its former competence to act when incumbent President or other staffs cannot realize one’s functions as is expected”. Present situation seems to be at such stage. Communication between new Presidents is rare due to inconvenience of the 1st President’s very restrictive channel.

Article 5. Hon. Presidents and other members may suggest the post (status) of a new member whom they invite to join the ELFO FAMILY, provided that President will appoint him or her later officially. In case of absence of the official appointment, the new member shall be regarded as having the post suggested by the inviters.

Such procedure will lighten the Presidents’ burden considerably. Daily I, Hon. Pres. Rikio, and Irina Karpekina is succeeding in inviting Diplomats or personalities to join the ELFO with suggesting their position. See, for example:

P.S. Here is my "Present" to you for Happy New Year!! Please see an attachment at pp. 5~8. There are many vacant seats where a suitable member may sit. I am very glad if you are willing to receive my "Present" of seat of Consultant for 3rd President Ajay Singh from India. He will appoint you officially. I am looking forward to your prompt reply.

Article 6. Hon. Presidents of both categories may continue to have right of vote provided for in ELFO Charter, Article 8. Hon. Presidents are regarded as a member of the ELFO FAMILY even after their retirement without membership fee.

The Article 8 reads: So long as a member does not express yes or no, his or her Representative shall be regarded a mandatory, and his or her yes or no shall also regarded as the same with that of Representative.

Article 7. Hon. President of both categories may, rather are expected to, invite many VIPs, Dignities, Diplomats and other personalities to join our ELFO FAMILY, and remuneration will be paid to them alike as to other members **in accordance with rules**.

Chapter 3. Presidents and Vice-Presidents of the central ELFO

Article 8. Incumbent President and Vice-President will continue to remain as present position so long as new President and Vice-President do not appear and, even if they are elected, are not recognized by incumbent President by Certificate.

Though 3 new Presidents were elected, I (Rikio Kaneko) had not yet sent them a Certificate to that effect, so officially they were not President. Soon I sent it to them. (For example [Click here](#))

Article 9. If only one member recommends oneself as a candidate for President or Vice-President, presents an oath that he will actually perform one's roles expected by our ELFO FAMILY, and join an open forum conducted by ELFO President, they will be regarded as having won the election. In the open forum former President, Hon. President and other members may participate.

Dr. Leo Rebello and BELFA Pres. Edmario Peixinho recommended themselves as a candidate for the IELFA and the BELFA, but there was not an open forum. What shall we do?

Article 10. If no member stands as a candidate for the vacant seats, 2nd prolonged election will be conducted in 14 days after the scheduled 1st election.

Article 11. In 2nd prolonged election any suitable member may be candidate for them, declaring oath that he will actually perform his roles expected by our ELFO FAMILY. In the open forum former President, Hon. President and other members may participate.

Article 12. Plural members may declare one's candidacy for Presidents or Vice-Presidents, provided that they will announce their political opinion and join an open forum conducted by ELFO President. Such a candidate may be regarded as elected automatically if there does not appear an opponent candidate.

Article 13. Under system of PRESIDENT of 3 HEADS, 2nd and 3rd Presidents have rights of appointment of their Acting Presidents, Advisors, Consultants and Assistants, and staffs of their subsidiary organs. All the other staffs shall be appointed by 1st President, **with reservation of Article 5.**

Chapter 4. Presidents' Functions under PRESIDENT of 3 HEADS

Article 14. The 3 Presidents shall respect the following rules:

- a. They shall pay attention to friendly cooperation and harmonious division of works among them under 1st President's leadership, if it is impossible, under 2nd President's leadership;
- b. They **shall** keep good communication among them, and if any of them cannot answer the other President, his or her Acting President or an assistant shall answer provisionally; and
- c. President may, in his or her own judgement, may announce President's Declaration or Statement, while both the 2nd President and the 3rd President may, with President's **or GA's** approval, make a Declaration in its name.

ELFO Charter, Article 22 stipulates that "President may, in his or her own judgement, may announce President's Declaration, while each Head of the primary organs may, with President's approval, make a declaration in its name." In the aforementioned paragraph (c) you notice 'or GA's' which allows the 2nd and the 3rd President to propose to the GA adoption of their Declaration if the 1st President did not agree to it.

Article 15. The 1st President under system of PRESIDENT of 3 HEADS may have such general functions as provided for in the ELFO Charter, provided that the 2nd and the 3rd Presidents have the functions laid down in Article 16 and Article 17 respectively.

One of the standard dividing 2nd President's and 3rd President's functions is necessity of external correspondence and unnecessariness of external correspondence. The former matters belong to functions of 2nd President, while the latter matters belong to the 3rd President.

Article 16. 2nd President has, among others, the following functions:

- a. to invite many kinds of persons to join our ELFO FAMILY, namely; a State, a present and former Head of State, a present and former Diplomat, an Autonomy (Self-Governing Community), an domestic and international Organization, and many kinds of natural persons;
- b. to introduce a proposal (a bill) to the GA (General Assembly) after approval with the 1st President, provided that a proposal not accompanied with financial outcome may be introduced straight to the GA.
- c. to make up one year's plan to be introduced in the GA, calling for cooperation with ELFO FAMILY, provided that the 2nd President shall make up in advance its contents as clear as possible.
- d. to be present in Interstate Department, Solidarity Department, Territorial and Boundary Department, and in other Department when they deliberate very important matters.

Article 17. 3rd President has, among others, the following functions:

- a. to keep and develop horizontal good communication among members, using emails, Zoom, Skype, Whatsapp, Twitter, making MM (Mail Magazine), conducting ZAP (Zoom Amicable Party) etc.;
- b. to create and develop national ELFA (Earth-Loving Friendly Association), helping them at the first stage by presiding 1st meeting or GA;
- c. to call for promotion of activities and development of the Principal organs of the ELFO, at the same time, hearing their wishes;
- d. to make up one year's plan, calling for cooperation with ELFO FAMILY, provided that the 3rd President shall make up in advance its contents as clear as possible;
- e. to be present in Principle organs of the ELFO when the 3rd President thinks it is good for both sides.

Chapter 5. Acting President

Article 18. Considering that almost all the Leaders of ELFO MAMILY are extremely busy with their personal affairs and social activities, each President of **our ELFO FAMILY**, besides **that of court of justice**, shall have an Acting President.

It implies that each President of national ELFA shall have his or her Acting President.

Article 19. When President does not keep good communication with ELFO members, Acting President may send info, talk with, them by one's judgement.

Article 20. Acting President may present one's ideas to ELFO members in President name with his or her consent as well as in one's own name.

Article 21. Acting President may appoint ELFO members as Vice-Presidents, Advisors, Consultants, and Assistants who are to be under one's President so long as the latter does not appoint them. *(See vacant posts in attachment at pp. 2~5)*

Article 22. Acting President may promote many kinds of events in President's name with his or her consent as well as in Acting President's own name.

Article 23. When the GA judges that present Acting President's inauguration as President is far better than a given existing presidency, the Acting President may inaugurate as President immediately without Certificate provided for in Article 8.

Under Construction

Chapter 6. Advisors, Consultant, and Assistant

Article 23. An Advisor has a right to recommend some steps to President even if the latter does not ask the first to do so. President appoints an Advisor Section Head and its staffs.

Article 24. A Consultant has not such right as an Advisor has, and recommend some steps to President if the latter asks the firster to do so. President appoints a Consultant Section Head and its staffs.

Article 25. While having free time, an assistant will help President perform routine functions. President appoints an Assistant Section Head and its staffs.

Chapter 7. Chairperson of the General Assembly of the ELFA

Article 26. Chairperson may receive any member's proposal on agenda item, and in his or her judgement may decide the priority of deliberation, provided that ELFO 1st President has priority in choosing the order of agenda items, shall propose the order if any. When the 1st President wishes to withdraw a matter from deliberation, he shall explain the situation about it.

Article 27. The 1st category of Hon. President has the 2nd priority after the 1st President, provided that if the latter has not presented a concurrent agenda items, the former's proposal goes automatically.

Such simplified procedure will accelerate deliberation and early adoption of decisions. If we set up bureaucratic documental restrictions, we will loose many time in vain. See reality, now I am writing the present Draft "Rules on Presidents and their concerning staffs" without consulting the 1st President. If I asked him to review my draft, and if he did not answer me for a long time, what would happen? Rule-making process would be as if it were such very slow movement of that of earthworm.

Article 28. Only the 1st category of Hon.President and 1st President may send their draft agenda items directly to the concerned members, not through the Chairperson, or may send it firstly to the Chairperson.

You know already such an example: I'll not send specially present Draft Rules only to GA Chair Chair Irina Karpekina, but straight to all of ELFO members including her, asking her as follow:

Dear GA Chair Irina Karpekina, I ask you to decide adoption of my proposal at 20: 00 of JAN 2023 if there is no objection to it.

Article 29. Period of deliberation may be restricted, in principle, to 2 days if there is no objection to it, or if there are only some members who are against it.

Article 30. When overwhelming majority vote “Yes”, it is not necessary for a Chairperson to announce the number of “Yes” votes.

Almost every day a new face join our central ELFO or national local ELFA (Earth-Loving Friendly Association). It is actually impossible to ascertain exact number of our members at the time of adoption of a given decision.

Article 31. The minutes of each General Assembly shall be certified by the 1st President, provided that the latter may not certify each decision on each agenda of the former.

If we taked beaurocratic step that each decision on agenda item shall be certified at the time of its doption, rule-making process would very slow as an earthwor.

Chapter 8. Election Administration Commission

Article 32. Election may be conducted by Interntet, Fax, email etc.

Article 33. A Central Election Administration Committee (CEAC) may be composed of 2 members which shall be recognized by the GA. A National Election Administration Committee (NEAC) also may be composed of 2 members which shall be recognized by the GA of its NELFA.

Article 34. President of a national ELFA may ask the Central Election Administration Committee (CEAC) to administer its national election without its national as a member of the CEAC, or may ask to add his or her national to the CEAC.

This rule reflects present week solidarity among members of NELFAs. Some of NELFAs have not organizational force even to creat one's national EAC.

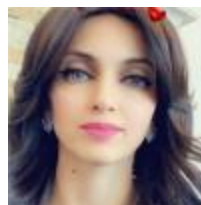
Article 35. When an elected person's winning is perfectly clear, it is not necessary for the CEAC or NEAC to totalize all the votes in accordance with the category of votes.

For example, when only a few was against a candidate, while overwhelming members voted for the candidate.

Dear African Dignities and Personalities concerned

I am Hon. Prof. President of the ICO (International Conciliation Organization), Hon. Pres. of the ELFO (Earth-Loving Friendly Organization). Dr. Ms. Tamara Alqolaghassi is Chief of Finance and Industry Council of the ELFO.

I have honor to send my greeting to your Excellency, and to wish you together with us to call for ceasefire and restoration of peace between Russia and Ukraine.

As is seen in the URL <http://mopw.org/pr.%20n233-con-3rd%20prop..pdf> our ICO have sent to Russian Pres. V. Putin and Ukrainian Pres. V. Zelensky our Proposal on conciliation 3 times with qualification.

Now our ICO General Assembly adopted the 4th Proposal in the form of our "WISH" to belligerents. I am very pleased if your Excellency are ready to address our 4th Proposal "WISH" together with us to Russian and Ukrainian Tops. The 4th Proposal on conciliation WISH will be as follows with African situation considered.

International Conciliation Organization and Africans Wish Ceasefire and Restoration of Peace

1. We the ELFO (Earth-Loving Friendly Organization), the ICO (International Conciliation Organization), *the undermentioned Africans and others* welcome Russian initiative of unilateral declaration of temporal truce of 36 hours because it is a positive step toward total ceasefire and restoration of peace.

2. We wish that *in future* Ukrainians also take a rest calmly by their top leader's declaration of truce even if it is 12 hours ceasefire, and even if it is not negotiation, but unilateral initiative. There is no doubt that even an unilateral truce and much more a bilateral ceasefire become blessed bliss for especially soldiers and their mothers because they can enjoy temporal peace with far more stressless feeling.

3. Even if Russian step is unilateral truce of 36 hours, it is the very first step which may lead to bilateral truce and finally to general ceasefire and restoration of peace. People around world, therefore, can see a Light and a Hope, which make their heart less stressful. So that we ~~the ELFO and ICO~~ wish that Russian and Ukrainian belligerents enter the 2nd stage for promoting truce and promoting ceasefire and restoration of peace. We wish that they consider our following Proposal:

a. When in future one of the belligerents declares an unilateral truce, the other belligerent complies with, and respect, it, stopping battle, not firing.

b. When it is impossible for one of them to respect the aforementioned clause, that belligerent makes an effort to make truce at least one third of the period which the other belligerent proposed.

c. We wish that belligerents pay the utmost attention to the fact that overwhelming majority around the world aspire after peace, not war; and that the current Russo-Ukrainian War is not a simple restrictive relations only between the belligerents, but it is one of the 2 greatest causes of contemporary world-wide serious distress: coronavirus and Russo-Ukrainian War are flying on our precious Earth hand in hand closely, influencing very bad huge impacts upon all human beings, *especially upon Africans*.

d. Further we wish that both of belligerents understand more or less gigantic compromise is necessary for building peace and amity between belligerents. The ICO has already sent its concrete conciliatory Proposal and draft compromise. (See <http://mopw.org/pr.%20n233-con-3rd%20prop..pdf>)

2. Let's promote truce process!! 4th Proposal to Belligerents was adopted JAN 9th

I asked the GA (General Assembly) of both the ELFO and the ICO (International Conciliation Organization) to announce our below-mentioned WISHES regarding truce between Russia and Ukraine, to send them the WISHES, which the ELFO and the ICO adopted

1. We both the ELFO and the ICO welcome Russian initiative of unilateral declaration of temporal truce of 36 hours because it is a positive step toward total ceasefire and restoration of peace.

2. We wish that Ukrainians also take a rest calmly by their top leader's declaration of truce even if it is 12 hours ceasefire, and even if it is not negotiation, but unilateral initiative. There is no doubt that even an unilateral truce and much more a bilateral ceasefire become blessed bliss for especially soldiers and their mothers because they can enjoy temporal peace with far more stressless feeling.

3. Even if Russian step is unilateral truce of 36 hours, it is the very first step which may lead to bilateral truce and finally to general ceasefire and restoration of peace. People around world, therefore, can see a Light and a Hope, which make their heart less stressful. So that we the ELFO and ICO wish that Russian and Ukrainian belligerents enter the 2nd stage for promoting truce and promoting ceasefire and restoration of peace. We wish that they consider our following Proposal:

a. When in future one of the belligerents declares an unilateral truce, the other belligerent complies with, and respect, it, stopping battle, not firing.

b. When it is impossible for one of them to respect the aforementioned clause, that belligerent makes an effort to make truce at least one third of the period which the other belligerent proposed.

c. We wish that belligerents pay the utmost attention to the fact that overwhelming majority around the world aspire after peace, not war, and that the current Russo-Ukrainian War is not a simple restrictive relations only between the belligerents, but it is one of the 2 greatest causes of contemporary world-wide serious distress: coronavirus and Russo-Ukrainian War are flying on our precious Earth hand in hand closely, influencing very bad huge impacts upon all human beings.

d. Further we wish that both of belligerents understand more or less gigantic compromise is necessary for building peace and amity between belligerents. The ICO has already sent its concrete conciliatory Proposal and draft compromise. (See)

3. Important staffs for PRESIDENT of 3 HEADS!!

I suppose that new 3 Presidents will be very glad if a FAMILY member is ready to help them as an Acting President, a Vice-President, an Advisor Section Head, its Advisor, a Consultant Section Head, its Consultant, an Assistant Section Head or its Assistant!!

When I was former ELFO President, I created aforementioned Section, and appointed members as staffs with their consent as mentioned bellow. I wish new Presidents will appoint them finally.

I am writing to interest you on the subject of ELFO structures and Finance. We are such a big family with different departments of importance.*

Now we have an obligation to see that all Arms of ELFO start to function from Head to Bottom. This will give us good output in the process. The different Councils must not be on paper but we need to make sure they function including the different

Regional and National Associations within ELFO.

Here bellow are my suggestions:

3. The Finances of this organization must be defined. We cannot depend on membership fees as a sole means of financing the organization's activities. I had earlier pledged to release one of **my gold concessions** in the Eastern Province of Ituri in the Democratic Republic of Congo to be developed by ELFO, I still maintain this position.

1. What is our compus of ELFO FAMILY? 何が羅針盤?

It is undoubtful that compus for our ELFO FAMILY is, amontg others, Preable of the ELFO Charter, its Purposes, Principles, and other constitutional rules. Preamble of the ELFO Charter reads, among others, as follows:

recollecting that as history tells us, for a long time a human society has been of heterogeneous and separated character, constantly conflicting,

in the future, however, having respect for diversity on the Earth community, their culture and tradition, strengthening mutual understanding and solidarity among the nations,

attaching importance to friendly relations among nations and individual friendship derived from a simple fact that we are a human.

HAVE APPROVED THE PRESENT CHARTER TO ACCOMPLISH THESE IDEALS AND AIMS, BY COMBINING OUR EFFORTS, SURMOUNTING DISTINCTION AS TO RACE, NATIONALITY, RELIGION, PARTY, ETC.

DONE at the city of Sapporo the first day of January, two thousands twenty.

2. Rikio K. sends 3rd Proposal to Pres. Putin and Zelensky

In January 1st of Happy New Year 2023 the General Assembly of our International Conciliation Organization (ICO) adopted the below-mentioned conciliatory Proposal to Russian Pres. V. Putin and Ukrainian Pres. V. Zelensky. Today (JAN 4, 2023), I will send them these documents, contents of which are the same though here you see only a message to Pres. Putin which reads, among others, as follow:

*Dear Mr. Vladimir Putin
President of Russia*

I have honor to send to your Excellency my 3rd hearty greeting regarding our goodwill proposal of conciliation between Russia and Ukraine, concerning Russo-Ukrainian War.

I am President of the ICO (International Conciliation Organization) which was created in May 17, 2022 with the current war as a momentum. The ICO is composed mainly of Diplomats of MFA, PAAs (Peace and Amity Ambassador), which attaches great importance to natural friendship irrespective of many differences among people, races or nations.

Pleased at the creation of the ICO, nevertheless I am very sad to see that by war many many people died, were killed. As wartime goes by for the longer time, the more people will kill each other, having the more and more intense hatred, which may lead to the more horrible unprecedented catastrophe, world war III.

Now in order to contribute to making our Planet safer, more peaceful and friendly, our ICO decided to make utmost efforts to render good offices or mediation for your Excellency's Russia and Ukraine.

Dear Mr. Vladimir Putin, members of our ICO will be very pleased if your Excellency or authorities as well as Ukrainian side will participate in our conciliatory process, even if agreeing partly to our fair proposal.

Both belligerent parties can see ICO's original Proposal in an URL: <http://mopw.org/pr.%20n186-con:start.pdf> at pp.7~12. Here our ICO proposed on the following matters: Cease-fire; Ukraine will not join the NATO; Demilitarization; Non-use of a mass destruction weapon; Territorial problems; Food (wheat) problems; Non-attack against an atomic station; Non-attack of a church, a hospital, a school; Humanitarian corridor; Belligerent nationals' intercourse; Prisoners; Aid and reparation; The Armistice Commission; ICJ for settling legal problems.

And in January 1, 2023, the ICO General Assembly decided to add 2 points (rosy phrases) to the original text.

1st additional point concerns conciliatory procedure of territorial problems which reads as follows:

Point N.5

If belligerents were unwilling to submit to their territorial case to international conciliation, the United Nations may organize an UN Conciliation Commission with or without belligerent States as its member.

2nd addition concerns sum of aid to be sent to Ukraine after the end of war:

SHARE (ratio) of aid by each State for Ukraine will be proportionate with (a) her military expenditure or (b) the increased budget part of the past military expenditure which was caused by Russo-Ukrainian War. (a) is preferable.

The ICO wants to accelerate process of early conciliation. So that the first talk between a belligerent and the ICO will begin with Russian side or Ukrainian side, which will express their readiness earlier than the other.

We want to conduct the present conciliation, opening its process through the Internet in many universities and before all the people around the world for keeping fairness and transparency.

Our authentic common language is English.

We have Rules on Presidents in ELFO FAMILY. (See: <http://mopw.org/rules%20on%20pres..pdf>) But it is not enough to develop our huge FAMILY effectively and orderly. I propose, therefore, to the GA (General Assebbly) of the ELFO as well as the ICO to adopte the following my proposal at 20:00 of JAN 6, 2023 if there is no objection to it..

N.B. **Rosy phrases is today's additional rules.** and **king's blue sentences are my comment.**

Rules on Presidents and their concerning staffs

Considering that in our ELFO FAMIY there are already many kinds of Presidents, and that in future there will appear more and more Presidents in our FAMILY, now it is necessary to elaborate rules concerning Hon. President, Presidents, **Acting Presidents**, Vice-Presidents, **Advisors**, **Consultants**, **Assitants**, **Chairperson of the General Assembly**, and Election Administration Committee etc.

In December 25, 2022 the General Assembly (GA) of the Earth-Loving Friendly Organization (ELFO) and the GA of the International Conciliation Organization (ICO) adopted unanimously the “Rules on Presidents in ELFO FAMILY” as is seen in the URL: <http://mopw.org/rules%20on%20pres..pdf>

Present Rules on Presidents and their concerning staffs are results of our wishes to develop the ELFO FAMILY more friendly, harmoniously and effectively by dividing many complex functions among competent collaborators willing actually to contribute to making our Planet better.

Chapter 1. General Rules

Article 1. At any time and in any place any ELFO member may suggest one’s idea to develop ELFO FAMILY for promoting friendship and peace amomg nations, and may announce one’s willingness to be ELFO President, Acting President, a Vice-President, or other important staff.

Article 2. Present Rules may be applied, with necessary qualifications, to status of imoportant staffs of ELFO MAMILY: namely, the ICO (International Conciliation Organization), many national ELFA (Earth-Loving Friendly Associations) etc.

Chapter 2. Hon. President of the ELFO

Article 3. President, who was recognized by the ELFO GA as having rendered great contribution in the development of the ELFO FAMILY, may be Hon. President of the ELFO.

Article 4. There may be 2 kinds of Hon. President. The 1st category of the Hon. President may continue to have its former competence to act when incumbent President or other staffs cannot realize one’s functions as is expected, ~~In that sense the 1st category of the Hon. President has responsibility for developing the ELFO FAMILY~~, while the 2nd category of Hon. President has not, **in principle, such rights and any** duties.

The deletion of the above sentence is a result of consideration of lightning Hon. President's burden.

Article 5. Hon. Presidents of both categories may continue to have right of vote provided for in ELFO Charter, Article 8. Hon. Presidents are regarded as a member of the ELFO FAMILY even after their retirement without membership fee.

The Article 8 reads: So long as a member does not express yes or no, his or her Representative shall be regarded a mandatory, and his or her yes or no shall also be regarded as the same with that of Representative.

Article 6. Hon. President of both categories may, rather are expected to, invite many VIPs, Dignities, Diplomats and other personalities to join our ELFO FAMILY, and remuneration will be paid to them alike as to other members

Chapter 3. Presidents and Vice-Presidents of the central ELFO

Article 7. Incumbent President and Vice-President will continue to remain as present position so long as new President and Vice-President do not appear and, even if they are elected, are not recognized by incumbent President by Certificate.

Though 3 new Presidents were elected, I had not yet sent them a Certificate to that effect, so officially they were not President. Soon I sent it to them.

Article 8. If only one member recommends oneself as a candidate for President or Vice-President, presents an oath that he will actually perform one's roles expected by our ELFO FAMILY, and join an open forum conducted by ELFO President, they will be regarded as having won the election. In the open forum former President, Hon. President and other members may participate.

Article 9. If no member stands as a candidate for the vacant seats, 2nd prolonged election will be conducted in 7-14 days after the scheduled 1st election.

Article 10. In 2nd prolonged election any suitable member may be candidate for them, declaring oath that he will actually perform his roles expected by our ELFO FAMILY. In the open forum former President, Hon. President and other members may participate.

Article 11. Plural members may declare one's candidacy for Presidents or Vice-Presidents, provided that they will announce their political opinion and join an open forum conducted by ELFO President. Such a candidate may be regarded as elected automatically if there does not appear an opponent candidate.

Article 12. Under system of PRESIDENT of 3 HEADS, 2nd and 3rd Presidents have rights of appointment of their Acting Presidents, Advisors, Consultants and Assistants, and staffs of their subsidiary organs. All the other staffs shall be appointed by 1st President.

Chapter 4. Acting President

Article 13. Considering that all most all the Leaders of ELFO MAMILY are extremely busy with their personal affairs and social activities, each ELFO President shall have an Acting President.

Article 14. President does not keep good communication with ELFO members, Acting President may talk with them by one's judgement.

Article 15. Acting President may present one's ideas to ELFO members in President name with his or her consent as well as in one's own name.

Article 16. Acting President may appoint ELFO members as Vice-Presidents, Advisors, Consultants, and Assistants who are to be under one's President so long as the latter does not appoint them. *(See vacant posts in attachment at pp. 2~5)*

Article 17. Acting President may promote many kinds of events in ne's President's name with is or her consent as well as in Acting President's own name.

Chapter 5. Advisors, Consultant, and Assistant

Article 18. An Advisor has a right to recommend some steps to President even if the latter does not ask the first to do so. President appoints an Advisor Section Head and its staffs.

Article 19. A Consultant has not such right as an Advisor has, and recommend some steps to President if the latter asks the firster to do so. President appoints an Consultant Section Head and its staffs.

Article 20. While having s free time, an ssistant will help President perform routine functons. President appoints an Assistant Section Head and its staffs.

Chapter 6. Chairperson of the General Assembly of the ELFA

Article 21. Chairperson may receive any member's proposal on agenda item, and in his or her judgement may decide the priority of deliberation, provided that ELFO 1st President has priority in choosing the order of agenda items, shall propose the order if any. When the 1st President wishes to withdraw a matter from deliberation, he shall explain the situation about it.

Article 22. The 1st category of Hon.President has the 2nd priority after the 1st President, provided that if the latter has not presented a concurrent agenda items, the former's proposal goes automatically.

Such simplified procedure will accelerate deliberation and early adoption of decisions. If we set up beaurocratic documental restrictions, we will loose many time in vain. See reality, now I am writing the present Draft "Rules on Presidents and their concerning staffs" without consulting the 1st President. If I asked him to review my draft, and if he did not answer me for a long time, what would happen? Rule-making process would be as if it were such very slow movement of that of earthworm.

Article 23. Only the 1st category of Hon.President and 1st President may send their draft agenda items directly to the concerned members, not through the Chairperson, or may send it firstly to the Chairperson.

You know already such an example: I'll not send specialy present Draft Rules only to GA Chair Chair Irina Karpekina, but straight to all of ELFO members including her, asking her as follow:

Dear GA Chair Irina Karpekina, I ask you to decide adoption of my proposal at 20: 00 of JAN 2023 if there is no objection to it.

Article 24. Period of deliberation may be restricted, in principle, to 2 days if there is no objection to it, or if there are only some members who are against it.

Article 25. When overwhelming majority vote “Yes”, it is not necessary for a Chairperson to announce the number of “Yes” votes.

Almost every day a new face join our central ELFO or national local ELFA (Earth-Loving Friendly Association). It is actually impossible to ascertain exact number of our members at the time of adoption of a given decision.

Article 26. The minutes of each General Assembly shall be certified by the 1st President, provided that the latter may not certify each decision on each agenda of the former.

If we taked beaurocratic step that each decision on agenda item shall be certified at the time of its doption, rule-making process would very slow as an earthwor.

Chapter 4. Election Administration Commission

Article 27. Election may be conducted by Interntet, Fax, email etc.

Article 28. A Central Election Administration Committee (CEAC) may be composed of 2 members which shall be recognized by the GA. A National Election Administration Committee (NEAC) also may be composed of 2 members which shall be recognized by the GA of its NELFA.

Article 29. President of a national ELFA may ask the Central Election Administration Committee (CEAC) to administer its national election without its national as a member of the CEAC, or may ask to add his or her national to the CEAC.

This rule reflects present week solidarity among members of NELFAs. Some of NELFAs have not organizational force even to creat one’s national EAC.

Article 30. When an elected person’s winning is perfectly clear, it is not necessary for the CEAC or NEAC to totalize all the votes in accordance with the category of votes.

For example, when only a few was against a candidate, while overwhelming members voted for the candidate.

From my past messages

ELFO leaders are expected to act more autonomously!!

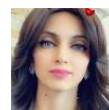

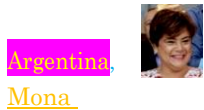

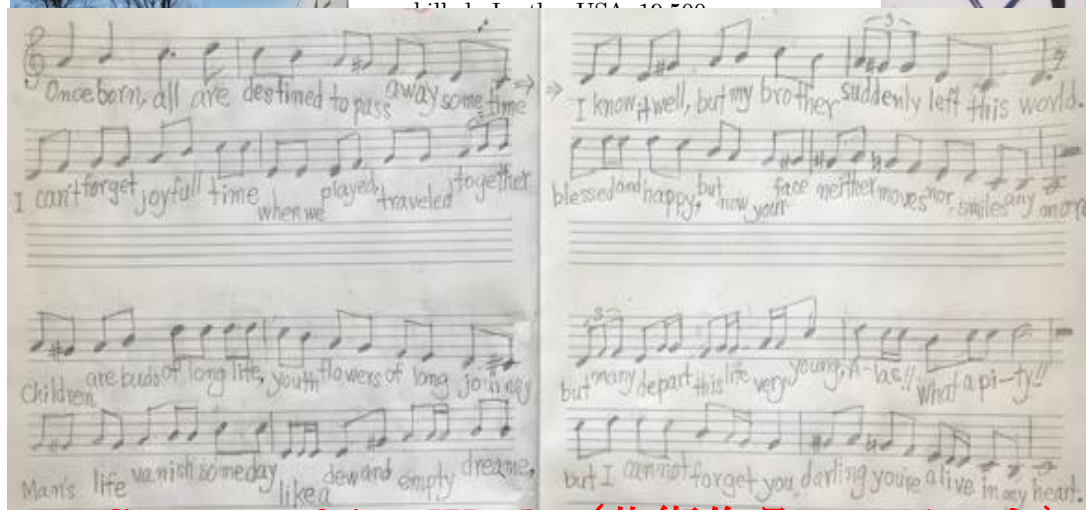
My former but important materials

At present you feel that there are sufficient info from central Sapporo, but rare other communication. It is extremely undesirable. ELFO Leaders must take initiative in our ELFO FAMILY's horizontal activities.

WIN-and-WIN good and fair relations 勝利と勝利の良き関係

In AUG 31, 2022 I proposed my idea on post war aid for Ukraine which reads as follows and adopted by the ICO GA:

1. **WIN-and-WIN relations. Aid and reparation will be rendered on basis of win-and-win relations, not a victor nation-and-a defeated nation.**
2. Almost all the States of the world should aid Ukraine until she restores her PPP to 50%; (<http://mopw.org/mem.fee.%20jan%202022.pdf>)
3. SHARE (ratio) of aid by each State for Ukraine will be proportionate with (a) her military expenditure or (b) the increased budget part of the past military expenditure which was caused by Russo-Ukrainian War.
4. On the basis of Win-and-Win spirit both Russia and Ukraine renounce mutually right to claim reparation for damages caused by war, provided that Russia shall also aid Ukraine in accordance with the preceding paragraph 3.
5. The State which went to default or the States whose PPP is less than 50% may be exempted from the aforesaid aid.



I am very very grateful to all the ICO members for understanding profound insight of my peaceful ideas for saving loss of countless lives and destruction. Regarding this proposal, ICO Secretary-General Irina Karpekina and a Secretary HOPE Watanabe agreed. Our member Ms. Joanna Korpo Ballah (pic.) sent me immediately her delightful message:

First of all General Armistice!! If it is impossible, Partial Truce!
まず第1に全面的停戦!! それが不可能なら部分的休戦を!!

At 20:00 of September 7, 2022, the ICO GA recognized the following addition (red sentences) to former proposal (black italics) which the GA had already adopted.

A. General Armistice

Considering incalculable precious value of life of human beings, to save succeeding generations from the scourge of war, and to evade terrible astronomical huge claim for reparation, we the ICO, expecting a possibility of adoption, by belligerents, of our ideas on stopping war immediately or in very near future, propose, first of all, holistic ceasefire as early as possible, and early commencement of negotiation for that purpose.

If only belligerents can agree to such General armistice, it is the best. But in case they cannot do so by themselves, our ICO proposes creation of an International Armistice Commission (IAC) as mentioned later (Paragraph 13).

B. Partial Armistice

Secondly, in case the belligerents cannot agree the aforesaid proposal, our ICO proposal is to realize ceasefire in such a time as the belligerents agree to:

1. while both of belligerents are negotiating, sitting face to face;
2. while both of belligerents are negotiating through online;
3. While our PAD is staying in Kyiv;
4. From 00:00~08:00 in the morning;
5. X-mas day from 00:00~24:00;
6. 1st~3rd of New Year;
7. Besides them the ICO welcome any agreement on cease-fire partly or wholly at any time and in any place.

N.B. Here "fire" means to launch a missile, to discharge a gun etc. and does not include preparation for battle.
