


In future in order to make our ICO more authoritative stronger international organization of character for all human beings, we will make efforts to invite many kinds persons to join our ICO, including present and former Heads of

Again we the ICO want both belligerent States and world people to pay great attention to ICO's fair and peaceful proposals bellow mentioned, and wish all of them to welcome Happy New Year.

I re-read our PROPOSAL to belligerent Russia and Ukraine, and I think it is not necessary to change our document addressed to the 2 Top Leaders. But I added 2 points: 1. Firstly, it concerns procedure of conciliation which reads as follows:

Point N.5

If belligerents were unwilling to submit to their territorial case to international conciliation, the United Nations may organize an UN Conciliation Commission with or without belligerent States as its member.

2. Secondly, regarding sum of aid to be sent to Ukraine after the end of war, I added the below rosy sentence:

SHARE (ratio) of aid by each State for Ukraine will be proportionate with (a) her military expenditure or (b) the increased budget part of the past military expenditure which was caused by Russo-Ukrainian War. (a) is preferable.

I will send our 3rd PROPOSAL to Russian and Ukrainian Top Leaders, and if you have any ideas, please feel free to send them to me.

As our ICO has not received an answer, I reported to its General Assembly (GA) about the absence of answer from both the Governments. And the GA recognized my following additional proposals, which contains more simplified procedure. So we the ICO wish, from the bottom of our heart, that both Russian and Ukrainian Governments send us their message even if it is also very simplified one.

My proposals, which the ICO GA recognized in October 29, 2022, reads as follow:

1. Matters to be talked with belligerents

If one or both belligerents are unwilling to touch a matter mentioned in 'Pres. Rikio's Message, N. 183' (pp.7~12), they don't have to speak about it. On the other hand, they can express their opinion or proposal on any matter other than those enumerated in the aforementioned Pres. Rikio's Message.

2. Net conciliation process

The first round of conciliation (pp.13~15 of the said Pres. Rikio's Message) may be rendered among Russian Party, Ukrainian Party and ICO President Rikio Kaneko very simply without Dialogists.

I have honor to send to your Excellency my 3rd hearty greeting regarding our goodwill proposal of conciliation between Russia and Ukraine, concerning Russo-Ukrainian War.

I am President of the ICO (International Conciliation Organization) which was created in May 17, 2022 with the current war as a momentum. The ICO is composed mainly of Diplomats of MFA, PAAs (Peace and Amity Ambassador), which attaches great importance to natural friendship irrespective of many differences among people, races or nations.

Pleased at the creation of the ICO, nevertheless I am very sad to see that by war many many people died, were killed. As wartime goes by for the longer time, the more people will kill each other, having the more and more intense hatred, which may lead to the more horrible unprecedented catastrophy, world war III.

Now in order to contribute to making our Planet safer, more peaceful and friendly, our ICO decided to make utmost efforts to render good offices or mediation for your Excellency's Russia and Ukraine.

Dear Mr. Vladimir Putin, members of our ICO will be very pleased if your Excellency or authorities as well as Ukrainian side will participate in our conciliatory process, even if agreeing partly to our fair proposal.

Both belligerent parties can see ICO's original Proposal in an URL: http://mopw.org/pr.%20n186-con-start.pdf at pp.7~12. Here our ICO proposed on the following matters: Cease-fire; Ukraine will not join the NATO; Demilitarization; Non-use of a mass destruction weapon; Territorial problems; Food (wheat) problems; Non-attack against an atomic station; Non-attack of a church, a hospital, a school; Humanitarian corridor; Belligerent nationals' intetcourse; Prisoners; Aid and reparation; The Armistice Commission; ICJ for settling legal problems.

And in January 1, 2023, the ICO General Assembly decided to add 2 points (rosy phrases) to the original text.

1st additional point concerns conciliatory procedure of territorial problems which reads as follows:

Point N.5

If belligerents were unwilling to submit to their territorial case to international conciliation, the United Nations may organize an UN Conciliation Commission with or without belligerent States as its member.

2nd addition concerns sum of aid to be sent to Ukraine after the end of war:

SHARE (ratio) of aid by each State for Ukraine will be proportionate with (a) her military expenditure or (b) the increased budget part of the past military expenditure which was caused by Russo-Ukrainian War. (a) is preferable.

The ICO wants to accelerate process of early conciliation. So that the first talk between a belligerent and the ICO will begin with Russian side or Ukrainian side, which will express their readiness earlier than the other.

We want to conduct the present conciliation, opening its process through the Internet in many universities and before all the people around the world for keeping fairness and transparency.

Outline of Conciliation

May peace be restored soon!!

In May 17, 2022 our ICO (international Conciliation Oganization) was established on the basis of the ELFO (Earth-Loving Friendly Organization) with Russo-Ukrainian War as as a momentum.

The ICO GA (General Assembly) decided to try conciliation by online because it is safer, more convenient, open to all the members, even to world people, and it may be realized with far less costs than those necessary for sending a delegation to belligerents.

Openess is a great merit of our online conciliation. The ICO will try to inform world people of our messages, belligerents' opinions and world public opinion as much as possible.

As a rule, a third party ICO has no duty to offer conciliation, or to respond to a request from belligerent States for this service, nor is it the duty of belligerent States themselves to ask for or to accept a third party ICO's conciliation.

It is possible, therefore, that both of Russia and Ukraine are willing or unwilling to talk with us about our conciliation proposal, or one of the belligerents will participate in it, and ready to accept ICO's proposals partly or considerably.

Anyway from the bottom of our heart, we expect both of Russia and Ukraine to participate in our conciliation dialogue for restoration of peace

Dear world people, let's save human beings by conciliation from death, killing, mutual destruction and miserable distress!!

I Purposes 目的

The ICO has a subsidiary organ ICCRUW (International Conciliation Commission of Russo-Ukrainian War). The Rules of the ICCRUW, Article1 stipulates its purposes which are "To contribute to development of friendly relations among nations and "To contribute to maintaining peace and peaceful settlement of conflicts."

II Principles 原則

According to the Rules of the ICCRUW, our Commission and Members shall act in accordance with the following Principles. (Art.2.)

- 1. Members shall fulfill in good faith the obligations assumed by them in accordance with the present Rules of the ICCRUW.
- 2. This Commission shall not intervene in matters which are within the domestic jurisdiction of any State.
- 3. Our Commission is based on the principle of equality among the same category of its Members.

According to the Decisions of the ICO GA, we can see the following 'Fundamental policy of Conciliation'

When I, Pres. Rikio Kaneko, announced my candidacy for ICO Presedent, I expressed my 6 clauses of political opinion regarding this new international organization ICO. I proposed to the GA to adopt these Clauses N.1~N.6, all of which it adopted unanimously. They are as follow:

N.1. The ICO must be a source of HOPEs

Our ICO as well as the ELFO must be always and everywhere a source of HOPEs for human beings. Human beings do both good conduct and bad deed. In these grey and rainy days, let us both ICO and ELFO march along peaceful and harmonious way:

For love, not hatred; by construction, not destruction; not dividing, but uniting people's hearts warmly.

N.2. See people's distress

See people's sadness and unhappiness caused artificially by human work, which leads to many conflicts and even to war. In our heart we cannot be calm. Let us both ICO and the ELFO refrain from deeds which would increase people's anguish.

Remebering people's distress, hoping recovery, to all wishing happiness, health, success and calm family (Earth-Loving Song), let's go with kind heart.

N.3. Life and Happiness are the first

Human beings are injuring or killing each other with or without justicification. In any conflict the disputing parties may settle it reasonably and peacefully if they are ready to compromise on the basis of respect of peaceful settlement as stipulated by UN Charter, Art. 33 or in accordance with equity and goodness (ex aequo et bono). Common sense demands mutual compromise, ceasefire and conclusion of peace treaty, neither mutual destruction nor killing precious lives.

N.4. Dangerous Escalation of Russo-Ulrainian War

If Russia and Ukraine continue war, and NATO supports Ukraine militarily, the world situation will be darker and darker, it may be possible that war may escalate into Ukrainian attacks of Russian territories (or even Moscow), anyway it is clear that more horrible destruction and loss of countless lives will be caused by such military choice.

N.5. Impartial and equitable approach

Both the ICO and the the ICCRUW must try to find peaceful settlement of a conflict or belligerency through impartial and equitable approach which means that a party compromises in some fields, and instead of them, the other party also compromises in some other sectors equitably and harmoniously.

N.6. Win and Win, not one belligerent's surrender

The ICCRUW should present to both of the belligerents such proposals by which two parties may not feel complete defeat. So that the ICCRUW should

avoid proposal to be sent to one of belligerents, by which the ICCRUW recommends one of them to surrender to the other in the present war.

Principles of conciliation

(From ELFO GA decision)

- a. A conciliator [the ICO—R.K.] shall try to find neutral equitable conditions to which belligerents are most likely to agree.
- b. Conciliator shall not mention lawfulness or unlawfulness of a given action of belligerents while conciliation goes on.
- c. Comciliator shall study in advance relevant facts and opinions concerning belligerents equally, trying to find matters to which they are most likely to agree to early.
- **d.** A conciliator shall respect instruction from the authorities of the Organization.

Conciliator is our ICO as such an international organization. It may happen, however, that our ICO Diologists mention lawfulness or unlawfulness, injuring one of the belligerent' feeling and position. But it is their personal opinion, not ICO's official opinion.

Ⅲ Composition of the ECOC 構成

The ICO GA decided that the ECOC (Executive Committee of Online Conciliation) would be composed of the following genre of members:

A. ELFO original 3 members for conciliation

1. ELFO Pres. Rikio Kaneko. I was an initiator of international, therefore, Russo-Ukrainan conflict and war.



2. Adv. of Indian Supreme Court, Ms. Chitranjari Negi, she made preparatory efforts for conciliation.



3. ELFO Secretary-general Irina Karpekina works very hard every day for the ELFO and the ICO.



B.PAD (Peace and Ambassadors Delegation) members whom you see now here:

1. Amb. Abraham Kisembo is willing to visit Moscow for conciliation between belligerents as our ELFO Peace and Amity Ambassador.

IV. Matters to be talked 話し合い事項

Respecting ELFO GA's decision dated April 15, 2022, I have been proposing many corrections and added new ideas or proposals to the former matters to be talked with belligerents.

Every time the ICO GA decided adoption of my proposals, I am so grateful to the GA members for their understang me and cooperation. So the following statement is of ICO' official position. It may be changed, however, due to new future situation.

1. Cease-fire

A. General Armistice

Considering incalculable precious value of life of human beings, to save succeeding generations from the scourge of war, and to evade terrible astronomical huge claim for reparation, we the ICO, expecting a possibility of adoption, by belligerents, of our ideas on stopping war immediately or in very near future, propose, first of all, wholistic ceasefire as early as possible, and early commemcement of negotiation for that purpose.

If only belligerents can agree to such General armistice, it is the best. But in case they cannot do so by themselves, our ICO proposes creation of an International Armistice Commission (IAC) as mentioned later (Paragraph 13).

B. Partial Armistice

Secondly, in case the belligerents cannot agree the aforesaid proposal, our ICO proposal is to realize ceasefire in such a time as the belligerents agree to:

- 1. while both of belligerents are negotiating, sitting face to face;
- 2. while both of belligerents are negotiating through online;
- 3. While our PAD (Peace and Amity Ambassadors Delegation) is staying in Kyiv;
- 4. From 00:00~08:00 in the morning;
- 5. X-mas day from 00:00~24:00;
- 6. 1st~3rd day of New Year;
- 7. Besides them the ICO welcome any agreement on cease-fire partly or wholly at any time and in any place.
- N.B. Here "fire" means to launch a missil, to discharge a gun etc. and does not include preparation for battle.

2. Ukraine will not join the NATO

As Ukraine once expressed her readiness not to join the NATO, it may be comparatively easy for the ICO to embody its equitable proposal to the belligerents. The ICO will search for the followings:

- i . What States should guarantee security of Ukrainian State?
- ii . Is it not better for the United Nations to be a contracting party of the said security treaty?

Permanent neutralization of Ukraine

In July 22, 2022 before all the ELFO FAMILY I dared to mention a way of neutralization of the Ukraine as one of the possible breakthroughs of negotiation for cease-fire and peaceful settlement of Russo-Ukrainian War.

If the ECOC (Executive Committee of Online Conciliation) were to propose it now, the Ukrainian Government would be more or less dissatisfied with such an idea. It is equitable, therefore, that, to that extent, Russian side would make due concessions to Ukrainians. Let's ICO talk about it.

A. ICO members' opinions

O ex-Amb. Yuba Nath. You know already his exclamation (JUL 22, 2022) regarding my idea about neutralization of Nepal and Ukraine. Nepal is similar with Switzerland in some respects. Our correspondance is as follows:

Rikio: Thank you, Yuba Nath San. I hope that your country be permanently neutralized State which not only States but other entities guarantee.

Yuba: Resourceful, Intelligent, Knowledgeable, Intelligent and Open. This is RIKIO.

Rikio: Dear Yuba, may I open our conversation to the ICO and ELFO members? Becouse I want very much to talk among ELFO FAMILY about permanent neutralization of Ukraine. I suppose you'll agree to my ideas.

Yuba: ok

OPres. of the BELFO Edmario Peoxinho.

In JUL 23, 2022 he wrote, "I agree with the valuable perspectives and mindset of Mr. Rikio Kaneko on Ukraine's Neutrality and Vision."

Neutralization was great thema of the ICO GA (General Assembly), but no body was against neutralization of Ukraine.

B. Reasons for neutralization of Ukraine

- 1. As I said, a way of neutralization of the Ukraine may be "one of the possible breakthroughs of negotiation for cease-fire and peaceful settlement of Russo-Ukrainian War."
- 2. Militarization with modern weapons and strengthening military alliances are contrary to normalization of Earth-community and maintaining beautiful cosmos.
- 3. Considering history of human beings, use of armed forces and even threat by it were prohibited gradually, so, the way along which humankind march is disarmament and peaceful settlement of conflicts.
- 4. Such peaceful amicable way leads to ONE World, namely, World Federation where every State shall be peaceful, and of neutralized character. Permanent neutralized States or regions are forerunners of progressive peaceful process moving toward establishment of ONE World. They can be even proud of it: they are in the van of the era!!

C. Concept of permanently neutralized State

Here a permanently neutralized State means a State whose independence and integrity are for all future time guaranteed by an international treaty, under the condition that such State binds itself never to take up arms against any other State except for defence against attack, and never to enter into such international obligation as could indirectly involve it in war. (Oppenheim's international law, Vol. I . PEACE, 8th ed. Longmans, p.243.)

The neutralization may contain a possibility to conclude a convention by which a neutralised State can acquir, without cession of, new parts of territory with the consent of all the contracting States.

Here I took into account Ukrainian possibility that Ukraine can recover sovereignty over region

which she lost it at the time of conclusion of peace treaty with Russia. It goes without saying that such alteration of sovereignty needs a new agreement among contracting parties of the treaty.

Separate treaty of neutralization. It seems better to conclude a treaty of permanent neutralization of Ukraine apart from a peace treaty between Russia and Ukraina because the former treaty involve more contractiong parties, while the latter concerns, in principle, belligerent Russia and Ukraine though both treaties relate each other closely.

D. Equitable and good compromise

What will be the compromises between Russia and Ukraine from view points of equity and goodness (ex aequo et bono)? First of all, our ECOC will see the contents of obligations to be imposed upon Ukrainian State. If the treaty of neutralization stipulates such heavy obligations for Ukraine as disarmament, it is equitable that on Russian back would be also heavy burdens, to that extent. The coverse is also true.

Here ECOC's task is to try to make up a draft convention as clearly as possible. Then it will be easier for the ECOC to propose several mutual compromises.

3. Demilitarization

Neutralization partakes politico-diplomatic and military character, while demilarization partakes mainly military character imposing restrictions in respect of weapons and region. We are pleased if belligerents agree to following points.

- 1. If restrictive burden is heavy on Ukrainian shoulder, then to that extent, Russian burden will be also heavy.
- 2. In Ukraine such **3 non-nuclear principles** are to be applied as in Japan for a long time, namely: not producing, not possessing and not allowing the entry of nuclear weapons into the country.
- 3. Along the Russo-Ukrainian border, will be created a **demilitarized zone** with certain width of regional belt.
- 4. Our ICO proposes to Russians and Ukrainians to change the said zone into not arena of

quarrels, but on the entire contrary, into a place where spirit of peace, friendship, welfare, and cooperation rules.

- 5. A definite zone (for example, 1km.) around an atomic station shall be demilitarized, and it shall not be a battlefield.
- 6. Ukraine and Russia shall neither locate military objects within or near a port which are used for exporting food, nor use such a port for importing weaponry and other military porposes.

4. Non-use of a mass destruction weapon

It may be comparatively easy for belligerents to promise not to use a mass destruction weapon, namely, ABC weaponry: Atomic, and Bacteriological and Chemical.

Our ICO will propose as follow:

- 1. Both belligerents agree to never use a mass destruction weapon at any place so far as the enemy belligerent does not use it.
- 2. When a Head of State or some authorities declare serious military action with severe words, they shall answer to any questioner that use of the ABC weapon will not be included in this action.
- 3. If there a doubt happens as to use of ABC weapons, the concerned State shall permit international inspection to be organized by the United Nations.

5. Territorial problems

It may be very complicated process to settle these problems:

- A. It will be very good if Russia and Ukraine can conclude a peace treaty by themselves which would settle their territorial problems finally.
- B. It is possible, however, that even if they succeeded to conclude peace treaty which stops warfare, they could not agree to final settlement of territorial problems.

The several points below-mentioned concerns the just said case B, and are to be regarded as the ICO PROPOSALs to bellegerents.

Point N.1

If Russia and Ukraina fail to settle territorial problems by peace treaty, they shall promise to continue to negotiate after its conclusion.

Point N.2

If they cannot settlte the territorial problem for a long time by negotiation after conclusion of peace treaty, it may be several phases which our ICO may propose to Russia and Ukraine.

Point N. 3

Our ICO proposes the 10 years for diplomatic negotiation. This period is for autonomy of diplomatic negotiation between Russia and Ukraine.

Point N.4

If they fail to settle territorial problems by diplomatic negotiation, they shall submit the case to an international conciliatory organization. (As to our ICO, the GA will decide if it is ready to receive the case)

Point N.5

If belligerents were unwilling to submit to their territorial case to international conciliation, the United Nations may organize an UN Conciliation Commission with or without belligerent States as its member.

Point N.6

If Russia and Ukraine agree to conclusion of the said international conciliatory organization, it is very good.

But if one of them does not agree to it, the case shall be submitted to the ICJ (International Court of Justice), asking it to deliver an advisory opinion.

Point N.6

If Russia and Ukraine agree to conclusion of the said advisory opinion of the ICJ, it is very good. But if one of them does not agree to it, the case shall be submitted to the ICJ, asking it to deliver a judicial decision binding both of the parties.

Point N.7

Russia and Ukraine shall respect the decision of the ICJ, provided that they may alter the contents of decision if they agree to it.

N.B. While conciliation or judicial procedure goes on, Russia and Ukraine may negotiate at any time.

6. Food (wheat) problems

In order that Ukraine provides African countries with food, especially Ukrainian wheat, we the ICO proposes followings:

- 1. Ukraine and Russia shall neither locate military objects within or near a port which are used for exporting food, nor use such a port for importing weaponry and other military porposes.
- 2. Russia and Ukraine will neither attack such a peaceful port so long as other belligerent observes the aforementioned rules, nor attack a ship carrying such humanitarian food.
- 3. A Commission for Exporting Food to Africa (CEFA) will be created. It shall be composed, among others, of permanent member of African Union, United Nations, Russia, Ukraina, and Turky.

7. Non-attack against an atomic station

According to Article 55 of the Hague Regulation of 1907, a belligerent occupying enemy territory shall only be regarded as administrator and usufractuay of the public buildings, real property, forests, and agricultural works belonging to the hostile State and situated in the occupied territory; and he must protect the stock and plant, and administer them according to the rules of usufruct.

He may, therefore, sell the crops from public land, cut and sell timber in the public forests, let public land and building for the time of his occupation. (Ibid, Oppenheim, pp. 397~398).

ICO's proposal is as follows:

- 1. A belligerent or a warring entity shall make an oath never to attack any atomic station at any time and from any place irrespective of nationality of the actual ruler or manager of the station.
- 2. A belligerent shall demilitarize 1 km. zone around an atomic station, provided that its ruling belligerent may have police power with small arms.
- 3. When attacks become serious in or around an atomic station, administrator shall stop its operation.
- 4. International inspection of any atomic station by International Atomic Energy Agency (IAEA) shall be admitted at any time when the IAEA think it necessary.

Article 56 of the Hague Regulation of 1907 prohibites all destruction of, and damage to, historical monuments, works of art and science, building for charitable, educational, and religious purposes.

"But such objects enjoy this protection only during military occupation of enemy territory. Should a battle be waged around an historical monument on open ground, should a church, a school, or a museum be defended and attacked during military operations, these otherwise protected objects may be damaged or destroyed under the same conditions as other enemy property".(Oppenheime's International Law, Lauterpacht, Vol. II, 7th edi.p.415)

Our ICO proposes:

- 1. that religious, educational and medical establishments shall not be used for military purposes, and so long as they remain so, they shall not be an object of military operation.
- 2. that Ukrainian side shall inform in advance Russian authorities of the name and place of the establishments of these categories which are, or to be, located within theatre of war.
- 3. If Russian armed forces are going to attack these categories, Russian side shall inform Ukrainian authorities of such attack in advance.

9. Humanitarian corridor

ICO's proposal is as follows:

- 1. Civilians shall neither remain in nor enter warring theatre where military objects are. If they are temporaly obliged to be there, humanitarian corridor must be created immediately for their leaving from there, and they must not be attacked.
- 2. When military objects in a region (a village, a city or prefecture etc.) are declared to be attacked, and the region is besieged by troops with possible severe destruction, humaniterian corridors shall be created by belligerents' agreement.
- 3. In case creation of humanitarian corridor is declared unilaterally by Ukrainian side, Russian side respect it as much as possible so long as the corridor is used as one-way-traffic along which only people wishing to leave the region may flee to a safer region or a foreign country.

- 4. Such an one-way-traffic corridor may be created by an belligernts' agreement.
- 5. Taking into account probability that even with such creation of one-way-traffic many civilians are obliged to remain there, they shall not be regarded as a terrolist or against some norm so long as civilians observe wartime rules.
- 6. When one of the belligerents asks the United Nations to observe a humanitarian corridor, and the UN agrees to it, the other belligerent shall respect it.

10. Belligerent nationals' intetcourse.

ICO proposes as follows:

- 1. Taking into account civilian common people's natural aspiration after restoration of peace and friendship, both of belligerents shall not prevent peaceful interchange not only among relatives of belligerent countries, but also in respect of their nationals' international interexchange.
- 2. May both belligerents stop war, restore peace for their nationals' friendly interexchange.

11. Prisoners

Our ICO proposes as follows:

- 1. From humanitarian point of view, belligerents shall facilitate exchange of prisoners as much as possible.
- 2. When a Russian troop or organ brings an Ukrainian civilian to Russian authorities, they shall inform Ukrainian authorities of the civilian name, address, profession etc. as soon as possible.

12. Aid and reparation

Money should be used not for destruction, but for construction and rising a leve of life ASAP

The problems of aid and reparation for Ukrainians are also very important, I presented my ideas to the ICO GA, which adopted the bellow-mentioned proposals of mine unanimously. Fortunately No ICO members expressed any doubt.

"Personally I want almost all the States around the world to aid Ukrainians to restore their

level of life. I suppose that Ukrainians' standard of living rapidly and horribly declined after commencement of Russo-Ukrainian War. Before the war Ukrainian PPP (purchasing power parity) was 51 % as is seen in the below table.

Fiji 56%; Bhutan 55%; Jordan 54%; Jamaica53%; **Ukraine** 51%; Eswatini 51%; Belize 50%; Philippines 49%; Morocco 48%;

(http://mopw.org/mem.fee.%20jan%202022.pdf)

I hope that all the Sates should help Ukrainians restore former level of life. What States, to what extent, and how many years should aid Ukrainians? Here it is desirable to apply some objective economic and social indications. One of my ideas is adoption, by the ICO GA, of followings."

Thus I sent my proposals to the GA (General Assebbly), which also adopted them unanimously:

- 1. <u>WIN-and-WIN relations</u>. Aid and reparation will be rendered on basis of win-and-win relations, not a victor nation-and-a defeated nation.
- 2. Almost all the States of the world should aid Ukraine until she restores her PPP to 50%;
- 3. SHARE (ratio) of aid by each State for Ukraine will be proportionate with (a) her military expenditure or (b) the increased budget part of the past military expenditure which was caused by Russo-Ukrainian War. (a) is preferable.
- 4. On the basis of Win-and-Win spirit both Russia and Ukraine renounce mutually right to claim reparation for damages caused by war, provided that Russia shall also aid Ukraine in accordance with the preceding paragraph 3.
- 5. The State which went to default or the States whose PPP is less than 50% may be exempted from the aforesaid aid.

13. The Armistice Commission

- 1. An International Armistice Commission (IAC) will be created which will be composed of belligerents. States and international organizations concerned.
- 2. In the aforesaid "States" will be included a State which guarattees neutralization of Ukraine. In the "international organization" may be included the United Nations (UN), FAO, IAEA, African Union etc.
- 3. The principal purpose of the IAC is to help belligerents agree to conditions of armistice and restoration of peace.
- 4. A cosultative committee without belligerents may be opened with the UN chairmanship.

14. ICJ for settling legal problems

War must be ended by coclusion of peace treaty. In case there appears legal problem regarding interpretation of some phrases, there must be an Article which provides method for settling the problem. It is desirable that when Russian and Ukrainian Government are not able to the problems neither by negotiation nor by conciliation, they choose, among others, judicial settlement by the International Court of Justice.

V. Good Communication 良き意思疎通

In order to promote peace and friendship not only between Russia and Ukraine, but also generally on our Planet, good communication is necessary,

So far as diplomatic channel is concerned, it is thin thread: there is only one Russian member-Dip. Mr. Acef Said (pic), and from

You see unbalance here, I'll ask Russian side to join us more. I expect

Net conciliation process 調停手

How to proceed with this official dynamic Online Conciliation? Our ICO (International Conciliation Organization) would like to do it, with help of universities, and in accordance with such a systematic procedure of general character which may be applied also to other conflicts or wars other than Russo-Ukrainian War.

The ideal procedure of conciliation composed of 9 steps as mentioned below. But actual course of it may be different from the steps due to little time for talking because belligerents are extremely busy with war. In this case the ICO will have to consider its simplified answer. Anyway ideal procedure is the following 9 steps:

1st step: ICO President's greeting

It is to send ICO President' invitational greeting by email to belligerent Russia and Ukraine, where ICO Pres. may express one's wishes:

- a. that the ICO and ELFO be a co-promoter of the conciliation between Russia and Ukraine with the ELC (Earth-Loving Company) in Sapporo as an assitent.
 - b. that belligerents consider our proposals;
- c. that we the ICO would like to render good offices for them, proposing mediation;
- d. that belligerents would express their readiness to compromise in what respects and to what extent.
- e. and that rendering good offices and mediation are conducted, in principle, by online and emails.

2nd step: commencement of dialogue

- a. Russia, Ukraine and the ICO may appoint its plural dialogists of assistant character respectively.
- b. First dialogists will be from the ICO and from the State which expressed firstly her readiness to participate in our conciliation project. (It may be Russia or Ukraine.) In any case conciliation shall be fair.
- c. Supposing that Ukrainian side answered to our call earlier than Russian, then the first phase of the conciliation will be conducted as follows. If Russian side answers first, the procedure will be alike. (It means the the 3rd step goes between Russian side and the ICO)

3rd step: ICO's speeches and Ukrainian answers

It will be conducted through Zoom meeting, host of which is the following joint promoters.

Promoter: Joint auspices of the ICO and the ELFO d the ELC and Universities will be an assitetent.

Date: The date will be agreed to with Ukrainian side.

Time: 14:00~16:00 by Japanese time (10:00~by U.time)

Place: House for Peace, Welfare & Friendship in Sapporo

Or at a University ready to be a kind of good offices

Participants: Its maximum is 50 per. including journalists

Viewwers: Members of our ICO, ELFO, Professors, students, and TV viewers around the world.

- 6. Mr. Rikio's speech on proposal of cease-fire

5th step: deliberation in the ICO

We expect that Ukrainian side found many points in the said 4^{rd} step to which it can agree to.

The ICO GA (General Assembly) shall deliberate on Russian answers and summarize them, making them open to the world and shall immediately decide what to do in order to make situation better, trying to widen sphere of cease-fire, and sending our additional proposals for restoration of peace.

6th step: 2nd Ukrainian answers to ICO and Russians

We expect that here Ukrainian side will expresses as many points as possible to which it can agree to.

7th step: deliberation in the ICO

The ICO GA (General Assembly) shall deliberate on Ukrainian answers and summarize them, making them open to the world and shall immediately hold such a fair Zoom meeting also with Russian side as was conducted with Ukrainian authorites:

8th step: 2nd Russian answers to ICO and Ukrainians

The program is almost the same with that of the $3^{\rm rd}$ step with possible addition of new matters.

We expect that here Russian side will expresses as many points as possible to which it can agree to.

9th step: deliberation in the ICO and its Conclusion

The ICO shall deliberate on Russia answers and summarize them, making them open to the world and declare final PROPOSAL of the 1 round conciliation between 2 belligerents, wishing earlier conclusion of peace treaty and people's happiness.

The II Round Conciliation

The aforementioned 9 steps are of I Round of Conciliation between Russia and Ukraine. It would be very happy if they finish war while I Round of Conciliation goes on. The 2nd Round Conciliation will begin when both belligerents could not agree to the end of war.

Rules for Friendship

GA decision (FEB 10, 2022)

The greatest friendship of all the members

Foreseeing that in future there will be many members whose States are not friendly, and considering imperative necessity to promote friendship irrespective coloful differences among numerous members, in February 10, 2022 the General Assembly of our Earth-Loving Friendly Organization (ELFO) adopted the following rules.

Done in February 10, 2022 in Sapporo

Article 1. Fainess

- 1. The ELFO shall be fair on contributing to easing strained relations not only among nations, but also among ELFO members concerned.
- 2. When a member complains of one of the conflicting party, the ELFO shall know also opinion of other party. (Blue paragraphs were added to the origina 'General Policy for Friendship)

Article 2. Friendly Manners

1.Any ELFO Family member shall be friendly even if among members concerning a given international or domestic conflict. At least members shall observe international courtesy and etiquette.

Possibly it may be uneasy to maintain friendly attitude between conflicting VIPs or Diplomats. Nevertheless members shall be friendly. Because our ELFO is deeply based on, and originate from, the attachment of importance to friendship as clearly expressed in the name our ELFO: Earth-Loving Friendly Organization. Our ELFO expects that Diplomats' relationship and friendship are different

from those observed in the United Nations, for example.

2. Members shall not use wording which would clearly injure other party's emotion, which usually friends would not choose among them.

Article 3. Finding of Illegality

1. Not only the Interstate Department, the Boundary Territorial Department, but also ELFO members in general shall neither declare illegality of a given action nor regard it as morally or ethically permissible, provided that it is stipulated in other ELFO rules.

First of all, I want all the members to pay attention to friendly amicable character of our ELFO as its Charter lays downs:

Article 11 (Friendly character) 1. In a provisional period the Organization shall attach a great importance to its friendly activities as participants in Ancient Olympic Games stopped war and enjoyed games.

Such norms and systems are stipulated here and there in the Charter. For example, Article 56, Paragraph 4 reads as follows:

4. Regarding the title to a contentious territory, the Council shall maintain principle that it refrains from legal conclusion, and it is an international court or the Earth-Loving Amicable Court (ELAC) which gives judgement on it.

If a member Diplomat declares clearly that an opponent's given action is unlawful or aggression, the other opponent Diplomats would retort vehemently as in the UN, and we could not maintain friendly atmosphere in the ELFO. We ELFO need not to imitate and repeat UN system because the ELFO is a bud growing for promotion of friendship of all members and all human beings.

The ELFO Charter designed very good scheme for the ELFO as well as for all human being such as Solidarity system (http://mopw.org/e-SC-n2.pdf), but it is not enough. There is room to be improved more.

2. Regarding illegality of a given action, the ELFO shall maintain principle that it refrains from legal conclusion, and it is an international court or the Earth-Loving Amicable Court (ELAC) which gives judgement on it.

Article 4. VIPs' Admission

- 1. Those Heads of State, Ministers of Foreign Affairs, and Diolomats (hereinafter referred to as VIPs), who condemned other party of a given conflict before acceding to the ELFO, may join our Organization.
- 2. Once the VIPs join our ELFO, however, they shall not declare, before the ELFO, other opponent's action in question as international delinquency.

Outside the ELFO they may do so.

They shall also respect friendly character of our Earth-Loving FRIENDLY Organization, paying more attention to our ELFO's Statements or Proposals.

Here you can understand very unique and good character of our ELFO. Even if VIPs of antagonistic States avoid international intercourse in many places, here they may rather want to be more or less amicable because of its very valuable golden thread.

Article 5. Imperative Answer

- 1. When the VIPs want the ELFO to deliberate their international conflict, the concerned organ of the ELFO shall make up a draft Declaration or Statement as soon as possible.
- 2. It shall be imperative for the VIPs to participate in the constructive deliberation for settling conflicts, to answer questions admitted by a Chairperson of a geven organ.

Article 6. Messenger of Documents

- 1. For the pupose of promoting friendship our ELFO may make a STATEMENT or a PROPOSAL (not Recommendation) to the belligerents.
- 2. The Diplomats shall cooperate as a messenger to send the STATEMEMT or the DECLARATION to their Government, and also send

their Governments' message to the ELFO.

3. Any VIPs including Diplomats may expresse one's opinions so long as it is constructive, mentioning an ELFO STATEMENT or an PROPOSAL.

Article 7. VIPs of Neutral States

- 1. When the ELFO try to contribute to settling international conflicts, it shall attach importance, among others, opinions of neutral counties and nonaligned countries as well as those of parties to this crisis.
- 2. The ELFO may organize in adcance a permanent cociliative organ or ad hoc committee for a given conflict.

My Dear Earth-Loving Family

Aforementioned Rules for Friendship is so important a document that we must deepen menbers' understanding.

The fundamental thought is, in a word, an OASIS, where members must be friendly, even among members of opponent STATES.

Look up the 'friendly trees' in Nishioka Park' near to my house. This is not composite picture, but real one. Even trees can be friendly like this. Let's ICO (International Conciliation Organization) try to make our Planet friendlier and more beautiful.

Though our ICO has not received any answer from the belligerent Russia and Ukraine, it is not so surprising because nowadays they want to continue to battle though it is unreasonable, against feasible better or best choice, and very risky dangerous way, and against the way along which human beings should go ahead.

It is said that about 200,000 PERSONS DIED as victims of war since the beginning of this war. It means that more than 20,000 persons left this world per one month. How we can endure such loss of human beings? In addition, you see terrible HUGE MATERIAL LOSS. And in many countries military expenditure is increasing. These elements are worsening world economy considerably, excepting military industrial complex.

Russo-Ukrainian Way is escalating, which may lead to nuclear war and the III World War. If current war continues, a problem of reparation will be more serious. Furthermore we must know that reason of human beings and fair compromiss by belligerents can settle these appearently difficult problems.

We will continue to propose

I imagine that majority or overwhelming majority of world people think stopping war is better than continuing it to the last. It is the very world-wide opinion explicit or implicit that our ICO should do conciliation between beligerents.

Maybe, at the end of this year it would be better for our ICO to send the 3rd PROPOSAL to both of Russian and Ukrainian Government, the content of which would be almost the same with some necessary qualifications and some additional matters. I expect members' opinion regarding these items if any.

Let's heighten ICO's authority

Our ICO seems to have great unprecedented potential power for international conciliation. But as it is only 6 month's baby organization, it is not influential at present time. So members must try to heighten its authority by inviting as many influential members as possible such as current or ex-State Top Leaders, influential MPs (Member of Parliament), eminent Mediators, Ambassadors, International Organizations etc. As to Intenational Organizations, it is important to try to invite, firstly, African Union, where countless people are suffering from starvation, secondly, to unite as many NGOs as possible under ICO's umbrella.
