Rules of the ICCRUW

Recognizing that conciliation is one of the peaceful means of settling international conflicts as provided for in the UN Charter, Art. 33,



Wishing that the present Rules on the ICCRUW (International Conciliation Commission on Russo-Ukrainian War) and we its Members help conflicting parties mitigate distress and tension by our conciliation and other friendly proposals.

The ELFO (Earth-Loving Friendly Organization) adopted unanimously the present Rules of the ICCRUW in April 26, 2022.

Art. 1. Purposes

- 1. To contribute to development of friendly relations among nations and
- 2. To contribute to maintaining peace and peaceful settlement of conflicts;

Art.2. Principles

Our Organization and Members shall act in accordance with the following Principles.

- 1. Members shall fulfill in good faith the obligations assumed by them in accordance with the present Rules of the ICCRUW.
- **2.** This Organization shall not intervene in matters which are within the domestic jurisdiction of any State.
- **3.** Our Organization is based on the principle of equality among the same category of its Members.

Art. 3. Composition

- 1. The ICCRUW shall be composed of States of comparatively neutral character; the States trying to conciliate between belligerents; and their Diplomats.
 - 2. The following States may be a member:
 - a. A neutral State by its policy or by a treaty;
 - b. A State which is demilitarized or has not force;
 - c. A nonaligned State.
- 3. Any ELFO VIPs and any Diplomats, excepting belligerent Diplomats, may be members of the ICCRUW, provided that they will try to find measures which both belligerents would agree to.
- 4. An ELFO Diplomat whose State abstained from voting in the United Nations in March 3, 2022, March 24, 2022 and April 7, 2022 shall be a member of the ICCRUW.
- 5. The ELFO of all humankind character, as an initiator of creation of the ICCRUW, has the exceptional status as an original Member of the ICCRUW.
- 6. If necessary, the General Assembly may recognize a State, an organization or an individual as a temporal member.

Art. 4. Principal organs

There are established as the principal organs of the present ICCRUW: a Representative, a Chairperson, a General Assembly, a Council and a Secretariat.

Art. 5. A Representative and a Chairperson

- 1. A Representative represents the ICCRUW externally, may negotiate with belligerents.
- 2. A Chairperson presides General Assembly, and may decide internal and external matters.

Art. 6. General Assembly

- 1. The General Assembly is composed of all the Member-States and the ELFO.
- 2. The main functions of the General Assembly include the following matters:
- **a.** to deliberate and adopt a draft PROPOSAL on conciliation to be sent to the conflicting parties;
- b. to propose such steps to belligerents as may mitigate tension between them;
- c. to elect a Representative and a Chairpersons;
- d. to deliberate and decide the budget of the ICCRUW.

Art. 7. The Council

- 1. Council may be composed of less than 5 members.
- 2. Its principal function is to present to the General Assembly a draft conciliation PROPOSAL to be sent to the belligerents.

Art.8. Secretariat

- 1. Chairperson may appoint staffs of the Secretariat.
- 2. The Secretary-General shall act in that capacity in the ICCRUW, and perform such other functions as are entrusted to him by these organs.
- 3. Each Member undertakes to respect the exclusively international responsibilities of the Secretary-General and the staff.

Art. 9. Decision

- 1. A declaration of intention of the ICCRUW and its members, the General Assembly and meeting may be conducted, in principle, by the Internet, televisions, e-mails, faxes and so forth.
- **2.** A decision of the Principal organs and the other subsidiary organs shall be adopted by affirmative votes of majority of members present.
 - 3. So long as a member-VIP or a member-Diplomat does not express yes or no, his

or her Representative by ELFO Charter, Art. 8 shall be regarded a mandatory, and his or her yes or no shall also regarded as the same with that of Representative by the ELFO Charter.

Art. 10. The right to vote

- 1. a State has bellow-mentioned right to vote, ratio of its population being taken into account;
 - i 80 votes are given to a State with more than 1,000,000,000;
 - ii 70 votes are given to a State with the population from 100,000,000,000 to less than 1,000,000,000;
 - iii 60 votes are given to a State with the population from 10,000,000 to 100,000,000.
 - iv 50 votes are given to a State with population from 1,000,000 to less than 10,000,000;
 - v 40 votes are given to a State with the population from 100,000 to less than 1,000,000;
 - vi 30 votes are given to a State with the population from 10,000 to less than 1 00,000;
 - vii 20 votes are given to a State with the population from 1,000 to less than 1 0,000;
 - viii 10 votes are given to a State with the population less than 1,000.
 - 2. 80 votes are given to President of the ELFO, taking into account its all humankind character.
 - 3. While an eligible State does not send its representative, an ELFO Diplomat from the country may become a member of the ICCRUW with 20% of votes of the State, each additional member will increase 20%.

Art.11. Beginning of Conciliatory Activities

When one State accedes to the ICCRUW, she may begin conciliatory activities together with the original member ELFO.

Art. 12. All National Conciliation Conference

The ICCRUW encourages creation of All National Conciliation Conference as for serious conflicts.

- N.B.1. Immediately after the effectuation of the present Rules, our ELFO is ready to talk about revision of the Rules.
 - N.B.2. Provisionally our ELFO is ready to be the Secretariat of the ICCRUW.
