

## Treaty On Permanent Neutralization Of Peaceful Ukraine

WE THE PEOPLES ON OUR PRECIOS PLANET DETERMINED

to save succeeding generations from the scourge of war, especially catastrophic nuclear war,

to strengthen friendly permanent peaceful relations among peoples and States large and small, and

to promote better standard of life, not destroying human and material resources,

AND FOR THESE ENDS

to practice tolerance and live together in peace with one another as good neighbors around Ukraine,

to unite our strength to maintain Permanent Neutralization of Peaceful Ukraine and security thereof, and

to ensure that armed forces shall never be used permanently in Peaceful Ukraine excepting the case of self-defense,

HAVE RESOLVED TO COMBINE OUR EFFORTS TO ACOMPLISH THESE AIMS.

Accordingly, the United Nations, our respective Governments, Autonomies, Organizations, and Individuals have agreed to conclude epoch-making Treaty On Permanent Neutralization of Ukraine and do have honor to declare that hereby Ukraine has become a permanently neutralized State, which can be proud of her historical role as a forerunner and color-bearer of progressive peaceful process leading to establishment of ONE World.

## PART I . PERMANENT NEUTRALIZATION OF UKRAINE

### Chapter 1. Purposes and Principles

**Article 1.** Peaceful Ukraine shall be built as a permanently neutralized, peaceful, exemplary State for future of ALL HUMAN BEING.

**Article 2.** Independence and integrity of peaceful Ukraine shall be for all future time guaranteed by the present general international democratic treaty, supported by the United Nations, States, organizations, and people aspiring after true permanent peace.

**Article 3.** The multilateral Treaty on Permanent Neutralization of Ukraine (hereinafter referred to as Treaty or TPNU) may be signed before or after bilateral Russo-Ukrainian Peace Treaty (hereinafter referred to as Peace Treaty or RUPT) or together at the same time.

**Article 4.** Principle of equity and good (aequo et bono) shall be applied between the GAPNU and the PATRU.

*What will be the compromises between Russia and Ukraine from view point of equity and goodness (ex aequo et bono)? First of all, the ELFO and the ICO will see the contents of obligations to be imposed upon Ukraine. If the TPNU stipulates such heavy obligations for Ukraine as disarmament, for example, it is equitable that on Russian shoulder would be also heavy burdens, to that extent. The converse is also true. (Italic sentences are ELFO Hon. Pres. Rikio Kaneko's comment recognized the ELFO General Assembly. And so on below. )*

## Chapter 2. Parties to the Treaty on Neutralization of Ukraine

**Article 5.** Parties to the Treaty on Permanent Neutralization of Ukraine may be not only the United Nations and States large or small, but also other autonomies (self-governing communities such as prefectures and cities), organizations, and even individuals (natural).

*This is a quite innovative Article, which will strengthen considerably the fundament of permanent neutrality of Ukraine. Concerned persons and ELFO FAMILY must study hard for making up a historical scheme which will secure Permanent Neutralization of Ukraine, and contribute to peace and welfare of ALL HUMAN KIND.*

**Article 6.** 1. The said United Nations, States, autonomies, organizations, and individuals have their Representative respectively.

2. A Representative of autonomies, organizations, and individuals shall be elected respectively in accordance with annex to the present TPNU.

## Chapter 3. Rights of Peaceful Ukraine

**Article 7.** Peaceful Ukraine has sovereignty, provided that she is permanently neutralized, and that her sovereignty may be restricted by other international treaties for the purpose of strengthening permanent neutrality of peaceful Ukraine.

**Article 8.** 1. Peaceful Ukraine has right to maintain military forces only for self-defense.

*This Article does not presupposes such a country as Costa Rica which does not possess military force. If Ukraine wants to maintain her military force, she may do.*

2. When Ukraine wishes to follow policy of general and complete disarmament within Ukraine, all the parties to the present TPNU shall support her.

3. Ukraine shall not regard such study as unfriendly, which will research Permanent Neutralization with her general and complete disarmament for the purpose of raising living standard of Ukrainian people and showing exemplary way leading to World Federation.

**Article 9.** Peaceful Ukraine may be a member of the United Nations, maintaining her honorary status of Permanent Neutral Peaceful Ukraine even if a war breaks out between member-States, or between a member-State and non-member-State as well as between non-member-States.

**Article 10.** 1. Peaceful Ukraine has right to be immune from military sanctions decided by the United Nations against aggressor or any State against which the United States is taking preventive or enforcement action.

2. Peaceful Ukraine has right to be immune, in principle, also from the other sanction decided by the United Nations

#### Chapter 4. Duties of Peaceful Ukraine

**Article 11.** Peaceful Ukraine shall bind itself never to take up arms against any other State except for self-defense.

**Article 12.** 1. Peaceful Ukraine shall never conclude or enter military alliance.

*It means that Ukraine cannot be a member-State of the NATO.*

**Article 13.** 1. Peaceful Ukraine shall never enter into such international obligation as

could indirectly involve it in war.

2. Peaceful Ukraine shall not take part in military exercise with any State's military forces.

## Chapter 5. Acquisition of territories

**Article 14.** Peaceful Ukraine may conclude a convention by which she can acquire, without cession of, new parts of territory with the consent of all the contracting States.

*Here I took into account Ukrainian possibility that Ukraine can recover sovereignty over region which she may lose at the time of conclusion of peace treaty with Russia. It goes without saying that such alteration of sovereignty needs a new agreement among contracting parties to the treaty.*

## PART II. DEMILITARIZATION OF UKRAINE AND NEIGHBORING TERRITORIES

**Article 15.** If restrictive burden in respect demilitarization is heavy on Ukrainian shoulder, then to that extent, Russian burden shall be also heavy.

**Article 16.** In Peaceful Ukraine such 3 non-nuclear principles shall be applied as: not producing nuclear weapon; not possessing it; and not allowing its entry into the country.

**Article 17.** Not only along the Russo-Ukrainian border, but also near from all the borders around her shall be created demilitarized zones with certain width of belt.

**Article 18.** A definite zone around an atomic station shall be demilitarized, and it shall never be a battlefield.

**Article 19.** 1. Peaceful Ukraine and neighbouring States shall neither locate military

objects within or near airports and seaports which are used exclusively for peaceful purposes such as exporting food.

2. Peaceful Ukraine shall not use such a port for importing weaponry and other military purposes.

### PART III. PALACE OF EARTH-LOVING PERMANENT PEACE AND AMITY

**Article 20.** All the Parties to the present Treaty shall make utmost efforts to change, by all means, Ukraine destroyed by war into not arena of quarrels, but on the entire contrary, into Permanent Neutralized Peaceful Ukraine with Hopes and Lights where spirit of peace, friendship, welfare, and cooperation rules.

**Article 21.** For this end contracting parties to the present Treaty shall pay attention not only to material aspects for securing permanent neutrality of Peaceful Ukraine, but also to spiritual aspects, especially by creating Ukrainian Palace of Earth-Loving Permanent Peace and Amity (UPELPPA)

**Article 22.** The UPELPPA shall be established by the form of PPP (Public Private Partnership) in cooperation with contracting States, organizations, individuals, and Loanee-Enterpriser thereof.

*Our ELFO (Earth-Loving Friendship Organization) are going to create many PELPAs (Palace of Earth-Loving Peace and Amity) around the world. They are almost of the same content. But the UPELPPA is exceptionally privileged in the sense that present draft treaty mentions contracting States' cooperation such as PPP.*

**Article 23.** CEO and promoters of the UPELPPA shall take steps conducive for understanding permanent neutralization, and it may be created on the basis of MOU (Memorandum Of Understanding, see <http://www.mopw.org/uk-loanee-n2-241125.pdf>)

**Article 24.** In the preceding case parties to the present Treaty shall cooperate with UPELPPA as well as its mother international NGO named Organization of Palace of Permanent Peace and Amity (OPPPA) which will be composed of members of many national ELAFs (Earth-Loving Amicable Fellows). **Article 25.** For securing Ukrainian permanent neutrality steadily and observing its situation, the OPPPA will be located in the capital Ukraine Kiev.

**Article 26.** The UPELPPA and the OPPPA and shall be established also by the form of PPP (Public Private Partnership) in cooperation with contracting States, organizations, individuals, and Loanee-Enterpriser thereof.

*The present Part 3 is very important matter. Deliberation leading to its conclusion may demand a long time. If so, Article 24 or entire Part 3 may be deleted at the beginning stage.*

## **PART V. AMENDMENT**

**Article 27.** Amendments to the present GAPNU shall come into force when they have been adopted by a vote of two thirds of the parties of the present GAPNU.

**Article 28.** General Conference of members of the GAPNU for the purpose of reviewing the present GAPNU may be held every 5 years.

## **PART VI. RATIFICATION AND SIGNATURE**

**Article 29.** The present GAPNU shall be ratified as follows:

- a. Regarding States, it shall be ratified by the signatory State in accordance with their respective constitutional process.

- b. Regarding Organizations, it may be ratified by signature attested by a notary public.
- c. Regarding Individuals, it may be ratified by signature also attested by a notary public.

**Article 30.** 1. The present GAPNU may come into force upon the deposit of ratification by Russia, Ukraine, the United Nations as an original member.

2. Other States, Organizations and Individuals may accede to it by ratification.

**Article 31.** The present GAPNU shall remain deposited in the archives of the Government of Ukraine. Duly certified copies shall be transmitted by that Government to the other signatory States, Organizations and Individuals.

IN FAITH WHEREOF the Representatives of the Governments of Russia, Ukraine, United Nations, Organization, and Individuals have signed the present GAPNU.
